A BILL

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Protecting Seniors
5 From Opioid Abuse Act”.

6 **SEC. 2. EXPANDING ELIGIBILITY FOR MEDICATION THER-**
7 **APY MANAGEMENT PROGRAMS UNDER PART**
8 **D.**

9 Section 1860D–4(c)(2)(A)(ii) of the Social Security
10 Act (42 U.S.C. 1395w–104(c)(2)(A)(ii)) is amended—

11 (1) by redesignating subclauses (I) through
12 (III) as items (aa) through (cc), respectively, and
13 adjusting the margins accordingly;

14 (2) by striking “are part D eligible individuals
15 who—” and inserting “are the following:

16 “(I) Part D eligible individuals
17 who—”; and

18 (3) by adding at the end the following new sub-
19 clause:

20 “(II) Beginning January 1,
21 2021, at-risk beneficiaries for pre-
22 scription drug abuse (as defined in
23 paragraph (5)(C)).”.
