Ms. HANABUSA (for herself, Mrs. DINGELL, Ms. BORDALLO, and Ms. GABBARD) introduced the following bill; which was referred to the Committee on Natural Resources

A BILL

To establish the Pearl Harbor National Memorial in the State of Hawai'i and the Honouliuli National Historic Site in the State of Hawai'i, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “World War II Pacific
5 Sites Establishment Act”.

6 **SEC. 2. PEARL HARBOR NATIONAL MEMORIAL, HAWAII.**

7 (a) DEFINITIONS.—In this section:

8 (1) MAP.—The term “Map” means the map en-
9 titled “Pearl Harbor National Memorial—Proposed

1 Boundary”, numbered 580/140,514, and dated No-
2 vember 2017.

3 (2) NATIONAL MEMORIAL.—The term “Na-
4 tional Memorial” means the Pearl Harbor National
5 Memorial established by subsection (b)(1)(A).

6 (3) SECRETARY.—The term “Secretary” means
7 the Secretary of the Interior.

8 (b) PEARL HARBOR NATIONAL MEMORIAL.—

9 (1) ESTABLISHMENT.—

10 (A) IN GENERAL.—There is established the
11 Pearl Harbor National Memorial in the State of
12 Hawai’i as a unit of the National Park System.

13 (B) BOUNDARIES.—The boundaries of the
14 National Memorial shall be the boundaries gen-
15 erally depicted on the Map.

16 (C) AVAILABILITY OF MAP.—The Map
17 shall be on file and available for public inspec-
18 tion in appropriate offices of the National Park
19 Service.

20 (2) PURPOSES.—The purposes of the National
21 Memorial are to preserve, interpret, and commemo-
22 rate for the benefit of present and future genera-
23 tions the history of World War II in the Pacific from
24 the events leading to the December 7, 1941, attack
25 on O’ahu, to peace and reconciliation.

1 (c) ADMINISTRATION.—The Secretary shall admin-
2 ister the National Memorial in accordance with this sec-
3 tion, section 121 of Public Law 111–88, and the laws gen-
4 erally applicable to units of the National Park System in-
5 cluding—

6 (1) section 100101(a), chapter 1003, and sec-
7 tions 100751(a), 100752, 100753, and 102101 of
8 title 54, United States Code; and

9 (2) chapter 3201 of title 54, United States
10 Code.

11 (d) REMOVAL OF PEARL HARBOR NATIONAL MEMO-
12 RIAL FROM WORLD WAR II VALOR IN THE PACIFIC NA-
13 TIONAL MONUMENT.—

14 (1) BOUNDARIES.—The boundaries of World
15 War II Valor in the Pacific National Monument are
16 revised to exclude from the monument the land and
17 interests in land identified as the “Pearl Harbor Na-
18 tional Memorial” as depicted on the Map.

19 (2) INCORPORATION INTO NATIONAL MEMO-
20 RIAL.—

21 (A) IN GENERAL.—The land and interests
22 in land excluded from the monument under
23 paragraph (1) are incorporated in and made
24 part of the National Memorial in accordance
25 with this section.

1 (B) USE OF FUNDS.—Any funds for the
 2 purposes of the land and interests in land ex-
 3 cluded from the monument under paragraph (1)
 4 shall be made available for the purposes of the
 5 National Memorial.

6 (C) REFERENCES.—Any references in law
 7 (other than in this Act), regulation, document,
 8 record, map or other paper of the United States
 9 to resources in the State of Hawai'i included in
 10 the World War II Valor in the Pacific National
 11 Monument shall be considered a reference to
 12 Pearl Harbor National Memorial.

13 **SEC. 3. HONOULIULI NATIONAL HISTORIC SITE, HAWAII.**

14 (a) DEFINITIONS.—In this section:

15 (1) HISTORIC SITE.—The term “Historic Site”
 16 means the Honouliuli National Historic Site estab-
 17 lished by subsection (b)(1)(A).

18 (2) MAP.—The term “Map” means the map en-
 19 titled “Honouliuli National Historic Site—Proposed
 20 Boundary”, numbered 680/139428, and dated June
 21 2017.

22 (3) SECRETARY.—The term “Secretary” means
 23 the Secretary of the Interior.

24 (b) HONOULIULI NATIONAL HISTORIC SITE.—

25 (1) ESTABLISHMENT.—

1 (A) IN GENERAL.—There is established the
2 Honouliuli National Historic Site in the State
3 of Hawai'i as a unit of the National Park Sys-
4 tem.

5 (B) BOUNDARIES.—The boundaries of the
6 Historic Site shall be the boundaries generally
7 depicted on the Map.

8 (C) AVAILABILITY OF MAP.—The Map
9 shall be on file and available for public inspec-
10 tion in appropriate offices of the National Park
11 Service.

12 (2) PURPOSES.—The purposes of the Historic
13 Site are to preserve and interpret for the benefit of
14 present and future generations the history associated
15 with the internment and detention of civilians of
16 Japanese and other ancestries during World War II
17 in Hawai'i, the impacts of war and martial law on
18 society in the Hawaiian Islands, and the co-location
19 and diverse experiences of Prisoners of War at the
20 Honouliuli Internment Camp site.

21 (c) ADMINISTRATION.—

22 (1) IN GENERAL.—The Secretary shall admin-
23 ister the Historic Site in accordance with this sec-
24 tion and the laws generally applicable to units of the
25 National Park System, including—

1 (A) section 100101(a), chapter 1003, and
2 sections 100751(a), 100752, 100753, and
3 102101 of title 54, United States Code; and

4 (B) chapter 3201 of title 54, United States
5 Code.

6 (2) PARTNERSHIPS.—

7 (A) IN GENERAL.—The Secretary may
8 enter into agreements with, or acquire ease-
9 ments from, the owners of property adjacent to
10 the Historic Site to provide public access to the
11 Historic Site.

12 (B) INTERPRETATION.—The Secretary
13 may enter into cooperative agreements with
14 governmental and nongovernmental organiza-
15 tions to provide for interpretation at the His-
16 toric Site.

17 (3) SHARED RESOURCES.—To the maximum
18 extent practicable, the Secretary may use the re-
19 sources of the Pearl Harbor National Memorial to
20 administer the Historic Site.

21 (d) ABOLISHMENT OF HONOLULI NATIONAL
22 MONUMENT.—

23 (1) IN GENERAL.—In light of the establishment
24 of the Honouliuli National Historic Site, the
25 Honouliuli National Monument is hereby abolished

1 and the lands and interests therein are incorporated
2 within and made part of Honouliuli National His-
3 toric Site. Any funds available for purposes of
4 Honouliuli National Monument shall be available for
5 purposes of the Historic Site.

6 (2) REFERENCES.—Any references in law
7 (other than in this Act), regulation, document,
8 record, map or other paper of the United States to
9 Honouliuli National Monument shall be considered a
10 reference to Honouliuli National Historic Site.
