- 11 pose or issue a notice of proposed rulemaking for any revi-
- 12 sion to such rule except to extend its effective date, or
- 13 for any other rule requiring the use of biometric readers
- 14 for biometric transportation security cards under section
- 15 70105(k)(3) of title 46, United States Code, before the
- 16 end of the 60-day period beginning on the date of the sub-
- 17 mission under paragraph (5) of section 1(b) of Public Law
- $18\ 114-278\ (130\ {\rm Stat.}\ 1411\ {\rm to}\ 1412)$ of the results of the
- 19 assessment required by that section.

20 SEC. 3. PROGRESS UPDATES.

- Not later than 30 days after the date of the enact-
- 22 ment of this Act, and every 90 days thereafter until the
- 23 submission under paragraph (5) of section 1(b) of Public
- 24 Law 114-278 (130 Stat. 1411 et seq.) of the results of
- 25 the assessment required by that section, the Secretary of
- 26 Homeland Security shall report to the Committee on

- 1 Homeland Security and the Committee on Transportation
- 2 and Infrastructure of the House of Representatives and
- 3 the Committee on Commerce, Science, and Transportation
- 4 of the Senate regarding the implementation of that sec-
- 5 tion.
