A BILL

To amend the Pittman-Robertson Wildlife Restoration Act and the Dingell-Johnson Federal Aid in Sport Fish Restoration Act, to provide parity for United States territories and the District of Columbia, to make technical corrections to such Acts and related laws, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. APPORTIONMENT UNDER PITTMAN-ROBERT-**
4 **SON WILDLIFE RESTORATION ACT.**

5 (a) EQUIVALENT MINIMUM APPORTIONMENT AMONG
6 STATES AND TERRITORIES OF TAX REVENUES ACCRUING
7 TO FUND.—The first subsection (c) of section 4 of the
8 Pittman-Robertson Wildlife Restoration Act (16 U.S.C.
9 669c), relating to apportionment of certain revenues ac-
10 cruing to the fund, is amended by striking “among the
11 States” and all that follows through the end of the first
12 sentence and inserting: “among the States and each of
13 American Samoa, Guam, the Northern Mariana Islands,
14 Puerto Rico, and the United States Virgin Islands in pro-
15 portion to the ratio that the population of each State and
16 each such territory bears to the population of all the
17 States and such territories, except that each State shall
18 be apportioned not more than 3 percent of such revenues,
19 and each State and each such territory shall be appor-
20 tioned not less than 1 percent of such revenues.”.

21 (b) APPORTIONMENT OF WILDLIFE CONSERVATION
22 AND RESTORATION ACCOUNT AMONG TERRITORIES AND
23 THE DISTRICT OF COLUMBIA.—The second subsection (c)
24 of section 4 of the Pittman-Robertson Wildlife Restoration
25 Act (16 U.S.C. 669c), as added by section 902(e) of H.R.

1 5548, as introduced in the 106th Congress and enacted
 2 into law by section 1(a)(2) of Public Law 106–55, and
 3 relating to apportionment of the Wildlife Conservation and
 4 Restoration Account, is amended by striking paragraph
 5 (1) and inserting the following:

6 “(1) The Secretary of the Interior shall appor-
 7 tion from the Wildlife Conservation and Restoration
 8 Account to each of the District of Columbia, Amer-
 9 ican Samoa, Guam, the Northern Mariana Islands,
 10 Puerto Rico, and the United States Virgin Islands a
 11 sum equal to not more than one-half of 1 percent of
 12 such Account.”.

13 (c) REPEAL OF PERCENTAGE RESTRICTIONS ON AP-
 14 PORTIONMENTS TO TERRITORIES.—Section 8A of the
 15 Pittman-Robertson Wildlife Restoration Act (16 U.S.C.
 16 669g–1) is amended by striking “as he shall determine,
 17 not exceeding” and all that follows through “, in any one
 18 year,” and inserting “as the Secretary shall determine for
 19 each year,”.

20 **SEC. 2. TECHNICAL CORRECTIONS TO PITTMAN-ROBERT-**
 21 **SON WILDLIFE RESTORATION ACT.**

22 (a) The first section and section 12 of the Pittman-
 23 Robertson Wildlife Restoration Act (16 U.S.C. 669, 669i)
 24 are each amended by striking “Secretary of Agriculture”
 25 and inserting “Secretary of the Interior”.

1 (b) Paragraph (2) of section 3(a) of such Act (16
2 U.S.C. 669b(a)) is amended—

3 (1) by moving such paragraph 2 ems to the left;
4 and

5 (2) by striking “16 U.S.C. 669(b)(1))” and in-
6 serting “subsection (b)(1)”.

7 (c)(1) Section 4 of such Act (16 U.S.C. 669c) is
8 amended by redesignating the second subsection (c) (as
9 added by section 902(e) of H.R. 5548, as introduced in
10 the 106th Congress and enacted into law by section
11 1(a)(2) of Public Law 106–55; relating to apportionment
12 of the Wildlife Conservation and Restoration Account) and
13 subsection (d) as subsections (d) and (e), respectively.

14 (2) Section 2(6) of such Act (16 U.S.C. 669a(6)) is
15 amended by striking “section 304(d)” and inserting “sec-
16 tion 4(e)”.

17 (3) Section 3(c)(2) of such Act (16 U.S.C.
18 669b(c)(2)) is amended by striking “sections 4(d) and (e)
19 of this Act,” and inserting “section 4(e),”.

20 (d) Subsection (d) of section 4 of such Act (16 U.S.C.
21 669c), as redesignated by paragraph (1) of this sub-
22 section, is further amended—

23 (1) in paragraph (1)—

1 (A) in subparagraph (A), by striking “to
2 the District” and inserting “To the District”;
3 and

4 (B) in subparagraph (B), by striking “to
5 Guam,” and inserting “To Guam,”; and

6 (2) in paragraph (2)(A)—

7 (A) in clause (i)—

8 (i) by striking “one-third of which is
9 based” and inserting “One-third of such
10 amount shall be apportioned based”; and

11 (ii) by striking “; and” and inserting
12 a period; and

13 (B) in clause (ii), by striking “two-thirds
14 of which is based” and inserting “Two-thirds of
15 such amount shall be apportioned based”.

16 (e) Section 6 of such Act (16 U.S.C. 669e) is amend-
17 ed—

18 (1) in subsection (a)—

19 (A) by inserting “(1)” before the first sen-
20 tence;

21 (B) by redesignating paragraphs (1) and
22 (2), as in effect before the enactment of this
23 paragraph, as subparagraphs (A) and (B) of
24 paragraph (1) (as designated by the amend-
25 ment made by subparagraph (A) of this para-

1 graph), and moving such subparagraphs 2 ems
 2 to the right; and

3 (C) by inserting “(2)” before “The Sec-
 4 retary of the Interior shall approve”; and

5 (2) in subsection (b), by striking “option (1) of
 6 subsection (a) of this section,” and inserting “sub-
 7 section (a)(1)(A),”.

8 **SEC. 3. APPORTIONMENT UNDER DINGELL-JOHNSON**
 9 **SPORT FISH RESTORATION ACT.**

10 Section 12 of the Dingell-Johnson Sport Fish Res-
 11 toration Act (16 U.S.C. 777K) is amended by striking “as
 12 he shall determine, not exceeding for Puerto Rico” and
 13 all that follows through “in any one year, but the Sec-
 14 retary” and inserting “as the Secretary shall determine,
 15 except the Secretary”.

16 **SEC. 4. TECHNICAL CORRECTIONS RELATING TO DINGELL-**
 17 **JOHNSON SPORT FISH RESTORATION ACT.**

18 (a) CORRECTIONS TO DINGELL-JOHNSON SPORT
 19 FISH RESTORATION ACT.—Section 4(a)(1) of the Dingell-
 20 Johnson Sport Fish Restoration Act (16 U.S.C.
 21 777c(a)(1)) is amended by striking “Protection,” and in-
 22 serting “Protection”.

23 (b) CORRECTIONS TO RELATED LAWS.—

1 (1) Section 111(f)(3) of Public Law 101–593
2 (16 U.S.C. 777e–1(f)(3)) is amended by striking
3 “section” and inserting “subsection”.

4 (2) Section 7404(d)(1) of Public Law 105–178
5 (16 U.S.C. 777g–1(d)(1)) is amended by striking
6 “section 4(a)(4)” and inserting “section
7 4(a)(3)(A)”.
