Mr. ROUZER introduced the following bill; which was referred to the Committee on Natural Resources

A BILL

To direct the Secretary of the Interior to annually designate at least one city in the United States as an “American World War II Heritage City”, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-
2 tives of the United States of America in Congress assembled,*

3 SECTION 1. AMERICAN WORLD WAR II HERITAGE CITIES.

4 (a) DESIGNATION.—In order to recognize and ensure
5 the continued preservation and importance of the history
6 of the United States involvement in World War II, each
7 calendar year the Secretary of the Interior shall designate
8 not less than one city located in one of the several States
9 or a territory of the United States as an “American World

1 War II Heritage City". Not more than one city in each
2 State or territory may be designated under this section.

3 (b) APPLICATION FOR DESIGNATION.—The Sec-
4 retary shall—

5 (1) establish and publicize the process by which
6 a city may apply for designation as an American
7 World War II Heritage City based on the criteria in
8 subsection (c); and

9 (2) encourage cities to apply for designation as
10 an American World War II Heritage City.

11 (c) CRITERIA FOR DESIGNATION.—The Secretary, in
12 consultation with the Secretary of the Smithsonian Insti-
13 tution or the President of the National Trust for Historic
14 Preservation, shall make each designation under sub-
15 section (a) based on the following criteria:

16 (1) Contributions by a city and its environs to
17 the World War II home-front war effort, including
18 contributions related to—

19 (A) defense manufacturing, such as ships,
20 aircraft, uniforms, and equipment;

21 (B) production of foodstuffs and consumer
22 items for Armed Forces and home consumption;

23 (C) war bond drives;

24 (D) adaptations to wartime survival;

25 (E) volunteer participation;

(F) civil defense preparedness;

(G) personnel serving in the Armed Forces, their achievements, and facilities for their rest and recreation; or

(H) the presence of Armed Forces camps, bases, airfields, harbors, repair facilities, and other installations within or in its environs.

(2) Achievements by a city and its environs to preserve the heritage and legacy of the city's contributions to the war effort and to preserve World War II history, including—

15 (B) establishment of museums, parks, and
16 markers:

(C) establishment of memorials to area
men who lost their lives in service;

19 (D) organizing groups of veterans and
20 home-front workers and their recognition;

(E) presentation of cultural events such as
dances, plays, and lectures;

(F) public relations outreach through the print and electronic media, and books; and

(G) recognition and ceremonies remem-
bering wartime event anniversaries such as
Pearl Harbor.

4 (d) THE FIRST “AMERICAN WORLD WAR II HERIT-
5 AGE CITY”.—Having met or exceeded all of criteria in
6 subsection (c), Wilmington, North Carolina, and its envi-
7 rons is hereby designated as an “American World War II
8 Heritage City”.
