AN ACT

To extend certain authorities relating to United States efforts to combat HIV/AIDS, tuberculosis, and malaria globally, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “PEPFAR Extension
3 Act of 2018”.

4 **SEC. 2. INSPECTORS GENERAL AND ANNUAL STUDY.**

5 Section 101 of the United States Leadership Against
6 HIV/AIDS, Tuberculosis, and Malaria Act of 2003 (22
7 U.S.C. 7611) is amended—

8 (1) in subsection (f)(1)—

9 (A) in subparagraph (A), by striking
10 “2018” and inserting “2023”; and

11 (B) in subparagraph (C)(iv)—

12 (i) by striking “four” and inserting
13 “nine”; and

14 (ii) by striking “2018” and inserting
15 “2023”; and

16 (2) in subsection (g)—

17 (A) in paragraph (1), by striking “2019”
18 and inserting “2024”; and

19 (B) in paragraph (2)—

20 (i) in the heading, by striking “2018”
21 and inserting “2024”; and

22 (ii) by striking “September 30, 2018”
23 and inserting “September 30, 2024”.

1 **SEC. 3. PARTICIPATION IN THE GLOBAL FUND TO FIGHT**
2 **AIDS, TUBERCULOSIS, AND MALARIA.**

3 Section 202(d) of the United States Leadership
4 Against HIV/AIDS, Tuberculosis, and Malaria Act of
5 2003 (22 U.S.C. 7622(d)) is amended—

6 (1) in paragraph (4)—

7 (A) in subparagraph (A)—

8 (i) in clause (i), by striking “fiscal
9 years 2009 through 2018” and inserting
10 “fiscal years 2004 through 2023”;

11 (ii) in clause (ii), by striking “2018”
12 and inserting “2023”; and

13 (iii) by striking clause (vi); and

14 (B) in subparagraph (B)—

15 (i) by striking clause (ii);

16 (ii) by redesignating clauses (iii) and
17 (iv) as clauses (ii) and (iii), respectively;

18 (iii) in clause (ii) (as redesignated by
19 clause (ii) of this subparagraph)—

20 (I) in the first sentence, by add-
21 ing at the end before the period the
22 following: “or section 104B or 104C
23 of such Act”; and

24 (II) in the second sentence, by
25 striking “for HIV/AIDS assistance”;
26 and

1 (iv) in clause (iii) (as redesignated by
2 clause (ii) of this subparagraph), by strik-
3 ing “2018” and inserting “2023”; and
4 (2) in paragraph (5), by striking “2018” and
5 inserting “2023”.

6 **SEC. 4. ALLOCATION OF FUNDS.**

7 Section 403 of the United States Leadership Against
8 HIV/AIDS, Tuberculosis, and Malaria Act of 2003 (22
9 U.S.C. 7673) is amended—

10 (1) in subsection (b), by striking “2018” and
11 inserting “2023”; and

12 (2) in subsection (c), in the matter preceding
13 paragraph (1), by striking “2018” and inserting
14 “2023”.
