A BILL

To extend certain authorities relating to United States efforts to combat HIV/AIDS, tuberculosis, and malaria globally, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “PEPFAR Extension Act*
5 *of 2018”.*

6 **SEC. 2. INSPECTORS GENERAL AND ANNUAL STUDY.**

7 *Section 101 of the United States Leadership Against*
8 *HIV/AIDS, Tuberculosis, and Malaria Act of 2003 (22*
9 *U.S.C. 7611) is amended—*

10 *(1) in subsection (f)(1)—*

11 *(A) in subparagraph (A), by striking*
12 *“2018” and inserting “2023”; and*

13 *(B) in subparagraph (C)(iv)—*

14 *(i) by striking “four” and inserting*
15 *“nine”; and*

16 *(ii) by striking “2018” and inserting*
17 *“2023”; and*

18 *(2) in subsection (g)—*

19 *(A) in paragraph (1), by striking “2019”*
20 *and inserting “2024”; and*

21 *(B) in paragraph (2)—*

22 *(i) in the heading, by striking “2018”*
23 *and inserting “2024”; and*

24 *(ii) by striking “September 30, 2018”*
25 *and inserting “September 30, 2024”.*

1 **SEC. 3. PARTICIPATION IN THE GLOBAL FUND TO FIGHT**
2 **AIDS, TUBERCULOSIS, AND MALARIA.**

3 *Section 202(d) of the United States Leadership*
4 *Against HIV/AIDS, Tuberculosis, and Malaria Act of 2003*
5 *(22 U.S.C. 7622(d)) is amended—*

6 *(1) in paragraph (4)—*

7 *(A) in subparagraph (A)—*

8 *(i) in clause (i), by striking “fiscal*
9 *years 2009 through 2018” and inserting*
10 *“fiscal years 2004 through 2023”;*

11 *(ii) in clause (ii), by striking “2018”*
12 *and inserting “2023”; and*

13 *(iii) by striking clause (vi); and*

14 *(B) in subparagraph (B)—*

15 *(i) by striking clause (ii);*

16 *(ii) by redesignating clauses (iii) and*
17 *(iv) as clauses (ii) and (iii), respectively;*

18 *(iii) in clause (ii) (as redesignated by*
19 *clause (ii) of this subparagraph)—*

20 *(I) in the first sentence, by adding*
21 *at the end before the period the fol-*
22 *lowing: “or section 104B or 104C of*
23 *such Act”; and*

24 *(II) in the second sentence, by*
25 *striking “for HIV/AIDS assistance”;*
26 *and*

1 *(iv) in clause (iii) (as redesignated by*
2 *clause (ii) of this subparagraph), by strik-*
3 *ing “2018” and inserting “2023”; and*
4 *(2) in paragraph (5), by striking “2018” and in-*
5 *serting “2023”.*

6 **SEC. 4. ALLOCATION OF FUNDS.**

7 *Section 403 of the United States Leadership Against*
8 *HIV/AIDS, Tuberculosis, and Malaria Act of 2003 (22*
9 *U.S.C. 7673) is amended—*

10 *(1) in subsection (b), by striking “2018” and in-*
11 *serting “2023”; and*

12 *(2) in subsection (c), in the matter preceding*
13 *paragraph (1), by striking “2018” and inserting*
14 *“2023”.*
