A BILL

To determine the feasibility of additional agreements for long-term use of existing or expanded non-Federal storage and conveyance facilities to augment Federal water supply, ecosystem, and operational flexibility benefits in certain areas, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Sustainable Water
5 Supplies Act”.

1 **SEC. 2. PILOT PROGRAM.**

2 (a) IN GENERAL.—In order to determine the feasi-
3 bility of agreements for long-term use of existing or ex-
4 panded non-Federal storage and associated conveyance fa-
5 cilities to augment Federal water supply, ecosystem, and
6 operational flexibility benefits, not later than 6 months
7 after the date of the enactment of this Act, the Secretary
8 of the Interior shall enter into cooperative agreements
9 with non-Federal entities to provide water supplies for
10 Central Valley Project contractors, units of the National
11 Wildlife Refuge System, State wildlife areas, and private
12 wetland areas. Agreements under this section shall—

13 (1) include the purchase of storage capacity in
14 non-Federal facilities from willing sellers; and

15 (2) provide reimbursement for the temporary
16 use of available capacity in existing above-ground,
17 off-stream storage, and associated conveyance facili-
18 ties owned by local water agencies.

19 (b) TREATMENT OF WATER DELIVERY WATER AS
20 REIMBURSABLE EXPENSE.—The cost of delivering water
21 to any Central Valley Project contractor that is not a wild-
22 life refuge shall be considered a reimbursable expense.

23 **SEC. 3. REPORT.**

24 Not later than 2 years after the date of the enact-
25 ment of this Act, the Secretary of the Interior shall com-
26 plete a report on the feasibility of the agreements de-

1 scribed in section 2 for long-term use of existing or ex-
2 panded non-Federal storage and conveyance facilities to
3 augment Federal water supply, ecosystem, and operational
4 flexibility benefits. The report shall be made available to
5 the Chief of the National Wildlife Refuge System and Cen-
6 tral Valley Project contractors.
