A BILL

To make technical corrections to provisions of law enacted
by the Frank LoBiondo Coast Guard Authorization Act
of 2018, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. TECHNICAL CORRECTIONS.**

4 (a) Upon the date amendments to section
5 3305(d)(3)(B) of title 46, United States Code, take effect
6 under section 501(a) of the Frank LoBiondo Coast Guard
7 Authorization Act of 2018 (Public Law 115–282), such
8 section is amended by striking “Coast Guard Authoriza-
9 tion Act of 2017” and inserting “Frank LoBiondo Coast
10 Guard Authorization Act of 2018”.

1 (b) Upon the date section 4312 of title 46, United
2 States Code, takes effect under section 503(c) of the
3 Frank LoBiondo Coast Guard Authorization Act of 2018
4 (Public Law 115–282), such section is amended by strik-
5 ing “Coast Guard Authorization Act of 2017” each place
6 it appears and inserting “Frank LoBiondo Coast Guard
7 Authorization Act of 2018”.

8 (c) Section 821(a)(2) of the Frank LoBiondo Coast
9 Guard Authorization Act of 2018 (Public Law 115–282)
10 is amended by striking “Coast Guard Authorization Act
11 of 2017” and inserting “this Act”.

12 (d) Section 820(b)(2) of the Frank LoBiondo Coast
13 Guard Authorization Act of 2018 (Public Law 115–282)
14 is amended by inserting “and the Consolidated Appropria-
15 tions Act, 2018 (Public Law 115–141)” after “(Public
16 Law 115–31)”.

17 (e) Section 820(a) of the Frank LoBiondo Coast
18 Guard Authorization Act of 2018 (Public Law 115–282)
19 is amended by striking “years 2018 and” and inserting
20 “year”.

21 (f) Section 810(d) of the Frank LoBiondo Coast
22 Guard Authorization Act of 2018 (Public Law 115–282)
23 is amended by striking “within 30 days after receiving the
24 notice under subsection (a)(1), the Secretary shall, by not
25 later than 60 days after transmitting such notice,” and

1 inserting “in accordance within subsection (a)(2), the Sec-
2 retary shall”.

3 (g) Subsections (a) and (d) of section 408 of the
4 Frank LoBiondo Coast Guard Authorization Act of 2018
5 (Public Law 115–282) shall have no force or effect.

6 (h) This section shall take effect on the date of the
7 enactment of the Frank LoBiondo Coast Guard Author-
8 ization Act of 2018 (Public Law 115–282) and apply as
9 if included therein as enacted.

10 **SEC. 2. ADVISORY COMMITTEE; REPRESENTATION.**

11 Section 15106(c)(3) of title 46, United States Code,
12 is amended—

13 (1) in subparagraph (C), by striking “mineral
14 and oil operations, including geophysical services”
15 and inserting “operations”;

16 (2) in subparagraph (D), by striking “explo-
17 ration and recovery”;

18 (3) in subparagraph (E), by striking “engaged
19 in diving services related to offshore construction,
20 inspection, and maintenance” and inserting “pro-
21 viding diving services to the offshore industry”;

22 (4) in subparagraph (F), by striking “engaged
23 in safety and training services related to offshore ex-
24 ploration and construction” and inserting “providing

1 safety and training services to the offshore indus-
2 try”;

3 (5) in subparagraph (G), by striking “engaged
4 in pipelaying services related to offshore construc-
5 tion” and inserting “providing subsea engineering,
6 construction, or remotely operated vehicle support to
7 the offshore industry”;

8 (6) in subparagraph (H), by striking “mineral
9 and energy”;

10 (7) in subparagraph (I), by striking “national
11 environmental entities” and inserting “entities pro-
12 viding environmental protection, compliance, or re-
13 sponse services to the offshore industry”; and

14 (8) in subparagraph (J), by striking “deepwater
15 ports” and inserting “entities engaged in offshore oil
16 exploration and production on the Outer Continental
17 Shelf adjacent to Alaska”.

18 **SEC. 3. TEMPORARY EARLY RETIREMENT AUTHORITY.**

19 Section 219 of the Coast Guard and Maritime Trans-
20 portation Act of 2012 (Public Law 112–213; 126 Stat.
21 1558) is amended by—

22 (1) striking “fiscal years” and inserting “fiscal
23 year”; and

1 (2) striking “2018” and inserting “calendar
2 year 2019”.
