

***In the Senate of the United States,***

*June 20, 2018.*

*Resolved*, That the bill from the House of Representatives (H.R. 770) entitled “An Act to require the Secretary of the Treasury to mint coins in recognition of American innovation and significant innovation and pioneering efforts of individuals or groups from each of the 50 States, the District of Columbia, and the United States territories, to promote the importance of innovation in the United States, the District of Columbia, and the United States territories, and for other purposes.”, do pass with the following

**AMENDMENT:**

Beginning on page 6, strike line 8 and all that follows through page 8, line 5, and insert the following:

1                   “(A) *ORDER OF ISSUANCE.*—  
2                   “(i) *IN GENERAL.*—*The coins issued*  
3                   *under this subsection commemorating either*  
4                   *an innovation, an individual innovator, or*  
5                   *a group of innovators, from each State, the*

1 *District of Columbia, or a territory shall be*  
2 *issued in the following order:*

3 “(I) *STATE.*—With respect to each  
4 *State, the coins shall be issued in the*  
5 *order in which the States ratified the*  
6 *Constitution of the United States or*  
7 *were admitted into the Union, as the*  
8 *case may be.*

9 “(II) *DISTRICT OF COLUMBIA AND*  
10 *TERRITORIES.*—After all coins are  
11 *issued under subclause (I), the coins*  
12 *shall be issued for the District of Co-*  
13 *lumbia and the territories in the fol-*  
14 *lowing order: the District of Columbia,*  
15 *the Commonwealth of Puerto Rico,*  
16 *Guam, American Samoa, the United*  
17 *States Virgin Islands, and the Com-*  
18 *monwealth of the Northern Mariana*  
19 *Islands.*

20 “(ii) *APPLICATION IN EVENT OF THE*  
21 *ADMISSION OF ADDITIONAL STATES.*—Not-  
22 *withstanding clause (i), if any additional*  
23 *State is admitted into the Union before the*  
24 *end of the 14-year period referred to in*  
25 *paragraph (1), the Secretary of the Treas-*

1            *ury may issue a \$1 coin with respect to the*  
 2            *additional State in accordance with clause*  
 3            *(i)(I).*

4            *“(iii) APPLICATION IN THE EVENT OF*  
 5            *INDEPENDENCE OR ADDING OF A TERRI-*  
 6            *TORY.—Notwithstanding clause (i)—*

7            *“(I) if any territory becomes inde-*  
 8            *pendent or otherwise ceases to be a ter-*  
 9            *ritory of the United States before \$1*  
 10           *coins are minted pursuant to this sub-*  
 11           *section, the subsection shall cease to*  
 12           *apply with respect to such territory;*  
 13           *and*

14           *“(II) if any new territory is*  
 15           *added to the United States, \$1 coins*  
 16           *shall be issued for such territories in*  
 17           *the order in which the new the terri-*  
 18           *tories are added, beginning after the \$1*  
 19           *coin is issued for the Commonwealth of*  
 20           *the Northern Mariana Islands.*

21           *“(B) ISSUANCE OF COINS COMMEMORATING*  
 22           *FOUR INNOVATIONS OR INNOVATORS DURING*  
 23           *EACH OF 14 YEARS.—*

24           *“(i) IN GENERAL.—Four \$1 coin de-*  
 25           *signs as described in this subsection shall be*

1           *issued during each year of the period re-*  
2           *ferred to in paragraph (1) until 1 coin fea-*  
3           *turing 1 innovation, an individual inno-*  
4           *vator, or a group of innovators, from each*  
5           *of the States, the District of Columbia, and*  
6           *territories has been issued.*

7           “(ii) *NUMBER OF COINS OF EACH DE-*  
8           *SIGN.—The Secretary shall prescribe, on the*  
9           *basis of such factors as the Secretary deter-*  
10          *mines to be appropriate, the number of \$1*  
11          *coins that shall be issued with each of the*  
12          *designs selected for each year of the period*  
13          *referred to in paragraph (1).*
