A BILL

To amend the National Trails System Act to designate the
Route 66 National Historic Trail, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Route 66 National His-*
 5 *toric Trail Designation Act”.*

6 **SEC. 2. DESIGNATION OF THE ROUTE 66 NATIONAL HIS-**
 7 **TORIC TRAIL.**

8 *Section 5(a) of the National Trails System Act (16*
 9 *U.S.C. 1244(a)) is amended by adding at the end the fol-*
 10 *lowing:*

11 *“(31) ROUTE 66 NATIONAL HISTORIC TRAIL.—*

12 *“(A) IN GENERAL.—The Route 66 National*
 13 *Historic Trail, a trail that includes all the*
 14 *alignments of U.S. Highway 66 in existence be-*
 15 *tween 1926 and 1985, extending along a route of*
 16 *approximately 2,400 miles from Chicago, Illi-*
 17 *nois, to Santa Monica, California, as generally*
 18 *depicted on the map entitled ‘Route 66 National*
 19 *Historic Trail, Proposed Route’, numbered P26/*
 20 *141,279, and dated December 2017.*

21 *“(B) AVAILABILITY OF MAP.—The map de-*
 22 *scribed in subparagraph (A) shall be on file and*
 23 *available for public inspection in the appro-*
 24 *priate offices of the National Park Service, De-*
 25 *partment of the Interior.*

1 “(C) *ADMINISTRATION.*—*The Route 66 Na-*
2 *tional Historic Trail shall be administered by*
3 *the Secretary of the Interior, acting through the*
4 *Director of the National Park Service. Such ad-*
5 *ministration shall be conducted in a manner*
6 *that respects and maintains the idiosyncratic*
7 *nature of the Route 66 National Historic Trail.*

8 “(D) *LAND ACQUISITION.*—*The United*
9 *States may not acquire for the Route 66 Na-*
10 *tional Historic Trail any land or interest in*
11 *land—*

12 “(i) *outside the exterior boundary of*
13 *any federally managed area without the*
14 *consent of the owner of the land or interest*
15 *in land; or*

16 “(ii) *that extends more than an aver-*
17 *age of one-quarter of a mile on either side*
18 *of the trail.*

19 “(E) *NO BUFFER ZONE CREATED.*—*Nothing*
20 *in this Act, the acquisition of the land or an in-*
21 *terest in land authorized by this Act, or the*
22 *management plan for the Route 66 National*
23 *Historic Trail shall be construed to create buffer*
24 *zones outside of the Trail. That activities or uses*
25 *can be seen, heard, or detected from the acquired*

1 *land shall not preclude, limit, control, regulate,*
2 *or determine the conduct or management of ac-*
3 *tivities or uses outside of the trail.*

4 “(F) *ENERGY.*—*Nothing in this Act, the ac-*
5 *quisition of land or an interest in land author-*
6 *ized by this Act, or the management plan for the*
7 *Route 66 National Historic Trail shall prohibit,*
8 *hinder, or disrupt the development, production,*
9 *or transmission of energy.*

10 “(G) *EMINENT DOMAIN OR CONDEMNATION.*—*In carrying out this Act, the Secretary of*
11 *the Interior may not use eminent domain or con-*
12 *demnation.”.*
