# **A BILL**

To redesignate the Saint-Gaudens National Historic Site as the “Saint-Gaudens National Historical Park”, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
 2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       *This Act may be cited as the “Saint-Gaudens National*  
 5       *Historical Park Redesignation Act”.*

6       **SEC. 2. DESIGNATION OF SAINT-GAUDENS NATIONAL HIS-**  
 7               **TORICAL PARK.**

8       *(a) IN GENERAL.—The Saint-Gaudens National His-*  
 9       *toric Site shall be known and designated as the “Saint-*  
 10       *Gaudens National Historical Park”.*

11       *(b) AMENDMENTS TO PUBLIC LAW 88–543.—Public*  
 12       *Law 88–543 (78 Stat.749) is amended—*

13               *(1) by striking “National Historic Site” each*  
 14       *place it appears and inserting “National Historical*  
 15       *Park”;*

16               *(2) in section 2(a), by striking “historic site”*  
 17       *and inserting “Saint-Gaudens National Historical*  
 18       *Park”;*

19               *(3) in section 3, by—*

20                       *(A) striking “national historical site” and*  
 21                       *inserting “Saint-Gaudens National Historical*  
 22                       *Park”; and*

23                       *(B) striking “part of the site” and inserting*  
 24                       *“part of the park”; and*

1           (4) in section 4(b), by striking “traditional to  
2       the site” and inserting “traditional to the park”.

3       (c) *REFERENCES*.—Any reference in any law, regula-  
4       tion, document, record, map, or other paper of the United  
5       States to the Saint-Gaudens National Historic Site shall  
6       be considered to be a reference to the “Saint-Gaudens Na-  
7       tional Historical Park”.
