## RESOLUTION

Directing the Secretary of Homeland Security to transmit certain documents to the House of Representatives relating to the Department of Homeland Security’s research, integration, and analysis activities relating to Russian Government interference in the elections for Federal office held in 2016.

1       *Resolved*, That, not later than 14 days after the date  
2 of the adoption of this resolution, the Secretary of Home-  
3 land Security is directed to transmit to the House of Rep-  
4 resentatives, to the extent that such information is in the  
5 possession of the Secretary, copies of any document,  
6 record, memo, correspondence, or other communication or  
7 any portion of any such communication of the Department  
8 of Homeland Security (in a classified format, if nec-  
9 essary), that refers or relates to the following:

10           (1) Research, integration, and analysis activities  
11       of the Department relating to interference with the  
12       elections for Federal office held in 2016 by or at the  
13       direction of the Russian Government, as announced  
14       in a joint statement with the Office of the Director  
15       of National Intelligence on October 7, 2016, and De-  
16       cember 29, 2016.

17           (2) Dissemination by the Department of infor-  
18       mation regarding interference with the elections for  
19       Federal office held in 2016 by or at the direction of  
20       the Russian Government, as announced in a joint  
21       statement with the Office of the Director of National  
22       Intelligence on October 7, 2016, and December 29,  
23       2016.

24           (3) Research into cyber compromises of emails  
25       of United States persons and institutions by or at

1 the direction of the Russian Government to interfere  
2 with the elections for Federal office held in 2016.

3 (4) Integration, analysis, and dissemination of  
4 the Joint Analysis Report detailing the tools and in-  
5 frastructure used by Russian intelligence services to  
6 compromise and exploit networks and infrastructure  
7 associated with the elections for Federal office held  
8 in 2016 issued by the Secretary of Homeland Secu-  
9 rity and the Director of the Federal Bureau of In-  
10 vestigation on December 29, 2016.
