- 16 opponent, shall not be subject to amendment, and shall

- SEC. 3. It shall be in order at any time for the chair
- 24 of the Committee on Armed Services or his designee to
- 25 offer amendments en bloc consisting of amendments print-

- 1 ed in the report of the Committee on Rules accompanying
- 2 this resolution not earlier disposed of. Amendments en
- 3 bloc offered pursuant to this section shall be considered
- 4 as read, shall be debatable for 20 minutes equally divided
- 5 and controlled by the chair and ranking minority member
- 6 of the Committee on Armed Services or their designees,
- 7 shall not be subject to amendment, and shall not be sub-
- 8 ject to a demand for division of the question in the House
- 9 or in the Committee of the Whole.
- Sec. 4. At the conclusion of consideration of the bill
- 11 for amendment pursuant to this resolution the Committee
- 12 shall rise and report the bill to the House with such fur-

- 15 amendments thereto to final passage without intervening
