Mr. Burgess, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 806) to facilitate efficient State implementation of ground-level ozone standards, and for other purposes.

- 1 Resolved, That at any time after adoption of this reso-
- 2 lution the Speaker may, pursuant to clause 2(b) of rule
- 3 XVIII, declare the House resolved into the Committee of
- 4 the Whole House on the state of the Union for consider-
- 5 ation of the bill (H.R. 806) to facilitate efficient State im-
- 6 plementation of ground-level ozone standards, and for
- 7 other purposes. The first reading of the bill shall be dis-

pensed with. All points of order against consideration of the bill are waived. General debate shall be confined to 3 the bill and shall not exceed one hour equally divided and 4 controlled by the chair and ranking minority member of the Committee on Energy and Commerce. After general debate the bill shall be considered for amendment under the five-minute rule. In lieu of the amendment in the na-8 ture of a substitute recommended by the Committee on Energy and Commerce now printed in the bill, it shall be 10 in order to consider as an original bill for the purpose of amendment under the five-minute rule an amendment in 12 the nature of a substitute consisting of the text of Rules Committee Print 115-26. That amendment in the nature of a substitute shall be considered as read. All points of 14 15 order against that amendment in the nature of a substitute are waived. No amendment to that amendment in 16 the nature of a substitute shall be in order except those printed in the report of the Committee on Rules accom-18 panying this resolution. Each such amendment may be of-19 20 fered only in the order printed in the report, may be of-21 fered only by a Member designated in the report, shall be considered as read, shall be debatable for the time spec-23 ified in the report equally divided and controlled by the proponent and an opponent, shall not be subject to amendment, and shall not be subject to a demand for division

- 1 of the question in the House or in the Committee of the
- 2 Whole. All points of order against such amendments are
- 3 waived. At the conclusion of consideration of the bill for
- 4 amendment the Committee shall rise and report the bill
- 5 to the House with such amendments as may have been
- 6 adopted. Any Member may demand a separate vote in the
- 7 House on any amendment adopted in the Committee of
- 8 the Whole to the bill or to the amendment in the nature
- 9 of a substitute made in order as original text. The previous
- 10 question shall be considered as ordered on the bill and
- 11 amendments thereto to final passage without intervening
- 12 motion except one motion to recommit with or without in-
- 13 structions.
