6 days after the date of the adoption of this resolution, copies of every document, map, survey, report, record, memorandum, call log, correspondence (electronic and otherwise), and other communication or any portion of any such
7 communication, that refers or relates to the executive
8 order on the review of designations under the Antiquities
9 Act (E.O. 13792, April, 26, 2017), including the following:
