- 11 Judiciary; and (2) one motion to recommit.
- 12 Sec. 2. On any legislative day during the period from
- 13 January 22, 2018, through January 26, 2018—
- 14 (a) the Journal of the proceedings of the previous day
- 15 shall be considered as approved; and
- 16 (b) the Chair may at any time declare the House ad-
- 17 journed to meet at a date and time, within the limits of
- 18 clause 4, section 5, article I of the Constitution, to be an-
- 19 nounced by the Chair in declaring the adjournment.
- Sec. 3. The Speaker may appoint Members to per-
- 21 form the duties of the Chair for the duration of the period
- 22 addressed by section 2 of this resolution as though under
- 23 clause 8(a) of rule I.
