Mr. WOODALL, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 5698) to amend title 18, United States Code, to punish criminal offenses targeting law enforcement officers, and for other purposes; providing for consideration of the bill (S. 2372) to amend title 38, United States Code, to provide outer burial receptacles for remains buried in National Parks, and for other purposes; and providing for consideration of the bill (H.R. 2) to provide for the reform and con-

tinuation of agricultural and other programs of the Department of Agriculture through fiscal year 2023, and for other purposes.

1 *Resolved*, That upon adoption of this resolution it
2 shall be in order to consider in the House the bill (H.R.
3 5698) to amend title 18, United States Code, to punish
4 criminal offenses targeting law enforcement officers, and
5 for other purposes. All points of order against consider-
6 ation of the bill are waived. The bill shall be considered
7 as read. All points of order against provisions in the bill
8 are waived. The previous question shall be considered as
9 ordered on the bill and on any amendment thereto to final
10 passage without intervening motion except: (1) one hour
11 of debate equally divided and controlled by the chair and
12 ranking minority member of the Committee on the Judici-
13 ary; (2) the further amendment printed in part A of the
14 report of the Committee on Rules accompanying this reso-
15 lution, if offered by the Member designated in the report,
16 which shall be in order without intervention of any point
17 of order, shall be considered as read, shall be separately
18 debatable for the time specified in the report equally di-
19 vided and controlled by the proponent and an opponent,
20 and shall not be subject to a demand for division of the
21 question; and (3) one motion to recommit with or without
22 instructions.

1 SEC. 2. Upon adoption of this resolution it shall be
2 in order to consider in the House the bill (S. 2372) to
3 amend title 38, United States Code, to provide outer bur-
4 ial receptacles for remains buried in National Parks, and
5 for other purposes. All points of order against consider-
6 ation of the bill are waived. An amendment in the nature
7 of a substitute consisting of the text of H.R. 5674 as re-
8 ported by the Committee on Veterans' Affairs, as modified
9 by the amendment printed in part B of the report of the
10 Committee on Rules accompanying this resolution, shall
11 be considered as adopted. The bill, as amended, shall be
12 considered as read. All points of order against provisions
13 in the bill, as amended, are waived. The previous question
14 shall be considered as ordered on the bill, as amended,
15 and on any further amendment thereto, to final passage
16 without intervening motion except: (1) one hour of debate
17 equally divided and controlled by the chair and ranking
18 minority member of the Committee on Veterans' Affairs;
19 and (2) one motion to recommit with or without instruc-
20 tions.

21 SEC. 3. At any time after adoption of this resolution
22 the Speaker may, pursuant to clause 2(b) of rule XVIII,
23 declare the House resolved into the Committee of the
24 Whole House on the state of the Union for consideration
25 of the bill (H.R. 2) to provide for the reform and continu-

1 ation of agricultural and other programs of the Depart-
2 ment of Agriculture through fiscal year 2023, and for
3 other purposes. The first reading of the bill shall be dis-
4 pensed with. All points of order against consideration of
5 the bill are waived. General debate shall be confined to
6 the bill and shall not exceed one hour equally divided and
7 controlled by the chair and ranking minority member of
8 the Committee on Agriculture. After general debate the
9 bill shall be considered for amendment under the five-
10 minute rule. It shall be in order to consider as an original
11 bill for the purpose of amendment under the five-minute
12 rule the amendment in the nature of a substitute rec-
13 ommended by the Committee on Agriculture now printed
14 in the bill. The committee amendment in the nature of
15 a substitute shall be considered as read. All points of order
16 against the committee amendment in the nature of a sub-
17 stitute are waived. No amendment to the committee
18 amendment in the nature of a substitute shall be in order
19 except those printed in part C of the report of the Com-
20 mittee on Rules accompanying this resolution. Each such
21 amendment may be offered only in the order printed in
22 the report, may be offered only by a Member designated
23 in the report, shall be considered as read, shall be debat-
24 able for the time specified in the report equally divided
25 and controlled by the proponent and an opponent, shall

1 not be subject to amendment, and shall not be subject to
2 a demand for division of the question in the House or in
3 the Committee of the Whole. All points of order against
4 such amendments are waived. At the conclusion of consid-
5 eration of the bill for amendment pursuant to this resolu-
6 tion, the Committee of the Whole shall rise without mo-
7 tion. No further consideration of the bill shall be in order
8 except pursuant to a subsequent order of the House.
