A BILL

To amend title XVIII of the Social Security Act to provide for coverage under the Medicare program of pharmacist services.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Pharmacy and Medi-
5 cally Underserved Areas Enhancement Act”.

1 **SEC. 2. MEDICARE COVERAGE OF PHARMACIST SERVICES.**

2 (a) **COVERAGE.**—Section 1861(s)(2) of the Social Se-
3 curity Act (42 U.S.C. 1395x(s)(2)) is amended—

4 (1) by striking “and” at the end of subpara-
5 graph (FF);

6 (2) by adding “and” at the end of subpara-
7 graph (GG); and

8 (3) by inserting after subparagraph (GG) the
9 following new subparagraph:

10 “(HH) pharmacist services furnished by a phar-
11 macist, as licensed by State law, individually or on
12 behalf of a pharmacy provider—

13 “(i) which the pharmacist is legally author-
14 ized to perform in the State in which the indi-
15 vidual performs such services;

16 “(ii) as would otherwise be covered under
17 this part if furnished by a physician, or as an
18 incident to a physician’s service; and

19 “(iii) in a setting located in a health pro-
20 fessional shortage area (as defined in section
21 332(a)(1)(A) of the Public Health Service Act),
22 medically underserved area, or medically under-
23 served population (as defined in section
24 330(b)(3) of such Act);”.

25 (b) **PAYMENT.**—Section 1833(a)(1) of the Social Se-
26 curity Act (42 U.S.C. 1395l(a)(1)) is amended—

1 (1) by striking “and (BB)” and inserting
2 “(BB)”; and

3 (2) by inserting before the semicolon at the end
4 the following: “, and (CC) with respect to phar-
5 macist services (as defined in section
6 1861(s)(2)(HH)), the amounts paid shall be equal to
7 80 percent of the lesser of the actual charge or 85
8 percent of the fee schedule amount provided under
9 section 1848 if such services had been furnished by
10 a physician”.

11 (c) EFFECTIVE DATE; PHARMACIST SPECIFIC
12 CODES.—

13 (1) EFFECTIVE DATE.—The amendments made
14 by subsections (a) and (b) shall apply with respect
15 to services furnished on or after January 1, 2018.

16 (2) PHARMACIST SPECIFIC CODES.—The Sec-
17 retary of Health and Human Services shall develop
18 pharmacist specific codes, as necessary, under the
19 physician fee schedule under section 1848 of the So-
20 cial Security Act (42 U.S.C. 1395w-4).
