## A BILL

To amend title 46, United States Code, to authorize appropriations for the program to provide assistance for small shipyards and maritime communities through fiscal year 2020, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Small Shipyards and  
5 Maritime Communities Act”.

6 **SEC. 2. AUTHORIZATION OF APPROPRIATIONS.**

7 Subsection (i) of section 54101 of title 46, United  
8 States Code, is amended—

1 (1) in the matter preceding paragraph (1), by  
2 striking “2017” and inserting “2020”;

3 (2) in paragraph (1), by striking “\$5,000,000”  
4 and inserting “\$7,500,00”; and

5 (3) in paragraph (2), by striking  
6 “\$25,000,000” and inserting “\$27,500,000”.

7 **SEC. 3. AWARD OF GRANTS.**

8 Subsection (b) of section 54101 of title 46, United  
9 States Code, is amended to read as follows:

10 “(b) AWARDS.—

11 “(1) IN GENERAL.—In providing assistance  
12 under the program, the Administrator shall take into  
13 account—

14 “(A) the economic circumstances and con-  
15 ditions of maritime communities;

16 “(B) projects that would be effective in  
17 fostering efficiency, competitive operations, and  
18 quality ship construction, repair, and reconfig-  
19 uration; and

20 “(C) projects that would be effective in  
21 fostering employee skills and enhancing produc-  
22 tivity.

23 “(2) TIMING OF AWARD.—

24 “(A) IN GENERAL.—Except as provided in  
25 subparagraph (B), the Administrator shall

1           make grants under this section within 120 days  
2           after the date of enactment of the appropria-  
3           tions Act for the fiscal year concerned.

4           “(B) REALLOCATION OF UNUSED  
5           FUNDS.—If a grant is awarded under this sec-  
6           tion and, for any reason, the grant funds are  
7           not used by the grantee, the Administrator may  
8           use such unused funds to make another grant  
9           under this section.”.

10 **SEC. 4. BUY AMERICA.**

11           Subsection (c) of section 54101 of title 46, United  
12 States Code, is amended by adding at the end the fol-  
13 lowing:

14           “(3) BUY AMERICA.—

15           “(A) REQUIREMENT.—A grant provided  
16           under this section may be used for a project  
17           only if the steel, iron, and manufactured goods  
18           used in the project are produced in the United  
19           States.

20           “(B) WAIVER.—The Administrator may  
21           waive subparagraph (A) if the Administrator  
22           finds that the waiver would be permitted under  
23           paragraph (2) of section 5323(j) of title 49,  
24           United States Code.”.
