**A BILL**

To amend section 21 of the Small Business Act to require cyber certification for small business development center counselors, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Small Business Cyber  
5 Training Act of 2017”.

1 **SEC. 2. DUTIES OF SMALL BUSINESS DEVELOPMENT CEN-**  
2 **TER COUNSELORS.**

3 (a) CYBER TRAINING.—Section 21 of the Small Busi-  
4 ness Act (15 U.S.C. 648) is amended by adding at the  
5 end the following:

6 “(o) CYBER STRATEGY TRAINING FOR SMALL BUSI-  
7 NESS DEVELOPMENT CENTERS.—

8 “(1) DEFINITIONS.—In this subsection—

9 “(A) the term ‘cyber strategy’ means re-  
10 sources and tactics to assist in planning for cy-  
11 bersecurity and defending against cyber risks  
12 and attacks; and

13 “(B) the term ‘lead small business develop-  
14 ment center’ means a small business develop-  
15 ment center that has received a grant from the  
16 Administration.

17 “(2) CERTIFICATION PROGRAM.—The Adminis-  
18 trator shall establish a cyber counseling program, or  
19 designate an existing program, under which the Ad-  
20 ministrator may certify the employees of lead small  
21 business development centers in providing cyber  
22 planning assistance to small business concerns.

23 “(3) NUMBER OF CERTIFIED EMPLOYEES.—  
24 The Administrator shall ensure that the number of  
25 employees of each lead small business development

1 center who are certified in providing cyber assistance  
2 is not less than the lesser of—

3 “(A) 5; or

4 “(B) 10 percent of the total number of em-  
5 ployees of the lead small business development  
6 center.

7 “(4) CYBER STRATEGY.—In carrying out para-  
8 graph (2), the Administrator, to the extent prac-  
9 ticable, shall consider any cyber strategy methods in-  
10 cluded in the Small Business Development Center  
11 Cyber Strategy developed under section  
12 1841(a)(3)(B) of the National Defense Authoriza-  
13 tion Act for Fiscal Year 2017 (Public Law 114-  
14 328).

15 “(5) REIMBURSEMENT FOR CERTIFICATION.—

16 “(A) IN GENERAL.—Subject to the avail-  
17 ability of appropriations, the Administrator  
18 shall reimburse a lead small business develop-  
19 ment center for costs relating to the certifi-  
20 cation of an employee of the lead small business  
21 center in providing cyber planning assistance  
22 under the program established under paragraph  
23 (2).

24 “(B) LIMITATION.—The total amount re-  
25 imbursed by the Administrator under subpara-

1 graph (A) may not exceed \$350,000 in any fis-  
2 cal year.”.

3 (b) IMPLEMENTATION.—Not later than 180 days  
4 after the date of enactment of this Act, the Administrator  
5 of the Small Business Administration shall implement  
6 paragraphs (2), (3), and (4) of section 21(o) of the Small  
7 Business Act, as added by subsection (a).
