## A BILL

To establish Fort Sumter and Fort Moultrie National Park in the State of South Carolina, and for other purposes.

1        *Be it enacted by the Senate and House of Representa-*  
2        *tives of the United States of America in Congress assembled,*

3        **SECTION 1. SHORT TITLE.**

4        This Act may be cited as the “Fort Sumter and Fort  
5        Moultrie National Park Act of 2017”.

1 **SEC. 2. FINDINGS.**

2 Congress finds that—

3 (1) Fort Sumter National Monument was es-  
4 tablished by the Joint Resolution entitled “Joint  
5 Resolution to establish the Fort Sumter National  
6 Monument in the State of South Carolina”, ap-  
7 proved April 28, 1948 (16 U.S.C. 450ee), to com-  
8 memorate historic events in the vicinity of Fort  
9 Sumter, the site of the first engagement of the Civil  
10 War on April 12, 1861;

11 (2) Fort Moultrie—

12 (A) was the site of the first defeat of the  
13 British in the Revolutionary War on June 28,  
14 1776; and

15 (B) was acquired by the Federal Govern-  
16 ment from the State of South Carolina in 1960  
17 under the authority of chapter 3201 of title 54,  
18 United States Code;

19 (3) since 1960, Fort Moultrie has been admin-  
20 istered by the National Park Service as part of the  
21 Fort Sumter National Monument without a clear  
22 management mandate or established boundary;

23 (4) Fort Sumter and Fort Moultrie played im-  
24 portant roles in the protection of Charleston Harbor  
25 and in the coastal defense system of the United  
26 States;

1           (5) Fort Moultrie is the only site in the Na-  
2           tional Park System that preserves the history of the  
3           United States coastal defense system during the pe-  
4           riod from 1776 through 1947; and

5           (6) Sullivan’s Island Life Saving Station, lo-  
6           cated adjacent to the Charleston Light—

7                   (A) was constructed in 1896; and

8                   (B) is listed on the National Register of  
9           Historic Places.

10 **SEC. 3. DEFINITIONS.**

11       In this Act:

12           (1) MAP.—The term “map” means the map en-  
13           titled “Boundary Map, Fort Sumter and Fort  
14           Moultrie National Historical Park”, numbered 392/  
15           80,088, and dated November 30, 2009.

16           (2) PARK.—The term “Park” means the Fort  
17           Sumter and Fort Moultrie National Park established  
18           by section 4(a).

19           (3) SECRETARY.—The term “Secretary” means  
20           the Secretary of the Interior.

21           (4) STATE.—The term “State” means the State  
22           of South Carolina.

23           (5) SULLIVAN’S ISLAND LIFE SAVING STATION  
24           HISTORIC DISTRICT.—The term “Sullivan’s Island  
25           Life Saving Station Historic District” means the

1 Charleston Lighthouse, the boathouse, garage, bunk-  
2 er/sighting station, signal tower, and any associated  
3 land and improvements to the land that are located  
4 between Sullivan's Island Life Saving Station and  
5 the mean low water mark.

6 **SEC. 4. FORT SUMTER AND FORT MOULTRIE NATIONAL**  
7 **PARK.**

8 (a) **ESTABLISHMENT.**—There is established the Fort  
9 Sumter and Fort Moultrie National Park in the State as  
10 a unit of the National Park System to preserve, maintain,  
11 and interpret the nationally significant historical values  
12 and cultural resources associated with Fort Sumter, Fort  
13 Moultrie, and the Sullivan's Island Life Saving Station  
14 Historic District.

15 (b) **BOUNDARY.**—

16 (1) **IN GENERAL.**—The boundary of the Park  
17 shall be comprised of the land, water, and sub-  
18 merged land depicted on the map.

19 (2) **AVAILABILITY OF MAP.**—The map shall be  
20 on file and available for public inspection in the ap-  
21 propriate offices of the National Park Service.

22 (c) **ADMINISTRATION.**—

23 (1) **IN GENERAL.**—The Secretary, acting  
24 through the Director of the National Park Service,  
25 shall administer the Park in accordance with this

1 Act and the laws generally applicable to units of the  
2 National Park System, including—

3 (A) ~~section 100101(a), chapter 1003, and~~  
4 ~~sections 100751(a), 100752, 100753, and~~  
5 ~~102101 of title 54, United States Code; and~~

6 (B) ~~chapter 3201 of title 54, United States~~  
7 ~~Code.~~

8 (2) INTERPRETATION OF HISTORICAL  
9 EVENTS.—The Secretary shall provide for the inter-  
10 pretation of historical events and activities that oc-  
11 curred in the vicinity of Fort Sumter and Fort  
12 Moultrie, including—

13 (A) the Battle of Sullivan’s Island on June  
14 28, 1776;

15 (B) the Siege of Charleston during 1780;

16 (C) the Civil War, including—

17 (i) the bombardment of Fort Sumter  
18 by Confederate forces on April 12, 1861;  
19 and

20 (ii) any other events of the Civil War  
21 that are associated with Fort Sumter and  
22 Fort Moultrie;

23 (D) the development of the coastal defense  
24 system of the United States during the period

1 from the Revolutionary War to World War II,  
2 including—

3 (i) the Sullivan’s Island Life Saving  
4 Station;

5 (ii) the lighthouse associated with the  
6 Sullivan’s Island Life Saving Station; and

7 (iii) the coastal defense sites con-  
8 structed during the period of fortification  
9 construction from 1898 to 1942, known as  
10 the “Endicott Period”; and

11 (E) the lives of—

12 (i) the free and enslaved workers who  
13 built and maintained Fort Sumter and  
14 Fort Moultrie;

15 (ii) the soldiers who defended the  
16 forts;

17 (iii) the prisoners held at the forts;  
18 and

19 (iv) captive Africans bound for slavery  
20 who, after first landing in the United  
21 States, were brought to quarantine houses  
22 in the vicinity of Fort Moultrie in the 18th  
23 century, if the Secretary determines that  
24 the quarantine houses and associated his-  
25 torical values are nationally significant.

1 (d) COOPERATIVE AGREEMENTS.—The Secretary  
 2 may enter into cooperative agreements with public and  
 3 private entities and individuals to carry out this Act.

4 **SEC. 5. REPEAL OF EXISTING LAW.**

5 Section 2 of the Joint Resolution entitled “Joint Res-  
 6 olution to establish the Fort Sumter National Monument  
 7 in the State of South Carolina”, approved April 28, 1948  
 8 (16 U.S.C. 450ee-1), is repealed.

9 **SECTION 1. SHORT TITLE.**

10 *This Act may be cited as the “Fort Sumter and Fort*  
 11 *Moultrie National Historical Park Act of 2018”.*

12 **SEC. 2. DEFINITIONS.**

13 *In this Act:*

14 (1) *MAP.*—The term “map” means the map enti-  
 15 tled “Boundary Map, Fort Sumter and Fort Moultrie  
 16 National Historical Park”, numbered 392/80,088, and  
 17 dated August 2009.

18 (2) *PARK.*—The term “Park” means the Fort  
 19 Sumter and Fort Moultrie National Historical Park  
 20 established by section 3(a).

21 (3) *SECRETARY.*—The term “Secretary” means  
 22 the Secretary of the Interior.

23 (4) *STATE.*—The term “State” means the State  
 24 of South Carolina.

1           (5) *SULLIVAN’S ISLAND LIFE SAVING STATION*  
2           *HISTORIC DISTRICT.*—*The term “Sullivan’s Island*  
3           *Life Saving Station Historic District” means the*  
4           *Charleston Lighthouse, the boathouse, garage, bunker/*  
5           *sighting station, signal tower, and any associated*  
6           *land and improvements to the land that are located*  
7           *between Sullivan’s Island Life Saving Station and*  
8           *the mean low water mark.*

9   **SEC. 3. FORT SUMTER AND FORT MOULTRIE NATIONAL HIS-**  
10                                   **TORICAL PARK.**

11           (a) *ESTABLISHMENT.*—*There is established the Fort*  
12           *Sumter and Fort Moultrie National Historical Park in the*  
13           *State as a single unit of the National Park System to pre-*  
14           *serve, maintain, and interpret the nationally significant*  
15           *historical values and cultural resources associated with Fort*  
16           *Sumter National Monument, Fort Moultrie National Monu-*  
17           *ment, and the Sullivan’s Island Life Saving Station His-*  
18           *toric District.*

19           (b) *BOUNDARY.*—*The boundary of the Park shall be*  
20           *as generally depicted on the map.*

21           (c) *AVAILABILITY OF MAP.*—*The map shall be on file*  
22           *and available for public inspection in the appropriate of-*  
23           *fices of the National Park Service.*

24           (d) *ADMINISTRATION.*—



1           (1) *IN GENERAL.*—*The Secretary, acting through*  
2           *the Director of the National Park Service, shall ad-*  
3           *minister the Park in accordance with this Act and the*  
4           *laws generally applicable to units of the National*  
5           *Park System, including—*

6                     (A) *section 100101(a), chapter 1003, and*  
7                     *sections 100751(a), 100752, 100753, and 102101*  
8                     *of title 54, United States Code; and*

9                     (B) *chapter 3201 of title 54, United States*  
10                    *Code.*

11           (2) *INTERPRETATION OF HISTORICAL EVENTS.*—  
12           *The Secretary shall provide for the interpretation of*  
13           *historical events and activities that occurred in the*  
14           *vicinity of Fort Sumter and Fort Moultrie, includ-*  
15           *ing—*

16                     (A) *the Battle of Sullivan’s Island on June*  
17                     *28, 1776;*

18                     (B) *the Siege of Charleston during 1780;*

19                     (C) *the Civil War, including—*

20                             (i) *the bombardment of Fort Sumter by*  
21                             *Confederate forces on April 12, 1861; and*

22                             (ii) *any other events of the Civil War*  
23                             *that are associated with Fort Sumter and*  
24                             *Fort Moultrie;*

1           (D) the development of the coastal defense  
2 system of the United States during the period  
3 from the Revolutionary War to World War II,  
4 including—

5           (i) the Sullivan’s Island Life Saving  
6 Station;

7           (ii) the lighthouse associated with the  
8 Sullivan’s Island Life Saving Station; and

9           (iii) the coastal defense sites con-

11 construction from 1898 to 1942, known as  
12 the “Endicott Period”; and

13       (E) the lives of—

14           (i) the free and enslaved workers who

1           (e) *COOPERATIVE AGREEMENTS.*—*The Secretary may*  
2 *enter into cooperative agreements with public and private*  
3 *entities and individuals to carry out this Act.*

4 **SEC. 4. REPEAL OF EXISTING LAW.**

5           *Section 2 of the Joint Resolution entitled “Joint Reso-*  
6 *lution to establish the Fort Sumter National Monument in*  
7 *the State of South Carolina”, approved April 28, 1948 (16*  
8 *U.S.C. 450ee-1), is repealed.*

Amend the title so as to read: “A bill to establish Fort Sumter and Fort Moultrie National Historical Park in the State of South Carolina, and for other purposes.”.
