A BILL

To authorize the Office on Violence Against Women to improve the handling of crimes of domestic violence, dating violence, sexual assault, and stalking by incorporating a trauma-informed approach into the initial response to and investigation of such crimes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Abby Honold Act".
- 5 SEC. 2. DEMONSTRATION PROGRAM ON TRAUMA-IN-
- 6 FORMED TRAINING FOR LAW ENFORCEMENT.
- 7 (a) Definitions.—In this section—

1	(1) the term "Attorney General" means the At-
2	torney General, acting through the Director of the
3	Office on Violence Against Women;
4	(2) the term "covered individual" means an in-
5	dividual who interfaces with victims of domestic vio-
6	lence, dating violence, sexual assault, and stalking,
7	including—
8	(A) an individual working for or on behalf
9	of an eligible entity;
10	(B) a school or university administrator;
11	and
12	(C) an emergency services or medical em-
13	ployee;
14	(3) the term "demonstration site", with respect
15	to an eligible entity that receives a grant under this
16	section, means—
17	(A) if the eligible entity is a law enforce-
18	ment agency described in paragraph (4)(A), the
19	area over which the eligible entity has jurisdic-
20	tion; and
21	(B) if the eligible entity is an organization
22	or agency described in paragraph (4)(B), the
23	area over which a law enforcement agency de-
24	scribed in paragraph (4)(A) that is working in

1	collaboration with the eligible entity has juris-
2	diction; and
3	(4) the term "eligible entity" means—
4	(A) a State, local, territorial, or tribal law
5	enforcement agency; or
6	(B) a national, regional, or local victim
7	services organization or agency working in col-
8	laboration with a law enforcement agency de-
9	scribed in subparagraph (A).
10	(b) Grants Authorized.—
11	(1) In General.—The Attorney General shall
12	award grants on a competitive basis to eligible enti-
13	ties to carry out the demonstration program under
14	this section by implementing evidence-based or
15	promising policies and practices to incorporate trau-
16	ma-informed techniques designed to—
17	(A) prevent re-traumatization of the vic-
18	$ ext{tim};$
19	(B) ensure that covered individuals use evi-
20	dence-based practices to respond to and inves-
21	tigate cases of domestic violence, dating vio-
22	lence, sexual assault, and stalking;
23	(C) improve communication between vic-
24	tims and law enforcement officers in an effort
25	to increase the likelihood of the successful in-

1	vestigation and prosecution of the alleged crime
2	in a manner that protects the victim to the
3	greatest extent possible;
4	(D) increase collaboration among stake-
5	holders who are part of the coordinated commu-
6	nity response to domestic violence, dating vio-
7	lence, sexual assault, and stalking; and
8	(E) evaluate the effectiveness of the train-
9	ing process and content by measuring—
10	(i) investigative and prosecutorial
11	practices and outcomes; and
12	(ii) the well-being of victims and their
13	satisfaction with the criminal justice proc-
14	ess.
15	(2) Term.—The Attorney General shall make
16	grants under this section for each of the first 2 fis-
17	cal years beginning after the date of enactment of
18	this Act.
19	(3) AWARD BASIS.—The Attorney General shall
20	award grants under this section to multiple eligible
21	entities for use in a variety of settings and commu-
22	nities, including—
23	(A) urban, suburban, tribal, remote, and
24	rural areas;
25	(B) college campuses; or

1	(C) traditionally underserved communities.
2	(c) USE OF FUNDS.—An eligible entity that receives
3	a grant under this section shall use the grant to—
4	(1) train covered individuals within the dem-
5	onstration site of the eligible entity to use evidence-
6	based, trauma-informed techniques throughout an
7	investigation into domestic violence, dating violence,
8	sexual assault, or stalking, including by—
9	(A) conducting victim interviews in a man-
10	ner that—
11	(i) elicits valuable information about
12	the domestic violence, dating violence, sex-
13	ual assault, or stalking; and
14	(ii) avoids re-traumatization of the
15	victim;
16	(B) conducting field investigations that
17	mirror best and promising practices available at
18	the time of the investigation;
19	(C) customizing investigative approaches to
20	ensure a culturally and linguistically appro-
21	priate approach to the community being served;
22	(D) becoming proficient in understanding
23	and responding to complex cases, including
24	cases of domestic violence, dating violence, sex-
25	ual assault, or stalking—

1	(i) facilitated by alcohol or drugs;
2	(ii) involving strangulation;
3	(iii) committed by a non-stranger;
4	(iv) committed by an individual of the
5	same sex as the victim;
6	(v) involving a victim with a disability;
7	(vi) involving a male victim; or
8	(vii) involving a lesbian, gay, bisexual,
9	or transgender (commonly referred to as
10	"LGBT") victim;
11	(E) developing collaborative relationships
12	between—
13	(i) law enforcement officers and other
14	members of the response team; and
15	(ii) the community being served; and
16	(F) developing an understanding of how to
17	define, identify, and correctly classify a report
18	of domestic violence, dating violence, sexual as-
19	sault, or stalking; and
20	(2) promote the efforts of the eligible entity to
21	improve the response of covered individuals to do-
22	mestic violence, dating violence, sexual assault, and
23	stalking through various communication channels,
24	such as the website of the eligible entity, social
25	media, print materials, and community meetings, in

1	order to ensure that all covered individuals within
2	the demonstration site of the eligible entity are
3	aware of those efforts and included in trainings, to
4	the extent practicable.
5	(d) Demonstration Program Trainings on
6	Trauma-Informed Approaches.—
7	(1) Identification of existing
8	TRAININGS.—
9	(A) IN GENERAL.—The Attorney General
10	shall identify trainings for law enforcement offi-
11	cers, in existence as of the date on which the
12	Attorney General begins to solicit applications
13	for grants under this section, that—
14	(i) employ a trauma-informed ap-
15	proach to domestic violence, dating vio-
16	lence, sexual assault, and stalking; and
17	(ii) focus on the fundamentals of
18	the—
19	(I) neurobiology of trauma; and
20	(II) impact of trauma on victims
21	of domestic violence, dating violence,
22	sexual assault, and stalking.
23	(B) Selection.—An eligible entity that
24	receives a grant under this section shall select
25	one or more of the approaches employed by a

- training identified under subparagraph (A) to test within the demonstration site of the eligible entity.
- 4 (2) Consultation.—In carrying out para-5 graph (1), the Attorney General shall consult with the Director of the Office for Victims of Crime in 6 7 order to seek input from and cultivate consensus 8 among outside practitioners and other stakeholders 9 through facilitated discussions and focus groups on 10 best practices in the field of trauma-informed care 11 for victims of domestic violence, dating violence, sex-12 ual assault, and stalking.
- 13 (e) EVALUATION.—The Attorney General, in con14 sultation with the Director of the National Institute of
 15 Justice, shall require each eligible entity that receives a
 16 grant under this section to identify a research partner,
 17 preferably a local research partner, to—
 - (1) design a system for generating and collecting the appropriate data to facilitate an independent process or impact evaluation of the use of the grant funds;
- 22 (2) periodically conduct an evaluation described 23 in paragraph (1); and
- (3) periodically make publicly available, during
 the grant period—

1	(A) preliminary results of the evaluations
2	conducted under paragraph (2); and
3	(B) recommendations for improving the
4	use of the grant funds.
5	(f) Authorization of Appropriations.—The At-
6	torney General shall carry out this section using amounts
7	otherwise available to the Attorney General.
