**A BILL**

To require the Surface Transportation Board to implement certain recommendations of the Inspector General of the Department of Transportation.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “STB Information Se-  
5 curity Improvement Act”.

1 **SEC. 2. REQUIREMENTS.**

2 (a) IN GENERAL.—The Surface Transportation  
3 Board (in this section referred to as the “STB”) shall de-  
4 velop a timeline and plan to implement the recommenda-  
5 tions of the Inspector General of the Department of  
6 Transportation in Report No. FI2018002, including im-  
7 provements—

8 (1) to identify controls, including risk manage-  
9 ment, weakness remediation, and security authoriza-  
10 tion;

11 (2) to protect controls, including configuration  
12 management, user identity and access management,  
13 and security training;

14 (3) to detect controls, including continuous  
15 monitoring;

16 (4) to respond controls, including incident han-  
17 dling and reporting;

18 (5) to recover controls for contingency planning;  
19 and

20 (6) to such other tools that would implement  
21 the recommendations in the report.

22 (b) IMPLEMENTATION.—

23 (1) IN GENERAL.—Not later than 180 days  
24 after the date of enactment of this Act, the STB  
25 shall submit the plan and timeline developed under  
26 subsection (a) to the Committee on Commerce,

1 Science, and Transportation of the Senate and the  
2 Committee on Transportation and Infrastructure of  
3 the House of Representatives.

4 (2) REPORT.—The STB shall report annually  
5 to such Committees on the progress on implementa-  
6 tion of the recommendations until the implementa-  
7 tion is complete.

8 (3) PLAN IMPLEMENTATION.—The STB shall  
9 designate an individual to implement the plan devel-  
10 oped under subsection (a).

11 **SEC. 3. NO ADDITIONAL FUNDS AUTHORIZED.**

12 No additional funds are authorized to carry out the  
13 requirements of this Act. Such requirements shall be car-  
14 ried out using amounts otherwise authorized.
