Ms. MURKOWSKI, from the Committee on Appropriations, reported the following original bill; which was read twice and placed on the calendar

A BILL

Making appropriations for the Department of the Interior, environment, and related agencies for the fiscal year ending September 30, 2019, and for other purposes.

1 Be it enacted by the Senate and House of Representa-

2 tives of the United States of America in Congress assembled,

3 That the following sums are appropriated, out of any4 money in the Treasury not otherwise appropriated, for the

5 Department of the Interior, environment, and related

3	BUREAU OF LAND MANAGEMENT
4	MANAGEMENT OF LANDS AND RESOURCES
5	For necessary expenses for protection, use, improve-
6	ment, development, disposal, cadastral surveying, classi-
7	fication, acquisition of easements and other interests in
8	lands, and performance of other functions, including main-
9	tenance of facilities, as authorized by law, in the manage-
10	ment of lands and their resources under the jurisdiction
11	of the Bureau of Land Management, including the general
12	administration of the Bureau, and assessment of mineral
13	potential of public lands pursuant to section 1010(a) of
14	Public Law 96–487 (16 U.S.C. 3150(a)), \$1,196,143,000,
15	to remain available until expended, including all such
16	amounts as are collected from permit processing fees, as
17	authorized but made subject to future appropriation by
18	section $35(d)(3)(A)(i)$ of the Mineral Leasing Act (30
19	U.S.C. 191), except that amounts from permit processing
20	fees may be used for any bureau-related expenses associ-
21	ated with the processing of oil and gas applications for
22	permits to drill and related use of authorizations.

In addition, \$39,696,000 is for Mining Law Administration program operations, including the cost of administering the mining claim fee program, to remain available

until expended, to be reduced by amounts collected by the 1 2 Bureau and credited to this appropriation from mining 3 claim maintenance fees and location fees that are hereby 4 authorized for fiscal year 2019, so as to result in a final 5 appropriation estimated at not more than \$1,196,143,000, 6 and \$2,000,000, to remain available until expended, from 7 communication site rental fees established by the Bureau 8 for the cost of administering communication site activities.

LAND ACQUISITION

For expenses necessary to carry out sections 205, 206, and 318(d) of Public Law 94–579, including administrative expenses and acquisition of lands or waters, or interests therein, \$26,016,000, to be derived from the Land and Water Conservation Fund and to remain available until expended.

OREGON AND CALIFORNIA GRANT LANDS

17 For expenses necessary for management, protection, 18 and development of resources and for construction, oper-19 ation, and maintenance of access roads, reforestation, and 20other improvements on the revested Oregon and California 21 Railroad grant lands, on other Federal lands in the Or-22 egon and California land-grant counties of Oregon, and 23 on adjacent rights-of-way; and acquisition of lands or in-24 terests therein, including existing connecting roads on or 25 adjacent to such grant lands; \$106,543,000, to remain

available until expended: *Provided*, That 25 percent of the 1 2 aggregate of all receipts during the current fiscal year 3 from the revested Oregon and California Railroad grant 4 lands is hereby made a charge against the Oregon and 5 California land-grant fund and shall be transferred to the General Fund in the Treasury in accordance with the sec-6 7 ond paragraph of subsection (b) of title II of the Act of 8 August 28, 1937 (43 U.S.C. 2605).

RANGE IMPROVEMENTS

10 For rehabilitation, protection, and acquisition of lands and interests therein, and improvement of Federal 11 rangelands pursuant to section 401 of the Federal Land 12 13 Policy and Management Act of 1976 (43 U.S.C. 1751), notwithstanding any other Act, sums equal to 50 percent 14 15 of all moneys received during the prior fiscal year under sections 3 and 15 of the Taylor Grazing Act (43 U.S.C. 16 17 315b, 315m) and the amount designated for range improvements from grazing fees and mineral leasing receipts 18 19 from Bankhead-Jones lands transferred to the Depart-20 ment of the Interior pursuant to law, but not less than 21 \$10,000,000, to remain available until expended: Pro-22 vided, That not to exceed \$600,000 shall be available for 23 administrative expenses.

1 SERVICE CHARGES, DEPOSITS, AND FORFEITURES

2 For administrative expenses and other costs related 3 to processing application documents and other authoriza-4 tions for use and disposal of public lands and resources, 5 for costs of providing copies of official public land documents, for monitoring construction, operation, and termi-6 7 nation of facilities in conjunction with use authorizations, 8 and for rehabilitation of damaged property, such amounts 9 as may be collected under Public Law 94–579 (43 U.S.C. 10 1701 et seq.), and under section 28 of the Mineral Leasing Act (30 U.S.C. 185), to remain available until expended: 11 *Provided*, That notwithstanding any provision to the con-12 13 trary of section 305(a) of Public Law 94–579 (43 U.S.C. 1735(a)), any moneys that have been or will be received 14 15 pursuant to that section, whether as a result of forfeiture, compromise, or settlement, if not appropriate for refund 16 17 pursuant to section 305(c) of that Act (43 U.S.C. 18 1735(c), shall be available and may be expended under 19 the authority of this Act by the Secretary to improve, pro-20 tect, or rehabilitate any public lands administered through 21 the Bureau of Land Management which have been dam-22 aged by the action of a resource developer, purchaser, per-23 mittee, or any unauthorized person, without regard to 24 whether all moneys collected from each such action are 25 used on the exact lands damaged which led to the action:

Provided further, That any such moneys that are in excess
 of amounts needed to repair damage to the exact land for
 which funds were collected may be used to repair other
 damaged public lands.

5 MISCELLANEOUS TRUST FUNDS

6 In addition to amounts authorized to be expended 7 under existing laws, there is hereby appropriated such 8 amounts as may be contributed under section 307 of Pub-9 lic Law 94–579 (43 U.S.C. 1737), and such amounts as 10 may be advanced for administrative costs, surveys, appraisals, and costs of making conveyances of omitted lands 11 12 under section 211(b) of that Act (43 U.S.C. 1721(b)), to 13 remain available until expended.

14 ADMINISTRATIVE PROVISIONS

15 The Bureau of Land Management may carry out the operations funded under this Act by direct expenditure, 16 17 contracts, grants, cooperative agreements and reimbursable agreements with public and private entities, including 18 with States. Appropriations for the Bureau shall be avail-19 able for purchase, erection, and dismantlement of tem-20 21 porary structures, and alteration and maintenance of nec-22 essary buildings and appurtenant facilities to which the 23 United States has title; up to \$100,000 for payments, at 24 the discretion of the Secretary, for information or evidence 25 concerning violations of laws administered by the Bureau;

miscellaneous and emergency expenses of enforcement ac-1 2 tivities authorized or approved by the Secretary and to be 3 accounted for solely on the Secretary's certificate, not to 4 exceed \$10,000: *Provided*, That notwithstanding Public 5 Law 90–620 (44 U.S.C. 501), the Bureau may, under co-6 operative cost-sharing and partnership arrangements au-7 thorized by law, procure printing services from cooperators 8 in connection with jointly produced publications for which 9 the cooperators share the cost of printing either in cash 10 or in services, and the Bureau determines the cooperator is capable of meeting accepted quality standards: Provided 11 12 *further*, That projects to be funded pursuant to a written 13 commitment by a State government to provide an identified amount of money in support of the project may be 14 15 carried out by the Bureau on a reimbursable basis. Appropriations herein made shall not be available for the de-16 17 struction of healthy, unadopted, wild horses and burros 18 in the care of the Bureau or its contractors or for the 19 sale of wild horses and burros that results in their destruc-20 tion for processing into commercial products.

21 UNITED STATES FISH AND WILDLIFE SERVICE

22 RESOURCE MANAGEMENT

For necessary expenses of the United States Fish and
Wildlife Service, as authorized by law, and for scientific
and economic studies, general administration, and for the

performance of other authorized functions related to such 1 resources, \$1,292,067,000, to remain available until Sep-2 3 tember 30. 2020: Provided, That not to exceed 4 \$17,818,000 shall be used for implementing subsections 5 (a), (b), (c), and (e) of section 4 of the Endangered Spe-6 cies Act of 1973 (16 U.S.C. 1533) (except for processing 7 petitions, developing and issuing proposed and final regu-8 lations, and taking any other steps to implement actions 9 described in subsection (c)(2)(A),(c)(2)(B)(i),or 10 (c)(2)(B)(ii)).

11

CONSTRUCTION

For construction, improvement, acquisition, or removal of buildings and other facilities required in the conservation, management, investigation, protection, and utilization of fish and wildlife resources, and the acquisition of lands and interests therein; \$50,413,000, to remain available until expended.

LAND ACQUISITION

19 For expenses necessary to carry out chapter 2003 of 20 title 54, United States Code, including administrative ex-21 penses, and for acquisition of land or waters, or interest 22 therein, in accordance with statutory authority applicable 23 the United States Fish and Wildlife Service, to 24 \$45,189,000, to be derived from the Land and Water Conservation Fund and to remain available until expended: 25

Provided, That none of the funds appropriated for specific
 land acquisition projects may be used to pay for any ad ministrative overhead, planning or other management
 costs.

5 COOPERATIVE ENDANGERED SPECIES CONSERVATION

6

FUND

7 For expenses necessary to carry out section 6 of the 8 Endangered Species Act of 1973 (16 U.S.C. 1535), 9 \$49,495,000, to remain available until expended, of which 10 \$18,695,000 is to be derived from the Cooperative Endan-11 Species Conservation Fund; and of which gered \$30,800,000 is to be derived from the Land and Water 12 Conservation Fund. 13

14 NATIONAL WILDLIFE REFUGE FUND

15 For expenses necessary to implement the Act of Octo-16 ber 17, 1978 (16 U.S.C. 715s), \$13,228,000.

17 NORTH AMERICAN WETLANDS CONSERVATION FUND

18 For expenses necessary to carry out the provisions
19 of the North American Wetlands Conservation Act (16
20 U.S.C. 4401 et seq.), \$43,000,000, to remain available
21 until expended.

22 NEOTROPICAL MIGRATORY BIRD CONSERVATION

For expenses necessary to carry out the Neotropical
Migratory Bird Conservation Act (16 U.S.C. 6101 et
seq.), \$3,910,000, to remain available until expended.

10

1 MULTINATIONAL SPECIES CONSERVATION FUND

2 For expenses necessary to carry out the African Ele-3 phant Conservation Act (16 U.S.C. 4201 et seq.), the 4 Asian Elephant Conservation Act of 1997 (16 U.S.C. 5 4261 et seq.), the Rhinoceros and Tiger Conservation Act 6 of 1994 (16 U.S.C. 5301 et seq.), the Great Ape Con-7 servation Act of 2000 (16 U.S.C. 6301 et seq.), and the 8 Marine Turtle Conservation Act of 2004 (16 U.S.C. 6601 9 et seq.), \$12,061,000, to remain available until expended.

10 STATE AND TRIBAL WILDLIFE GRANTS

11 For wildlife conservation grants to States and to the District of Columbia, Puerto Rico, Guam, the United 12 13 States Virgin Islands, the Northern Mariana Islands, American Samoa, and Indian tribes under the provisions 14 15 of the Fish and Wildlife Act of 1956 and the Fish and Wildlife Coordination Act, for the development and imple-16 mentation of programs for the benefit of wildlife and their 17 habitat, including species that are not hunted or fished, 18 19 \$65,571,000, to remain available until expended: Pro-20 *vided*, That of the amount provided herein, \$4,209,000 is 21 for a competitive grant program for Indian tribes not sub-22 ject to the remaining provisions of this appropriation: *Pro*-23 vided further, That \$6,362,000 is for a competitive grant 24 program to implement approved plans for States, terri-25 tories, and other jurisdictions and at the discretion of af-

fected States, the regional Associations of fish and wildlife 1 2 agencies, not subject to the remaining provisions of this 3 appropriation: *Provided further*, That the Secretary shall, 4 after deducting \$10,571,000 and administrative expenses, 5 apportion the amount provided herein in the following 6 manner: (1) to the District of Columbia and to the Com-7 monwealth of Puerto Rico, each a sum equal to not more 8 than one-half of 1 percent thereof; and (2) to Guam, 9 American Samoa, the United States Virgin Islands, and 10 the Commonwealth of the Northern Mariana Islands, each a sum equal to not more than one-fourth of 1 percent 11 12 thereof: *Provided further*, That the Secretary shall appor-13 tion the remaining amount in the following manner: (1) 14 one-third of which is based on the ratio to which the land 15 area of such State bears to the total land area of all such States; and (2) two-thirds of which is based on the ratio 16 to which the population of such State bears to the total 17 18 population of all such States: *Provided further*, That the 19 amounts apportioned under this paragraph shall be ad-20 justed equitably so that no State shall be apportioned a 21 sum which is less than 1 percent of the amount available 22 for apportionment under this paragraph for any fiscal year 23 or more than 5 percent of such amount: Provided further, 24 That the Federal share of planning grants shall not exceed 25 75 percent of the total costs of such projects and the Fed-

eral share of implementation grants shall not exceed 65 1 percent of the total costs of such projects: Provided fur-2 3 ther, That the non-Federal share of such projects may not 4 be derived from Federal grant programs: *Provided further*, 5 That any amount apportioned in 2019 to any State, territory, or other jurisdiction that remains unobligated as of 6 7 September 30, 2020, shall be reapportioned, together with 8 funds appropriated in 2021, in the manner provided here-9 in.

10 Administrative provisions

11 The United States Fish and Wildlife Service may 12 carry out the operations of Service programs by direct ex-13 penditure, contracts, grants, cooperative agreements and reimbursable agreements with public and private entities. 14 15 Appropriations and funds available to the United States Fish and Wildlife Service shall be available for repair of 16 17 damage to public roads within and adjacent to reservation 18 areas caused by operations of the Service; options for the purchase of land at not to exceed \$1 for each option; facili-19 20 ties incident to such public recreational uses on conserva-21 tion areas as are consistent with their primary purpose; 22 and the maintenance and improvement of aquaria, build-23 ings, and other facilities under the jurisdiction of the Serv-24 ice and to which the United States has title, and which 25 are used pursuant to law in connection with management,

and investigation of fish and wildlife resources: *Provided*, 1 2 That notwithstanding 44 U.S.C. 501, the Service may, 3 under cooperative cost sharing and partnership arrange-4 ments authorized by law, procure printing services from 5 cooperators in connection with jointly produced publica-6 tions for which the cooperators share at least one-half the 7 cost of printing either in cash or services and the Service 8 determines the cooperator is capable of meeting accepted 9 quality standards: *Provided further*, That the Service may 10 accept donated aircraft as replacements for existing aircraft: *Provided further*, That notwithstanding 31 U.S.C. 11 12 3302, all fees collected for non-toxic shot review and ap-13 proval shall be deposited under the heading "United States Fish and Wildlife Service—Resource Management" 14 15 and shall be available to the Secretary, without further appropriation, to be used for expenses of processing of 16 17 such non-toxic shot type or coating applications and revising regulations as necessary, and shall remain available 18 19 until expended.

20 NATIONAL PARK SERVICE

21 OPERATION OF THE NATIONAL PARK SYSTEM

For expenses necessary for the management, operation, and maintenance of areas and facilities administered by the National Park Service and for the general administration of the National Park Service,

\$2,500,369,000, of which \$10,032,000 for planning and 1 2 interagency coordination in support of Everglades restoration and \$141,961,000 for maintenance, repair, or reha-3 4 bilitation projects for constructed assets and 5 \$149,075,000 for cyclic maintenance projects for con-6 structed assets shall remain available until September 30, 2020: Provided, That funds appropriated under this head-7 8 ing in this Act are available for the purposes of section 9 5 of Public Law 95–348.

10 NATIONAL RECREATION AND PRESERVATION

For expenses necessary to carry out recreation programs, natural programs, cultural programs, heritage partnership programs, environmental compliance and review, international park affairs, and grant administration, not otherwise provided for, \$64,138,000.

16 HISTORIC PRESERVATION FUND

17 For expenses necessary in carrying out the National 18 Historic Preservation Act (division A of subtitle III of title 54, United States Code), \$88,910,000, to be derived from 19 20 the Historic Preservation Fund and to remain available 21 until September 30, 2020: *Provided*, That of the funds 22 provided for the Historic Preservation Fund, \$500,000 is 23 for competitive grants for the survey and nomination of 24 properties to the National Register of Historic Places and as National Historic Landmarks associated with commu-25

nities currently under-represented, as determined by the 1 2 Secretary, \$13,000,000 is for competitive grants to pre-3 serve the sites and stories of the Civil Rights movement, 4 \$5,000,000 is for grants to Historically Black Colleges 5 and Universities, and \$5,000,000 is for competitive grants for the restoration of historic properties of national, State 6 7 and local significance listed on or eligible for inclusion on 8 the National Register of Historic Places, to be made with-9 out imposing the usage or direct grant restrictions of sec-10 tion 101(e)(3) (54 U.S.C. 302904) of the National Historical Preservation Act: Provided further, That such com-11 12 petitive grants shall be made without imposing the matching requirements in section 302902(b)(3) of title 54, 13 United States Code, to States and Indian tribes as defined 14 15 in chapter 3003 of such title, Native Hawaiian organizations, local governments, including Certified Local Govern-16 ments, and non-profit organizations. 17

18

CONSTRUCTION

For construction, improvements, repair, or replacement of physical facilities, and compliance and planning for programs and areas administered by the National Park Service, \$364,704,000, to remain available until expended: *Provided*, That notwithstanding any other provision of law, for any project initially funded in fiscal year 2019 with a future phase indicated in the National Park

Service 5-Year Line Item Construction Plan, a single pro-1 2 curement may be issued which includes the full scope of 3 the project: *Provided further*, That the solicitation and 4 contract shall contain the clause availability of funds 5 found at 48 CFR 52.232–18: Provided further, That National Park Service Donations, Park Concessions Fran-6 7 chise Fees, and Recreation Fees may be made available 8 for the cost of adjustments and changes within the origi-9 nal scope of effort for projects funded by the National 10 Park Service Construction appropriation: *Provided further*, That the Secretary of the Interior shall consult with the 11 12 Committees on Appropriations, in accordance with current 13 reprogramming thresholds, prior to making any charges 14 authorized by this section.

15 LAND ACQUISITION AND STATE ASSISTANCE

16 For expenses necessary to carry out chapter 2003 of 17 title 54, United States Code, including administrative expenses, and for acquisition of lands or waters, or interest 18 19 therein, in accordance with the statutory authority appli-20 cable to the National Park Service, \$174,444,000, to be 21 derived from the Land and Water Conservation Fund and to remain available until expended, of which \$124,006,000 22 23 for the State assistance program and of which is 24 \$15,000,000 shall be for the American Battlefield Protection Program grants as authorized by chapter 3081 of title
 54, United States Code.

3

CENTENNIAL CHALLENGE

4 For expenses necessary to carry out the provisions 5 of section 101701 of title 54, United States Code, relating 6 to challenge cost share agreements, \$23,000,000, to re-7 main available until expended, for Centennial Challenge 8 projects and programs: *Provided*, That not less than 50 9 percent of the total cost of each project or program shall 10 be derived from non-Federal sources in the form of donated cash, assets, or a pledge of donation guaranteed by 11 12 an irrevocable letter of credit.

13 Administrative provisions

14 (INCLUDING TRANSFER OF FUNDS)

15 In addition to other uses set forth in section 101917(c)(2) of title 54, United States Code, franchise 16 17 fees credited to a sub-account shall be available for expenditure by the Secretary, without further appropriation, 18 19 for use at any unit within the National Park System to 20 extinguish or reduce liability for Possessory Interest or 21 leasehold surrender interest. Such funds may only be used 22 for this purpose to the extent that the benefitting unit an-23 ticipated franchise fee receipts over the term of the con-24 tract at that unit exceed the amount of funds used to ex-25 tinguish or reduce liability. Franchise fees at the benefitting unit shall be credited to the sub-account of the origi nating unit over a period not to exceed the term of a single
 contract at the benefitting unit, in the amount of funds
 so expended to extinguish or reduce liability.

5 For the costs of administration of the Land and 6 Water Conservation Fund grants authorized by section 7 105(a)(2)(B) of the Gulf of Mexico Energy Security Act 8 of 2006 (Public Law 109–432), the National Park Service 9 may retain up to 3 percent of the amounts which are au-10 thorized to be disbursed under such section, such retained 11 amounts to remain available until expended.

12 National Park Service funds may be transferred to
13 the Federal Highway Administration (FHWA), Depart14 ment of Transportation, for purposes authorized under 23
15 U.S.C. 204. Transfers may include a reasonable amount
16 for FHWA administrative support costs.

- 17 UNITED STATES GEOLOGICAL SURVEY
- 18 SURVEYS, INVESTIGATIONS, AND RESEARCH

For expenses necessary for the United States Geological Survey to perform surveys, investigations, and research covering topography, geology, hydrology, biology, and the mineral and water resources of the United States, its territories and possessions, and other areas as authorized by 43 U.S.C. 31, 1332, and 1340; classify lands as to their mineral and water resources; give engineering su-

pervision to power permittees and Federal Energy Regu-1 latory Commission licensees; administer the minerals ex-2 3 ploration program (30 U.S.C. 641); conduct inquiries into 4 the economic conditions affecting mining and materials 5 processing industries (30 U.S.C. 3, 21a, and 1603; 50 6 U.S.C. 98g(1)) and related purposes as authorized by law; 7 and to publish and disseminate data relative to the fore-8 going activities; \$1,148,457,000, to remain available until 9 September 30, 2020; of which \$84,337,000 shall remain 10 available until expended for satellite operations; and of which \$15,164,000 shall be available until expended for 11 12 deferred maintenance and capital improvement projects 13 that exceed \$100,000 in cost: *Provided*, That none of the funds provided for the ecosystem research activity shall 14 15 be used to conduct new surveys on private property, unless specifically authorized in writing by the property owner: 16 17 *Provided further*, That no part of this appropriation shall be used to pay more than one-half the cost of topographic 18 19 mapping or water resources data collection and investiga-20 tions carried on in cooperation with States and municipali-21 ties.

ADMINISTRATIVE PROVISIONS

From within the amount appropriated for activities
of the United States Geological Survey such sums as are
necessary shall be available for contracting for the fur-

nishing of topographic maps and for the making of geo-1 physical or other specialized surveys when it is administra-2 3 tively determined that such procedures are in the public 4 interest; construction and maintenance of necessary build-5 ings and appurtenant facilities; acquisition of lands for gauging stations, observation wells, and seismic equip-6 7 ment; expenses of the United States National Committee 8 for Geological Sciences; and payment of compensation and 9 expenses of persons employed by the Survey duly ap-10 pointed to represent the United States in the negotiation 11 and administration of interstate compacts: Provided, That 12 activities funded by appropriations herein made may be 13 accomplished through the use of contracts, grants, or co-14 operative agreements as defined in section 6302 of title 15 31, United States Code: *Provided further*, That the United States Geological Survey may enter into contracts or coop-16 17 erative agreements directly with individuals or indirectly 18 with institutions or nonprofit organizations, without re-19 gard to 41 U.S.C. 6101, for the temporary or intermittent 20 services of students or recent graduates, who shall be con-21 sidered employees for the purpose of chapters 57 and 81 22 of title 5, United States Code, relating to compensation 23 for travel and work injuries, and chapter 171 of title 28, 24 United States Code, relating to tort claims, but shall not be considered to be Federal employees for any other pur poses.

The Bureau of Indian Affairs may carry out the operation of Indian programs by direct expenditure, contracts,
cooperative agreements, compacts, and grants, either directly or in cooperation with States and other organizations.

Notwithstanding Public Law 87–279 (25 U.S.C. 15),
8 the Bureau of Indian Affairs may contract for services in
9 support of the management, operation, and maintenance
10 of the Power Division of the San Carlos Irrigation Project.

11 Notwithstanding any other provision of law, no funds 12 available to the Bureau of Indian Affairs for central office 13 oversight and Executive Direction and Administrative Services (except executive direction and administrative 14 15 services funding for Tribal Priority Allocations, regional offices, and facilities operations and maintenance) shall be 16 17 available for contracts, grants, compacts, or cooperative agreements with the Bureau of Indian Affairs under the 18 provisions of the Indian Self-Determination Act or the 19 Tribal Self-Governance Act of 1994 (Public Law 103– 2021 413).

In the event any tribe returns appropriations made available by this Act to the Bureau of Indian Affairs, this action shall not diminish the Federal Government's trust responsibility to that tribe, or the government-to-government relationship between the United States and that
 tribe, or that tribe's ability to access future appropria tions.

4 Notwithstanding any other provision of law, no funds
5 available to the Bureau of Indian Education, other than
6 the amounts provided herein for assistance to public
7 schools under 25 U.S.C. 452 et seq., shall be available to
8 support the operation of any elementary or secondary
9 school in the State of Alaska.

10 No funds available to the Bureau of Indian Edu-11 cation shall be used to support expanded grades for any 12 school or dormitory beyond the grade structure in place 13 or approved by the Secretary of the Interior at each school in the Bureau of Indian Education school system as of 14 15 October 1, 1995, except that the Secretary of the Interior may waive this prohibition to support expansion of up to 16 17 one additional grade when the Secretary determines such waiver is needed to support accomplishment of the mission 18 19 of the Bureau of Indian Education, or more than one 20 grade to expand the elementary grade structure for Bu-21 reau-funded schools with a K-2 grade structure on Octo-22 ber 1, 1996. Appropriations made available in this or any 23 prior Act for schools funded by the Bureau shall be avail-24 able, in accordance with the Bureau's funding formula, only to the schools in the Bureau school system as of Sep-25

1 tember 1, 1996, and to any school or school program that was reinstated in fiscal year 2012. Funds made available 2 3 under this Act may not be used to establish a charter 4 school at a Bureau-funded school (as that term is defined 5 in section 1141 of the Education Amendments of 1978 6 (25 U.S.C. 2021)), except that a charter school that is 7 in existence on the date of the enactment of this Act and 8 that has operated at a Bureau-funded school before Sep-9 tember 1, 1999, may continue to operate during that pe-10 riod, but only if the charter school pays to the Bureau a pro rata share of funds to reimburse the Bureau for 11 12 the use of the real and personal property (including buses 13 and vans), the funds of the charter school are kept separate and apart from Bureau funds, and the Bureau does 14 15 not assume any obligation for charter school programs of the State in which the school is located if the charter 16 17 school loses such funding. 1 EMERGENCY TRANSFER AUTHORITY—DEPARTMENT-WIDE

The Secretary may authorize the expendi-3 ture or transfer of any no year appropriation in this title, 4 in addition to the amounts included in the budget pro-5 grams of the several agencies, for the suppression or emer-6 gency prevention of wildland fires on or threatening lands 7 under the jurisdiction of the Department of the Interior; 8 for the emergency rehabilitation of burned-over lands 9 under its jurisdiction; for emergency actions related to po-10 tential or actual earthquakes, floods, volcanoes, storms, or other unavoidable causes; for contingency planning subse-11 12 quent to actual oil spills; for response and natural resource 13 damage assessment activities related to actual oil spills or releases of hazardous substances into the environment; for 14 15 the prevention, suppression, and control of actual or potential grasshopper and Mormon cricket outbreaks on 16 17 lands under the jurisdiction of the Secretary, pursuant to the authority in section 417(b) of Public Law 106–224 18 19 (7 U.S.C. 7717(b)); for emergency reclamation projects 20 under section 410 of Public Law 95–87; and shall trans-21 fer, from any no year funds available to the Office of Sur-22 face Mining Reclamation and Enforcement, such funds as 23 may be necessary to permit assumption of regulatory au-24 thority in the event a primacy State is not carrying out 25 the regulatory provisions of the Surface Mining Act: Pro-

vided, That appropriations made in this title for wildland 1 2 fire operations shall be available for the payment of obliga-3 tions incurred during the preceding fiscal year, and for reimbursement to other Federal agencies for destruction 4 5 of vehicles, aircraft, or other equipment in connection with 6 their use for wildland fire operations, with such reimburse-7 ment to be credited to appropriations currently available 8 at the time of receipt thereof: *Provided further*, That for 9 wildland fire operations, no funds shall be made available 10 under this authority until the Secretary determines that funds appropriated for "wildland fire suppression" shall 11 be exhausted within 30 days: Provided further, That all 12 13 funds used pursuant to this section must be replenished by a supplemental appropriation, which must be requested 14 15 as promptly as possible: *Provided further*, That such replenishment funds shall be used to reimburse, on a pro 16 17 rata basis, accounts from which emergency funds were transferred. 18

19 AUTHORIZED USE OF FUNDS

SEC. 103. Appropriations made to the Department of the Interior in this title shall be available for services as authorized by section 3109 of title 5, United States Code, when authorized by the Secretary, in total amount not to exceed \$500,000; purchase and replacement of motor vehicles, including specially equipped law enforce-

ment vehicles; hire, maintenance, and operation of air-1 2 craft; hire of passenger motor vehicles; purchase of re-3 prints; payment for telephone service in private residences 4 in the field, when authorized under regulations approved 5 by the Secretary; and the payment of dues, when authorized by the Secretary, for library membership in societies 6 7 or associations which issue publications to members only 8 or at a price to members lower than to subscribers who 9 are not members.

MANAGEMENT

12 SEC. 104. Appropriations made in this Act under the 13 headings Bureau of Indian Affairs and Bureau of Indian Education, and Office of the Special Trustee for American 14 15 Indians and any unobligated balances from prior appropriations Acts made under the same headings shall be 16 17 available for expenditure or transfer for Indian trust man-18 agement and reform activities. Total funding for historical 19 accounting activities shall not exceed amounts specifically 20designated in this Act for such purpose.

21 REDISTRIBUTION OF FUNDS, BUREAU OF INDIAN

AFFAIRS

SEC. 105. Notwithstanding any other provision of
law, the Secretary of the Interior is authorized to redistribute any Tribal Priority Allocation funds, including

tribal base funds, to alleviate tribal funding inequities by 1 2 transferring funds to address identified, unmet needs, 3 dual enrollment, overlapping service areas or inaccurate 4 distribution methodologies. No tribe shall receive a reduc-5 tion in Tribal Priority Allocation funds of more than 10 percent in fiscal year 2019. Under circumstances of dual 6 7 enrollment, overlapping service areas or inaccurate dis-8 tribution methodologies, the 10 percent limitation does not 9 apply.

10 ELLIS, GOVERNORS, AND LIBERTY ISLANDS

11 SEC. 106. Notwithstanding any other provision of law, the Secretary of the Interior is authorized to acquire 12 13 lands, waters, or interests therein including the use of all or part of any pier, dock, or landing within the State of 14 15 New York and the State of New Jersey, for the purpose of operating and maintaining facilities in the support of 16 transportation and accommodation of visitors to Ellis, 17 18 Governors, and Liberty Islands, and of other program and 19 administrative activities, by donation or with appropriated funds, including franchise fees (and other monetary con-2021 sideration), or by exchange; and the Secretary is author-22 ized to negotiate and enter into leases, subleases, conces-23 sion contracts or other agreements for the use of such fa-24 cilities on such terms and conditions as the Secretary may determine reasonable. 25

OUTER CONTINENTAL SHELF INSPECTION FEES

2 SEC. 107. (a) In fiscal year 2019, the Secretary shall 3 collect a nonrefundable inspection fee, which shall be de-4 posited in the "Offshore Safety and Environmental En-5 forcement" account, from the designated operator for fa-6 cilities subject to inspection under 43 U.S.C. 1348(c).

7 (b) Annual fees shall be collected for facilities that
8 are above the waterline, excluding drilling rigs, and are

16 CONTRACTS AND AGREEMENTS FOR WILD HORSE AND

17 BURRO HOLDING FACILITIES

18 SEC. 109. Notwithstanding any other provision of this Act, the Secretary of the Interior may enter into 19 multiyear cooperative agreements with nonprofit organiza-20 21 tions and other appropriate entities, and may enter into 22 multiyear contracts in accordance with the provisions of 23 section 3903 of title 41, United States Code (except that 24 the 5-year term restriction in subsection (a) shall not 25 apply), for the long-term care and maintenance of excess wild free roaming horses and burros by such organizations
 or entities on private land. Such cooperative agreements
 and contracts may not exceed 10 years, subject to renewal
 at the discretion of the Secretary.

5 MASS MARKING OF SALMONIDS

6 SEC. 110. The United States Fish and Wildlife Serv-7 ice shall, in carrying out its responsibilities to protect 8 threatened and endangered species of salmon, implement 9 a system of mass marking of salmonid stocks, intended 10 for harvest, that are released from federally operated or federally financed hatcheries including but not limited to 11 12 fish releases of coho, chinook, and steelhead species. 13 Marked fish must have a visible mark that can be readily identified by commercial and recreational fishers. 14

15 CONTRACTS AND AGREEMENTS WITH INDIAN AFFAIRS

16 SEC. 111. Notwithstanding any other provision of law, during fiscal year 2019, in carrying out work involv-17 ing cooperation with State, local, and tribal governments 18 19 or any political subdivision thereof, Indian Affairs may 20 record obligations against accounts receivable from any 21 such entities, except that total obligations at the end of 22 the fiscal year shall not exceed total budgetary resources 23 available at the end of the fiscal year.

HUMANE TRANSFER OF EXCESS ANIMALS

2 SEC. 112. Notwithstanding any other provision of 3 law, the Secretary of the Interior may transfer excess wild 4 horses or burros that have been removed from the public 5 lands to other Federal, State, and local government agencies for use as work animals: *Provided*, That the Secretary 6 7 may make any such transfer immediately upon request of 8 such Federal, State, or local government agency: *Provided* 9 *further*, That any excess animal transferred under this 10 provision shall lose its status as a wild free-roaming horse or burro as defined in the Wild Free-Roaming Horses and 11 Burros Act: *Provided further*, That any Federal, State, or 12 local government agency receiving excess wild horses or 13 burros as authorized in this section shall not: destroy the 14 15 horses or burros in a way that results in their destruction into commercial products; sell or otherwise transfer the 16 horses or burros in a way that results in their destruction 17 for processing into commercial products; or euthanize the 18 19 horses or burros except upon the recommendation of a li-20 censed veterinarian, in cases of severe injury, illness, or 21 advanced age.

22 DEPARTMENT OF THE INTERIOR EXPERIENCED SERVICES 23 PROGRAM

24 SEC. 113. (a) Notwithstanding any other provision 25 of law relating to Federal grants and cooperative agreements, the Secretary of the Interior is authorized to make
 grants to, or enter into cooperative agreements with, pri vate nonprofit organizations designated by the Secretary
 of Labor under title V of the Older Americans Act of 1965
 to utilize the talents of older Americans in programs au thorized by other provisions of law administered by the
 Secretary and consistent with such provisions of law.

8 (b) Prior to awarding any grant or agreement under
9 subsection (a), the Secretary shall ensure that the agree10 ment would not—

No timber sale in Alaska's Region 10 shall be advertised if the indicated rate is deficit (defined as 19 20 the value of the timber is not sufficient to cover all logging 21 and stumpage costs and provide a normal profit and risk 22 allowance under the Forest Service's appraisal process) 23 when appraised using a residual value appraisal. The west-24 ern red cedar timber from those sales which is surplus 25 to the needs of the domestic processors in Alaska, shall

be made available to domestic processors in the contiguous
 48 United States at prevailing domestic prices. All addi tional western red cedar volume not sold to Alaska or con tiguous 48 United States domestic processors may be ex ported to foreign markets at the election of the timber sale
 holder. All Alaska yellow cedar may be sold at prevailing
 export prices at the election of the timber sale holder.

8 PROHIBITION ON NO-BID CONTRACTS

9 SEC. 411. None of the funds appropriated or other-10 wise made available by this Act to executive branch agen-11 cies may be used to enter into any Federal contract unless 12 such contract is entered into in accordance with the re-13 quirements of Chapter 33 of title 41, United States Code, 14 or Chapter 137 of title 10, United States Code, and the 15 Federal Acquisition Regulation, unless—

16 (1) Federal law specifically authorizes a con17 tract to be entered into without regard for these re18 quirements, including formula grants for States, or
19 federally recognized Indian tribes; or

20 (2) such contract is authorized by the Indian
21 Self-Determination and Education Assistance Act
22 (Public Law 93–638, 25 U.S.C. 450 et seq.) or by
23 any other Federal laws that specifically authorize a
24 contract within an Indian tribe as defined in section
25 4(e) of that Act (25 U.S.C. 450b(e)); or

1	(3) such contract was awarded prior to the date
2	of enactment of this Act.
3	POSTING OF REPORTS
4	SEC. 412. (a) Any agency receiving funds made avail-
5	able in this Act, shall, subject to subsections (b) and (c),

PRIORITIES

17 SEC. 414. (a) In providing services or awarding financial assistance under the National Foundation on the 18 19 Arts and the Humanities Act of 1965 from funds appro-20 priated under this Act, the Chairperson of the National 21 Endowment for the Arts shall ensure that priority is given 22 to providing services or awarding financial assistance for 23 projects, productions, workshops, or programs that serve 24 underserved populations.

25 (b) In this section:

(1) The term "underserved population" means 1 2 a population of individuals, including urban minori-3 ties, who have historically been outside the purview 4 of arts and humanities programs due to factors such as a high incidence of income below the poverty line 5 6 or to geographic isolation. (2) The term "poverty line" means the poverty 7 8 line (as defined by the Office of Management and 9 Budget, and revised annually in accordance with sec-

tion 673(2) of the Community Services Block Grant
Act (42 U.S.C. 9902(2))) applicable to a family of
the size involved.

13 (c) In providing services and awarding financial as-14 sistance under the National Foundation on the Arts and 15 Humanities Act of 1965 with funds appropriated by this Act, the Chairperson of the National Endowment for the 16 17 Arts shall ensure that priority is given to providing services or awarding financial assistance for projects, produc-18 tions, workshops, or programs that will encourage public 19 20 knowledge, education, understanding, and appreciation of 21 the arts.

(d) With funds appropriated by this Act to carry out
section 5 of the National Foundation on the Arts and Humanities Act of 1965—

1	(1) the Chairperson shall establish a grant cat-
2	egory for projects, productions, workshops, or pro-
3	grams that are of national impact or availability or
4	are able to tour several States;
5	(2) the Chairperson shall not make grants ex-
6	ceeding 15 percent, in the aggregate, of such funds
7	to any single State, excluding grants made under the
8	authority of paragraph (1);
9	(3) the Chairperson shall report to the Con-
10	gress annually and by State, on grants awarded by
11	the Chairperson in each grant category under sec-

16	STATUS OF BALANCES OF APPROPRIATIONS
17	SEC. 415. The Department of the Interior, the Envi-

16 FUNDING PROHIBITION

17 SEC. 418. None of the funds made available by this 18 or any other Act may be used to regulate the lead content 19 of ammunition, ammunition components, or fishing tackle 20 under the Toxic Substances Control Act (15 U.S.C. 2601 21 et seq.) or any other law.

22 CONTRACTING AUTHORITIES

SEC. 419. Section 412 of Division E of Public Law
112–74 is amended by striking "fiscal year 2019" and inserting "fiscal year 2020".

EXTENSION OF GRAZING PERMITS

SEC. 420. The terms and conditions of section 325
of Public Law 108–108 (117 Stat. 1307), regarding grazing permits issued by the Forest Service on any lands not
subject to administration under section 402 of the Federal
Lands Policy and Management Act (43 U.S.C. 1752),
shall remain in effect for fiscal year 2019.

8 FUNDING PROHIBITION

23 USE OF AMERICAN IRON AND STEEL

24 SEC. 423. (a)(1) None of the funds made available 25 by a State water pollution control revolving fund as authorized by section 1452 of the Safe Drinking Water Act
 (42 U.S.C. 300j-12) shall be used for a project for the
 construction, alteration, maintenance, or repair of a public
 water system or treatment works unless all of the iron and
 steel products used in the project are produced in the
 United States.

7 (2) In this section, the term "iron and steel" products
8 means the following products made primarily of iron or
9 steel: lined or unlined pipes and fittings, manhole covers
10 and other municipal castings, hydrants, tanks, flanges,
11 pipe clamps and restraints, valves, structural steel, rein12 forced precast concrete, and construction materials.

(b) Subsection (a) shall not apply in any case or category of cases in which the Administrator of the Environmental Protection Agency (in this section referred to as
the "Administrator") finds that—

17 (1) applying subsection (a) would be incon-18 sistent with the public interest;

(2) iron and steel products are not produced in
the United States in sufficient and reasonably available quantities and of a satisfactory quality; or

(3) inclusion of iron and steel products produced in the United States will increase the cost of
the overall project by more than 25 percent.

1 (c) If the Administrator receives a request for a waiver under this section, the Administrator shall make avail-2 3 able to the public on an informal basis a copy of the re-4 quest and information available to the Administrator con-5 cerning the request, and shall allow for informal public 6 input on the request for at least 15 days prior to making 7 a finding based on the request. The Administrator shall 8 make the request and accompanying information available 9 by electronic means, including on the official public Inter-10 net Web site of the Environmental Protection Agency.

(d) This section shall be applied in a manner con-sistent with United States obligations under internationalagreements.

(e) The Administrator may retain up to 0.25 percent
of the funds appropriated in this Act for the Clean and
Drinking Water State Revolving Funds for carrying out
the provisions described in subsection (a)(1) for management and oversight of the requirements of this section.
MIDWAY ISLAND

SEC. 424. None of the funds made available by this Act may be used to destroy any buildings or structures on Midway Island that have been recommended by the United States Navy for inclusion in the National Register of Historic Places (54 U.S.C. 302101). 1 JOHN F. KENNEDY CENTER REAUTHORIZATION

2 SEC. 425. Section 13 of the John F. Kennedy Center

for the Nation Act (Public Law 114–322);
(3) \$25,000,000 shall be for grants for lead
testing in school and child care program drinking
water authorized in section 2107 of the Water Infra-
structure Improvements for the Nation Act (Public
Law 114–322);
(4) \$15,000,000 shall be for grants for reduc-
ing lead in drinking water authorized in section
2105 of the Water Infrastructure Improvements for
the Nation Act (Public Law 114–322).
(c) For an additional amount for "Environmental
Protection Agency—Water Infrastructure Finance and In-
novation Program Account", \$53,000,000, to remain
available until expended, for the cost of direct loans, for
the cost of guaranteed loans, and for administrative ex-
penses to carry out the direct and guaranteed loan pro-
grams, of which \$3,000,000, to remain available until Sep-
