## A BILL

To amend title XVIII of the Social Security Act to improve quality measurement and development.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Addiction Treatment  
5       Quality Improvement Act of 2018”.

1 **SEC. 2. IMPROVING QUALITY MEASUREMENT AND DEVEL-**  
 2 **OPMENT RELATED TO THE TREATMENT OF**  
 3 **OPIOID AND SUBSTANCE USE DISORDERS.**

4 (a) IN GENERAL.—Section 1890A of the Social Secu-  
 5 rity Act (42 U.S.C. 1395aaa–1) is amended by adding at  
 6 the end the following new subsection:

7 “(g) STRATEGIC FRAMEWORK FOR QUALITY MEAS-  
 8 URE DEVELOPMENT AND IMPLEMENTATION RELATED TO  
 9 THE TREATMENT OF OPIOID AND SUBSTANCE USE DIS-  
 10 ORDERS.—

11 “(1) ASSESSMENT.—Not later than 3 months  
 12 after the date of the enactment of this subsection,  
 13 the Secretary shall conduct an assessment of the  
 14 current state of quality measures and measure con-  
 15 cepts in the area of opioid and substance use dis-  
 16 orders. Such assessment shall also include an anal-  
 17 ysis to identify top-priority considerations for meas-  
 18 urement in the areas of opioid and substance use  
 19 disorders and gaps in areas of such measures.

20 “(2) REPORT.—Not later than 18 months after  
 21 the date of the enactment of this subsection, the  
 22 Secretary shall submit to Congress the results of the  
 23 assessment conducted under paragraph (1), together  
 24 with recommendations the Secretary determines ap-  
 25 propriate.

26 “(3) MEASURE DEVELOPMENT PLAN.—

1           “(A) DEVELOPMENT OF A PLAN.—The  
 2           Secretary shall develop a measure development  
 3           plan to address the gaps, measure concepts,  
 4           and identified measure domains stemming from  
 5           the recommendations in the report under para-  
 6           graph (2).

7           “(B) PLAN TO BE MADE PUBLICLY AVAIL-  
 8           ABLE.—Not later than 2 years after the date of  
 9           the enactment of this subsection, the Secretary  
 10          shall make the plan developed under subpara-  
 11          graph (A) publicly available.

12          “(4) CONTRACT.—The Secretary may enter into  
 13          a contract, or as necessary amend the contract, with  
 14          the entity with a contract under section 1890(a) to  
 15          conduct the assessment under paragraph (1) and  
 16          submit the report under paragraph (2), which may  
 17          be included in an annual report submitted under  
 18          section 1890(b)(5) before the deadline under such  
 19          paragraph (2) and which shall also be submitted to  
 20          the Secretary if not included in such annual re-  
 21          port.”.

22          (b) FUNDING.—Section 1890(d)(2) of the Social Se-  
 23          curity Act (42 U.S.C. 1395aaa(d)(2)) is amended—

24                 (1) in the first sentence, by striking “and (f)”  
 25                 and inserting “, (f), and (g)(3)”; and

1           (2) by adding at the end the following new sen-  
 2           tence: “Amounts transferred under this paragraph  
 3           for purposes of carrying out section 1890A(g) (other  
 4           than paragraph (3)) shall only be for the period of  
 5           fiscal years 2018 through 2020 and may not exceed  
 6           a total of \$1,500,000.”.

7   **SEC. 3. FACILITATION OF INCREASED COORDINATION AND**  
 8                           **ALIGNMENT BETWEEN THE PUBLIC AND PRI-**  
 9                           **VATE SECTOR WITH RESPECT TO QUALITY**  
 10                          **AND EFFICIENCY MEASURES.**

11           (a) IN GENERAL.—Section 1890(b) of the Social Se-  
 12           curity Act (42 U.S.C. 1395aaa(b)) is amended by insert-  
 13           ing after paragraph (3) the following new paragraph:

14                       “(4) FACILITATION OF INCREASED COORDINA-  
 15           TION AND ALIGNMENT BETWEEN THE PUBLIC AND  
 16           PRIVATE SECTOR WITH RESPECT TO QUALITY AND  
 17           EFFICIENCY MEASURES.—

18                       “(A) IN GENERAL.—The entity shall facili-  
 19           tate increased coordination and alignment be-  
 20           tween the public and private sector with respect  
 21           to quality and efficiency measures.

22                       “(B) ANNUAL REPORTS.—The entity shall  
 23           prepare and make available to the public its  
 24           findings under this paragraph in its annual re-  
 25           port. Such public availability shall include post-

1           ing each report on the Internet website of the  
2           entity”.

3           (b) **EFFECTIVE DATE.**—The amendment made by  
4 subsection (a) shall take effect on the date of the enact-  
5 ment of this Act.
