AN ACT

To amend the removal and transfer procedures for the Inspectors General of the Library of Congress, the Office of the Architect of the Capitol, and the Government Publishing Office.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

1 SECTION 1. SHORT TITLE.

2	This Act may be cited as the "Improving the Inspec-
3	tor General Process for Legislative Branch Instrumental-
4	ities Act''.
5	SEC. 2. REMOVAL AND TRANSFER PROCEDURES FOR THE
6	INSPECTORS GENERAL OF THE LIBRARY OF
7	CONGRESS, OFFICE OF THE ARCHITECT OF
8	THE CAPITOL, AND GOVERNMENT PUB-
9	LISHING OFFICE.
10	(a) Library of Congress.—Paragraph (2) of sec-
11	tion 1307(c) of the Legislative Branch Appropriations
12	Act, 2006 (2 U.S.C. 185(c)) is amended to read as follows:
13	"(2) Removal or transfer.—
14	"(A) IN GENERAL.—The Inspector General
15	may be removed from office, or transferred to
16	another position within, or another location of,
17	the Library of Congress, by the Librarian of
18	Congress.
19	"(B) Notice.—Not later than 30 days be-
20	fore the Librarian of Congress removes or
21	transfers the Inspector General under subpara-
22	graph (A), the Librarian of Congress shall com-
23	municate in writing the reason for the removal
24	or transfer to—

1	"(i) the Committee on House Administra-
2	tion and the Committee on Appropriations of
3	the House of Representatives; and
4	"(ii) the Committee on Rules and Adminis-
5	tration and the Committee on Appropriations of
6	the Senate.
7	"(C) Applicability.—Nothing in this para-
8	graph shall prohibit a personnel action (except for
9	removal or transfer) that is otherwise authorized by
10	law.".
11	(b) Office of the Architect of the Capitol.—
12	Paragraph (2) of section 1301(c) of the Architect of the
13	Capitol Inspector General Act of 2007 (2 U.S.C. 1808(c))
14	is amended to read as follows:
15	"(2) Removal or transfer.—
16	"(A) IN GENERAL.—The Inspector General
17	may be removed from office, or transferred to
18	another position within, or another location of,
19	the Office of the Architect of the Capitol, by the
20	Architect of the Capitol.
21	"(B) Notice.—Not later than 30 days be-
22	fore the Architect of the Capitol removes or
23	transfers the Inspector General under subpara-
24	graph (A), the Architect of the Capitol shall

1	communicate in writing the reason for the re-
2	moval or transfer to—
3	"(i) the Committee on House Administra-
4	tion and the Committee on Appropriations of
5	the House of Representatives; and
6	"(ii) the Committee on Rules and Adminis-
7	tration and the Committee on Appropriations of
8	the Senate.
9	"(C) Applicability.—Nothing in this para-
10	graph shall prohibit a personnel action (except for
11	removal or transfer) that is otherwise authorized by
12	law.".
13	(c) Government Publishing Office.—Section
14	3902(b) of title 44, United States Code, is amended to
15	read as follows:
16	``(b)(1) The Inspector General may be removed from
17	office, or transferred to another position within, or an-
18	other location of, the Government Publishing Office, by
19	the Director of the Government Publishing Office.
20	"(2) Not later than 30 days before the Director re-
21	moves or transfers the Inspector General under paragraph
22	(1), the Director shall communicate in writing the reason
23	for the removal or transfer to—

1	"(A) the Committee on House Administration
2	and the Committee on Appropriations of the House
3	of Representatives; and
4	"(B) the Committee on Rules and Administra-
5	tion and the Committee on Appropriations of the
6	Senate.
7	"(3) Nothing in this subsection shall prohibit a per-
8	sonnel action (except for removal or transfer) that is oth-
9	erwise authorized by law.".
