## HIGHLIGHTS

Senate confirmed the nomination of Neil M. Gorsuch, of Colorado, to be an Associate Justice of the Supreme Court of the United States.

## Senate

**Measures Introduced:** Twenty-four bills and thirteen resolutions were introduced, as follows: S. 888–911, and S. Res. 122–134. **Pages S2449–50**

#### Measures Reported:

S. Res. 116, condemning the Assad regime for its continued use of chemical weapons against the Syrian people, with amendments and with an amended preamble. **Page S2449**

**Authorizing Leadership to Make Appointments—Agreement:** A unanimous-consent agreement was reached providing that, notwithstanding the upcoming adjournment of the Senate, the President of the Senate, the President Pro Tempore, and the Majority and Minority Leaders be authorized to make appointments to commissions, committees, boards, conferences, or interparliamentary conferences authorized by law, by concurrent action of the two Houses, or by order of the Senate, and that they be printed in the Record. **Page S2462**

**Pro Forma Sessions—Agreement:** A unanimous-consent agreement was reached providing that the Senate adjourn, to then convene for pro forma sessions only, with no business being conducted on the following dates and times, and that following each pro forma session, the Senate adjourn until the next pro forma session: Monday, April 10, 2017 at 1:30 p.m.; Thursday, April 13, 2017 at 8:30 a.m.; Monday, April 17, 2017 at 4:30 p.m.; Thursday, April 20, 2017 at 7:20 p.m.; and that when the Senate adjourns on Thursday, April 20, 2017, it next convene at 3 p.m., on Monday, April 24, 2017. **Pages S2462–63**

**Rosenstein Nomination—Cloture:** Senate began consideration of the nomination of Rod J. Rosenstein, of Maryland, to be Deputy Attorney General. **Pages S2443–44**
