H.R. 5070.

Congress has the power to enact this legislation pursuant to the following:

Pursuant to Article 1, Section 8, Clause 3, Congress has the authority to regulate foreign and interstate commerce.

Congress has the power to enact this legislation pursuant to the following:

The ability to provide for the general welfare of the United States under Article 1, Section 8, Clause 1, which includes the power to promote the development of Rural America through research.

Congress has the power to enact this legislation pursuant to the following:

Article I, Section 8, Clause 4 of the Constitution of the United States, which states that Congress shall have the power to "establish a uniform Rule of Naturalization."

Congress has the power to enact this legislation pursuant to the following:

Article 1, Section 8, Clause 18

Congress has the power to enact this legislation pursuant to the following:

Article I, Section 8, Clause 18: To make all Laws which shall be necessary and proper for carrying into Execution the foregoing Powers, and all other Powers vested by this Constitution in the Government of the United States, or in any Department or Officer thereof.

H.R. 5075.

Congress has the power to enact this legislation pursuant to the following:

Article 1, Section 8

The Congress shall have Power To lay and collect Taxes, Duties, Imposts and Excises, to pay the Debts and provide for the common Defence and general Welfare of the United States; but all Duties, Imposts and Excises shall be uniform throughout the United States;

To borrow money on the credit of the United States;

To regulate Commerce with foreign Nations, and among the several States, and with the Indian Tribes;

To establish an uniform Rule of Naturalization, and uniform Laws on the subject of Bankruptcies throughout the United States;

To coin Money, regulate the Value thereof, and of foreign Coin, and fix the Standard of Weights and Measures;

To provide for the Punishment of counterfeiting the Securities and current Coin of the United States;

To establish Post Offices and Post Roads;

To promote the Progress of Science and useful Arts, by securing for limited Times to Authors and Inventors the exclusive Right to their respective Writings and Discoveries;

To constitute Tribunals inferior to the supreme Court;

and Offenses against the Law of Nations;

To declare War, grant Letters of Marque and Reprisal, and make Rules concerning Captures on Land and Water;

To raise and support Armies, but no Appropriation of Money to that Use shall be for a longer Term than two Years;

To provide and maintain a Navy;

To make Rules for the Government and Regulation of the land and naval Forces;

To provide for calling forth the Militia to execute the Laws of the Union, suppress Insurrections and repel Invasions;

To provide for organizing, arming, and disciplining, the Militia, and for governing such Part of them as may be employed in the Service of the United States, reserving to the States respectively, the Appointment of the Officers, and the Authority of training the Militia according to the discipline prescribed by Congress;

To exercise exclusive Legislation in all Cases whatsoever, over such District (not exceeding ten Miles square) as may, by Cession of particular States, and the acceptance of Congress, become the Seat of the Government of the United States, and to exercise like Authority over all Places purchased by the Consent of the Legislature of the State in which the Same shall be, for the Erection of Forts, Magazines, Arsenals, dock-Yards, and other needful Buildings; And

To make all Laws which shall be necessary and proper for carrying into Execution the foregoing Powers, and all other Powers vested by this Constitution in the Government of the United States, or in any Department or Officer thereof.

Mr. RYAN of Wisconsin. Mr. Speaker, I rise today to pay tribute to the life of Jeffrey L. Bell, an Army veteran and prominent conservative leader who passed away on February 10, 2018. I extend the deepest condolences of the whole House to the Bell family, most especially his wife, Rosalie, and their four children.

Jeff Bell's many contributions to politics and public policy date back half a century. He was a heavyweight in the conservative movement before it even was a movement. His ideas, and the passion with which he espoused them, paved the way for the Reagan Revolution. He was an integral part of President Reagan's campaigns, and worked with my mentor, Jack Kemp, to develop the policy agenda that would bring the nation great prosperity and end the Cold War.

His work spanned, and inspired, generations. Jeff ran for U.S. Senate in New Jersey twice, in 1978 and 2014. He published two influential books, in 1992 and 2012. To the last, he remained at the forefront, one of the most original voices for inclusive, aspirational conservatism.

Indeed, I count myself among the many who learned so much from this man. We first met in the early 1990s, and I have looked up to him ever since. Beyond the depth of his thinking, I was always struck by how decent and gracious Jeff was to everyone he encountered—the epitome of a happy warrior. It was such an honor to know him.

God bless the memory of Jeff Bell, the family that he loved so dearly, and this great country that he served so well and faithfully.

### RECOGNIZING JAMES (JIM) BERNEY McMILLAN, JR. ON THE OCCASION OF HIS 90TH BIRTHDAY

Mr. DeSAULNIER. Mr. Speaker, I rise to recognize Mr. James (Jim) Berney McMillan, Jr., on the occasion of his 90th Birthday. Jim is a longtime resident of and small business owner in Richmond, California.

Jim McMillan was the first African American student and graduate from the College of Pharmacy at Oregon State. He was the second African American Oregon State Graduate, after William Maxwell. When he enrolled in 1948, only one African American had graduated from Oregon State in any field. At that time, there were only two African Americans on the entire campus of about 6,000 students.

While at Oregon State, McMillan worked on trains traveling between Portland and Oakland during summers to support his college studies.

Jim moved to Berkeley after graduation because he found that no pharmacy in Portland, Oregon was willing to hire an African American pharmacist. In 1958, he opened McMillan's Pharmacy on 10th Street in Richmond, California. Jim ran McMillan's Pharmacy on Cutting Blvd. for 28 years, closing in 1996.

McMillan was elected to the Richmond City Council in 1982 and took his seat in early 1983. He served three consecutive terms, retiring in 1995.

Though he retired from the council in 1996, he has remained an active leader. He is a Golden Heritage and Lifetime member of the National Association for the Advancement of Colored People, a member of Alpha Phi Alpha Fraternity, a founder of the Richmond Black American Political Action Committee, served on the Zhoushan China Sister City Commission, served on the Board of Directors of the West County Housing Corporation and volunteers on the Citizens Advisory Committee on toxic pollution for the Port of Richmond. Also served on the City of Richmond Library Commission.

I congratulate Jim on his lifetime of achievements and wish him the very best in the future.

For more than 20 years, Sheila held an annual Fourth of July flag-raising ceremony using the flagpole in her front lawn. Through the years this event attracted friends and family, local and statewide elected officials, and many others who wished to pay tribute to those who had given the ultimate sacrifice for our freedoms.

Sheila had the ability to build bridges of friendship and engage in constructive discussions, with those of differing beliefs. Many times, Sheila united members of different faiths, to join together in humanitarian projects. She also served on the Executive Committee of the Greater Idaho Falls Public Affairs Council as a liaison between the media and The Church of Jesus Christ of Latter-Day Saints. She was frequently asked and entrusted to provide her insight and views to the media with regard to sensitive issues involving religion, faith and politics.

Bush.

Despite all of the awards and accolades that have come her way, Sheila will be remembered for the personal relationship that she built with anyone she came in contact with. Our nation is a better place because of Sheila Olsen.

Had I been present for roll call vote 80, on final passage of the ADA Education and Reform Act of 2017 (H.R. 620), I would have voted nay due to the vast setbacks this bill poses for the disability community. As a civil rights issue, the ADA Education and Reform Act would gut protections and key enforcements for an already vulnerable population. The onus falls on businesses to be proactive and to follow proper guidelines to ensure access for all. I particularly find troubling the "notice and cure" provisions detailed in the bill, which allows businesses to postpone compliance and fundamentally changes the American with Disabilities Act.
