#### CONSTITUTIONAL AUTHORITY STATEMENT

Pursuant to clause 7 of rule XII of the Rules of the House of Representatives, the following statements are submitted regarding the specific powers granted to Congress in the Constitution to enact the accompanying bill or joint resolution.

H.R. 5408.

Congress has the power to enact this legislation pursuant to the following:

Congress taxes and spends (which is applied to numerous government programs, including grant programs) under Article I, Sec. 8, Cl. "The Congress shall have Power To lay and collect Taxes, Duties, Imposts and Excises, to pay the Debts and provide for the common Defence and general Welfare of the United States. . . ."

H.R. 5409.

Congress has the power to enact this legislation pursuant to the following:

Article I Section 8 of the U.S. Constitution
