

The decision continues to be vital and relevant today—not only in its rejection of segregation and racial discrimination, but also as a leading precedent for the Iowa Supreme Court's independent constitutional analysis."

Muthuvel Karunanithi was a poet, writer, publisher, orator, novelist, and literary critic in the Tamil language. His books sold millions of copies and his movie scripts shattered old boundaries of political possibility, articulating a new vision of human relationships.

He ran for political office thirteen times and never lost over a seventy year period. He was chief minister of the state of Tamil Nadu in southern India five times. His career was marked by a lifelong commitment to breaking the barriers of the caste system, especially for the lowest caste people who handle human waste. Karunanithi led a successful effort for an affirmative action program for their admittance to medical schools and subsequent admission to the practice of medicine. He visited Chicago in 1972.

Muthuvel Karunanithi was a man from the lowest rung of the social ladder who climbed the highest political mountains, but kept his lifestyle simple and his thoughts and actions fixed on the highest aspirations for all of his people.
