## **COMMITTEE MARKUP ACTION**

The Committee on Natural Resources met in open session on Wednesday, September 5, 2018, to consider the following bills:

**H. Res. 418 (Rep. Sean P. Duffy),** Urging the Secretary of the Interior to recognize the cultural significance of Rib Mountain by adding it to the National Register of Historic Places.

The Subcommittee on Federal Lands was discharged from further consideration of H. Res. 418 by unanimous consent.

H. Res. 418 was adopted and ordered favorably reported to the House of Representatives by unanimous consent.

**H. Res. 460** (**Rep. Sean P. Duffy**), Requesting the Secretary of the Interior to recognize the rich history of the logging industry and the importance of lumberjack sports by adding the Lumberjack Bowl to the National Register of Historic Places.

The Subcommittee on Federal Lands was discharged from further consideration of H. Res. 460 by unanimous consent.

H. Res. 460 was adopted and ordered favorably reported to the House of Representatives by unanimous consent.

**H.R. 5420** (**Rep. John J. Faso**), To authorize the acquisition of land for addition to the Home of Franklin D. Roosevelt National Historic Site in the State of New York, and for other purposes. "FDR Historic Preservation Act".

The Subcommittee on Federal Lands was discharged from further consideration of H.R. 5420 by unanimous consent.

An amendment offered by Mr. McClintock [#1], was agreed to by unanimous consent.

H.R. 5420, as amended, was adopted and ordered favorably reported to the House of Representatives by unanimous consent.

**H.R. 5513** (**Rep. Paul Cook**), To provide for an exchange of lands with San Bernardino County, California, to enhance management of lands within the San Bernardino National Forest, and for other purposes. "Big Bear Land Exchange Act".

The Subcommittee on Federal Lands was discharged from further consideration of H.R. 5513 by unanimous consent.

An amendment offered by Mr. Cook [#1], was agreed to by unanimous consent.

H.R. 5513, as amended, was adopted and ordered favorably reported to the House of Representatives by unanimous consent.

**H.R. 6013 (Rep. Rob Bishop),** To amend the Migratory Bird Treaty Act to establish January 31 of each year as the Federal closing date for duck hunting season and to establish special duck hunting days for youths, veterans, and active military personnel, and for other purposes. "Migratory Bird Framework and Hunting Opportunities for Veterans Act".

The Subcommittee on Federal Lands was discharged from further consideration of H.R. 6013 by unanimous consent.

An amendment offered by Mr. Bishop of Utah [#1], was agreed to by voice vote.

An amendment offered by Mr. Graves of Louisiana [#2], was offered and withdrawn.

H.R. 6013, as amended, was adopted and ordered favorably reported to the House of Representatives by voice vote.

**H.R. 6287 (Rep. Thomas MacArthur),** To provide competitive grants for the operation, security, and maintenance of certain memorials to victims of the terrorist attacks of September 11, 2001. "9/11 Memorial Act".

H.R. 6287 was adopted and ordered favorably reported to the House of Representatives by unanimous consent.

**H.R. 6299 (Rep. Mark E. Amodei),** To modify the process of the Secretary of the Interior for examining certain mining claims on Federal lands in Storey County, Nevada, to facilitate certain pinyon-juniper-related projects in Lincoln County, Nevada, to modify the boundaries of certain wilderness areas in the State of Nevada, to fully implement the White Pine County Conservation, Recreation, and Development Act, and for other purposes. "Nevada Lands Bill Technical Corrections Act of 2018".

The Subcommittee on Federal Lands was discharged from further consideration of H.R. 6299 by unanimous consent.

An amendment offered by Mr. McClintock [#1], was agreed to by unanimous consent.

H.R. 6299, as amended, was adopted and ordered favorably reported to the House of Representatives by unanimous consent.

**H.R. 6599** (**Rep. Stephen Knight**), To modify the application of temporary limited appointment regulations to the National Park Service, and for other purposes.

H.R. 6599 was adopted and ordered favorably reported to the House of Representatives by unanimous consent.

**H.R. 6665** (**Rep. Madeleine Z. Bordallo**), To amend the Outer Continental Shelf Lands Act to apply to territories of the United States, to establish offshore wind lease sale requirements, to provide dedicated funding for coral reef conservation, and for other purposes. "Offshore Wind for Territories Act".

H.R. 6665 was adopted and ordered favorably reported to the House of Representatives by unanimous consent.

**H.R. 6678** (**Rep. Barbara Comstock**), To direct the Secretary of the Interior to convey certain National Park Service land in Fairfax County, Virginia, to the Friends of the Claude Moore Farm. "Claude Moore Farm Land Conveyance Act".

An amendment offered by Mr. Grijalva [111], was not agreed to by a roll call vote of 14 yeas and 18 nays.

H.R. 6678 was adopted and ordered favorably reported to the House of Representatives by a roll call vote of 18 yeas and 14 nays.

**H.R. 6687** (**Rep. Jared Huffman**), To direct the Secretary of the Interior to manage the Point Reyes National Seashore in the State of California consistent with Congress' long-standing intent to maintain working dairies and ranches on agricultural property as part of the seashore's unique historic, cultural, scenic and natural values, and for other purposes.

An amendment offered by Mr. Huffman [#1], was agreed to by unanimous consent.

H.R. 6687, as amended, was adopted and ordered favorably reported to the House of Representatives by unanimous consent.

**S. 2857** (Sen. Maria Cantwell), A bill to designate the Nordic Museum in Seattle, Washington, as the "National Nordic Museum", and for other purposes. "National Nordic Museum Act".

The Subcommittee on Federal Lands was discharged from further consideration of S. 2857 by unanimous consent.
