A BILL

To amend the Department of Agriculture Reorganization Act of 1994 to reaffirm the authority of the Under Secretary of Agriculture for Research, Education, and Economics, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as “Agriculture Research In-
5 tegrity Act of 2019”.

1 **SEC. 2. REAFFIRMING AUTHORITY OF THE UNDER SEC-**
2 **RETARY OF AGRICULTURE FOR RESEARCH,**
3 **EDUCATION, AND ECONOMICS.**

4 Subtitle F of the Department of Agriculture Reorga-
5 nization Act of 1994 (7 U.S.C. 6971 et seq.) is amended
6 by adding at the end the following:

7 **“SEC. 253. REAFFIRMING AUTHORITY OF THE UNDER SEC-**
8 **RETARY.**

9 “(a) IN GENERAL.—Notwithstanding the authority
10 specified in Reorganization Plan No. 2 of 1953 (5 U.S.C.
11 App.; 7 U.S.C. 2201 note) or any other provision of Fed-
12 eral law relating to the authority of the Secretary, includ-
13 ing section 296—

14 “(1) the Agricultural Research Service, the
15 Economic Research Service, the National Agricul-
16 tural Statistics Service, and the National Institute
17 for Food and Agriculture, and any successor agen-
18 cies shall be within the research, education, and eco-
19 nomics mission area of the Department;

20 “(2) the authority to administer such agencies
21 is vested in the Under Secretary for Research, Edu-
22 cation, and Economics; and

23 “(3) such authority may not be vested in the
24 head of another agency or office within the Depart-
25 ment.

1 “(b) LOCATION.—The Secretary shall locate each
2 agency referred to in subsection (a)(1) and the majority
3 of the staff of each such agency within the National Cap-
4 ital Region to ensure maximum coordination and inter-
5 action with each other such agency, with the agencies de-
6 livering food and agricultural programs and services of the
7 Department, and with other Federal Government science
8 agencies (including science agencies of the Department).”.
