# **A BILL**

To update the map of, and modify the maximum acreage available for inclusion in, the Yucca House National Monument.

1       *Be it enacted by the Senate and House of Representa-*  
 2       *tives of the United States of America in Congress assembled,*

3       **SEC. 1. SHORT TITLE.**

4       *This Act may be cited as the “Yucca House National*  
 5       *Monument Expansion Act”.*

6       **SEC. 2. DEFINITIONS.**

7       *In this Act:*

8               (1) *NATIONAL MONUMENT.*—*The term “National*  
 9       *Monument” means the Yucca House National Monu-*  
 10       *ment in Cortez, Colorado, established by Presidential*  
 11       *Proclamation 1549.*

12              (2) *MAP.*—*The term “map” means the map enti-*  
 13       *tled “Yucca House National Monument Proposed*  
 14       *Boundary Addition”, numbered 318/105,085A, and*  
 15       *dated February 27, 2019.*

16              (3) *SECRETARY.*—*The term “Secretary” means*  
 17       *the Secretary of the Interior.*

18       **SEC. 3. YUCCA HOUSE NATIONAL MONUMENT LAND ACQUI-**  
 19               **SITION.**

20              (a) *ACQUISITION.*—*The Secretary may acquire by do-*  
 21       *nation the approximately 160 acres of land and any inter-*  
 22       *ests in the land that is identified on the map.*

23              (b) *BOUNDARY.*—*On the acquisition of the land au-*  
 24       *thorized under subsection (a), the Secretary shall adjust the*

1 *boundaries of the National Monument to include the ac-*  
2 *quired land.*

3       *(c) ADMINISTRATION.—The land and any interests in*  
4 *land acquired under subsection (a) shall be administered*  
5 *as part of the National Monument.*
