10	"(1) Definitions.—In this subsection—				
11	"(A) the term 'cyber strategy' means re-				
12	sources and tactics to assist in planning for cy-				
13	bersecurity and defending against cyber risks				
14	and cyber attacks; and				
15	"(B) the term 'lead small business develop-				
16	ment center' means a small business develop-				
17	ment center that has received a grant from the				
18	Administration.				
19	"(2) Certification Program.—The Adminis-				
20	trator shall establish a cyber counseling certification				
21	program, or approve a similar existing program, to				
22	certify the employees of lead small business develop-				
23	ment centers to provide cyber planning assistance to				
24	small business concerns.				
25	"(3) Number of Certified Employees.—				
26	The Administrator shall ensure that the number of				

1 employees of each lead small business development 2 center who are certified in providing cyber planning assistance under this subsection is not fewer than 3 the lesser of— "(A) 5; or 6 "(B) 10 percent of the total number of em-7 ployees of the lead small business development 8 center. 9 "(4) Consideration of small business de-10 VELOPMENT CENTER CYBER STRATEGY.—In car-11 rying out this subsection, the Administrator, to the 12 extent practicable, shall consider any cyber strategy methods included in the Small Business Develop-13 14 ment Center Cyber Strategy developed under section 15 1841(a) of the National Defense Authorization Act 16 for Fiscal Year 2017 (Public Law 114–328; 130 17 Stat. 2662). 18 "(5) Reimbursement for certification.— 19 "(A) IN GENERAL.—Subject to the avail-20 ability of appropriations and subparagraph (B), 21 the Administrator shall reimburse a lead small 22 business development center for costs relating

to the certification of an employee of the lead

small business development center under the

program established under paragraph (2).
