Mr. STEUBE (for himself, Mr. DUNN, Mr. McCLINTOCK, and Ms. GABBARD) introduced the following bill; which was referred to the Committee on Natural Resources

A BILL

To waive the application fee for any special use permit for veterans demonstrations and special events at war memorials on Federal land, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Free Veterans from
5 Fees Act”.

1 **SEC. 2. WAIVER OF SPECIAL USE PERMIT APPLICATION**
2 **FEE FOR VETERANS DEMONSTRATIONS AND**
3 **SPECIAL EVENTS.**

4 (a) **WAIVER.**—The application fee for any special use
5 permit solely for a veterans demonstration or special event
6 at war memorials on Federal land shall be waived.

7 (b) **DEFINITIONS.**—In this section:

8 (1) **DEMONSTRATION; SPECIAL EVENT.**—The
9 terms “demonstration” and “special event” have the
10 meaning given those terms in section 7.96 of title
11 36, Code of Federal Regulations.

12 (2) **VETERAN.**—The term “veteran” has the
13 meaning given that term in section 101(2) of title
14 38, United States Code.

15 (3) **VETERANS DEMONSTRATION OR SPECIAL**
16 **EVENT.**—The term “veterans demonstration or spe-
17 cial event” means a demonstration or special event
18 whose primary purpose is to commemorate, or honor
19 either a group of people because of their service as
20 veterans or immediate family members of veterans.

21 (4) **WAR MEMORIAL.**—The term “war memo-
22 rial” means any tangible object which has been
23 erected or dedicated to commemorate—

24 (A) war, conflict, victory, or peace;

1 (B) casualties who served in, were affected
2 by, or killed as a result of war, conflict, or
3 peacekeeping; or

4 (C) those who died as a result of accident
5 or disease while engaged in military service.

6 (c) APPLICABILITY.—This section shall apply to any
7 special use permit application submitted after the date of
8 the enactment of this Act.

9 (d) APPLICABILITY OF EXISTING LAWS.—Permit ap-
10 plicants remain subject to all other laws, regulations, and
11 policies regarding the application, issuance and execution
12 of special use permits for a veterans demonstration or spe-
13 cial event at war memorials on Federal land.
