- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Students and Teachers
- 5 Over Politicians Act" or "STOP Act".

 to the 10-Year Pediatric Research Initiative Fund
 described in section 9008(i)(2), to be available as described in such section; and
 - "(2) the Secretary shall transfer the remainder to the Secretary of Education (to the extent and in such amounts as provided in advance in appropriations Acts), to be used only to carry out activities under title II of the Elementary and Secondary Education Act of 1965 (20 U.S.C. 6601 et seq.).".
- 11 (2) TERMINATION OF ACCOUNT.—Chapter 96 12 of subtitle H of such Code is amended by adding at 13 the end the following new section:
