A BILL

To amend the Public Health Service Act to ensure the consensual donation and respectful disposition of human bodies and human body parts donated or transferred for education, research, or the advancement of medical, dental, or mortuary science and not for use in human transplantation, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-

- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Consensual Donation
- 5 and Research Integrity Act of 2019".

| 9 | "(D) The name of the person, including |
| 10 | any trade or business name, who transferred |
| 11 | the human body or human body part to the reg- |
| 12 | istrant, if applicable. |
| 13 | "(E) The full name and most recent ad- |
| 14 | dress of the donor. |
| 15 | "(F) A description of the human body or |
| 16 | human body part being acquired or transferred. |
| 17 | "(G) The medical history of the donor, in- |
| 18 | cluding the autopsy report if an autopsy was |
| 19 | conducted. |
| 20 | "(H) The identity and address of each per- |
| 21 | son that has been in possession of the human |
| 22 | body or human body part prior to the reg- |
| 23 | istrant, including any funeral home, coroner, |
| 24 | hospital, organ procurement organization, or |
| 25 | tissue bank. |

| 10 | that all human bodies and human body parts in the |
| 11 | possession of, or transferred by, a registrant are la- |
| 12 | beled and packaged in accordance with paragraphs |
| 13 | (2) and (3). |
| 14 | "(2) Labeling requirements.—A label |
| 15 | under paragraph (1) shall contain such information |
| 16 | as the Secretary may by regulation require con- |
| 17 | sistent with any applicable Federal privacy provi- |
| 18 | sions. Unless the Secretary specifies otherwise by |
| 19 | regulation, a label under paragraph (1) shall include |
| 20 | the following: |
| 21 | "(A) The proper name of the donor. |
| 22 | "(B) A description of the contents of the |
| 23 | package, indicating whether it is a human body |
| 24 | or human body parts, including a list of all |
| 25 | such parts. |

| 11 | "(G) Any known infectious disease agents |
| 12 | of such human body or human body part. |
| 13 | "(H) A statement about the use of per- |
| 14 | sonal protective equipment and universal pre- |
| 15 | cautions when handling a human body or |
| 16 | human body part as required by law. |
| 17 | "(I) The statement 'not for transplan- |
| 18 | tation.'. |
| 19 | "(3) Packaging requirements.—Each |
| 20 | human body or human body part described in para- |
| 21 | graph (1) shall be wrapped and packaged in such |
| 22 | manner as the Secretary may by regulation require. |
| 23 | Unless the Secretary specifies otherwise by regula- |
| 24 | tion, each such human body or human body part |
| 25 | shall be wrapped and packaged in a manner that— |

| I | "(A) mitigates potential contamination and |

| 4 | "(C) is sealed to prevent leakage; and |

| 7 | "(e) DISPOSITION.—The registrant shall ensure the |
| 8 | proper disposition of a human body or human body part, |
| 9 | in accordance with applicable Federal and State law, by— |
| 10 | "(1) returning the human body or human body |
| 11 | part to a relative or personal representative of the |
| 12 | donor or carrying out the disposition of such human |
| 13 | body or human body part; or |
| 14 | "(2) if the registrant is transferring the human |
| 15 | body or human body part to another person, con- |
| 16 | tracting with such person to assume the obligation |
| 17 | described in paragraph (1). |
| 18 | "(f) VIOLATIONS.— |
| 19 | "(1) In general.—Any person who violates a |
| 20 | requirement of this section shall be fined in accord- |
| 21 | ance with title 18, United States Code. |
| 22 | "(2) REVOCATION OF REGISTRATION.—The |
| 23 | Secretary may suspend or revoke the registration of |
| 24 | any registrant found to be in violation of this sec- |
| 25 | tion. |

1 "(3) ALTERATION OR FALSIFICATION OF 2 LABEL.—It shall be a violation of this section for 3 any person to alter or falsify any information in a 4 label required by subsection (d).

"(g) DEFINITIONS.—In this section:

- "(1) Donor.—The term 'donor' means a person who has knowingly consented in accordance with applicable law to the transfer of such person's deceased body or deceased or living body part (not for use in transplantation) for education, research, or the advancement of medical, dental, or mortuary science.
- "(2) EDUCATION.—The term 'education' means the use of a human body or body parts for teaching or training individuals, including medical, dental, or mortuary science students or professionals, with regard to the anatomy and characteristics of the human body, disease detection, and such other uses as may be specified by the Secretary by regulation.
- "(3) Human Body.—The term 'human body' means a deceased human body.
- "(4) Human Body Part.—The terms 'human body part' or 'body part' mean an organ, tissue, eye, bone, blood vessel or any other portion of a deceased or living human body that is subject to an anatom-

| 5 | "(5) Research.—The term 'research' does not |
| 6 | include an autopsy or examination, conducted as |

| 8 | (b) Rule of Applicability.—The amendments |
| 9 | made by this section shall apply with respect to any acqui- |
| 10 | sition or transfer of a human body or human body parts |
| 11 | after the date that is 2 years after the date of the enact- |
| 12 | ment of this Act. |
