A BILL

To amend the Communications Act of 1934 to direct the Federal Communications Commission to carry out a grant program to make grants for the establishment or expansion of job training programs for communications tower service, construction, and maintenance.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Communications Jobs
- 5 Training Act of 2019".

1 SEC. 2. FINDINGS.

2	Congress finds that—
3	(1) the reorganization of broadcast television
4	spectrum under section 6403(b) of the Middle Class
5	Tax Relief and Job Creation Act of 2012 (47 U.S.C.
6	1452(b)), the establishment of the First Responder
7	Network Authority (FirstNet) under such Act, and
8	advances toward 5G technology have created high
9	demand for communications tower service, construc-
10	tion, maintenance, and structural modification;
11	(2) additional job training is necessary to meet
12	such demand; and
13	(3) enhancement of communications tower serv-
14	ice is essential to the Nation's economy, competitive-
15	ness, homeland security, and vital communications
16	capabilities.
17	SEC. 3. COMMUNICATIONS TOWER JOB TRAINING GRANT
18	PROGRAM.
19	Part I of title III of the Communications Act of 1934
20	(47 U.S.C. 301 et seq.) is amended by adding at the end
21	the following:
22	"SEC. 344. COMMUNICATIONS TOWER JOB TRAINING
23	GRANT PROGRAM.
24	"(a) In General.—The Commission, in consultation
25	with the Secretary of Education, shall carry out a grant
26	program to make grants to covered entities to establish

- 1 or expand job training programs for communications
- 2 tower service, construction, maintenance, and structural
- 3 modification.
- 4 "(b) Application.—To be eligible to receive a grant
- 5 under this section, a covered entity shall submit an appli-
- 6 cation to the Commission at such time, in such manner,
- 7 and containing such information as the Commission may
- 8 require.
- 9 "(c) Deadline.—The Commission shall begin ac-
- 10 cepting applications for grants under this section not later
- 11 than the date that is 90 days after the date of the enact-
- 12 ment of this section.
- 13 "(d) Reports to Congress.—Not later than 1 year
- 14 after the date of the enactment of this section, and annu-
- 15 ally thereafter, the Commission shall submit to the Com-
- 16 mittee on Energy and Commerce of the House of Rep-
- 17 resentatives and the Committee on Commerce, Science,
- 18 and Transportation of the Senate a report on the grant
- 19 program carried out under this section that includes, with
- 20 respect to the 1-year period preceding the date of the sub-
- 21 mission of the report—
- "(1) the number and total dollar amount of
- 23 grants made under this section;
- 24 "(2) the number of individuals and crews
- 25 trained to perform communications tower service,

1	construction, maintenance, and structural modifica-
2	tion using grant funds; and
3	"(3) the number of communications towers on
4	which service, construction, maintenance, or struc-
5	tural modification was performed by individuals or
6	crews while participating in job training programs
7	receiving grant funds.
8	"(e) Definitions.—In this section:
9	"(1) Communications tower.—The term
10	'communications tower' means a structure that
11	transmits broadcast radio signals, commercial mobile
12	service (as defined in section 332) signals, or com-
13	mercial mobile data service (as defined in section
14	6001 of the Middle Class Tax Relief and Job Cre-
15	ation Act of 2012 (47 U.S.C. 1401)) signals.
16	"(2) COVERED ENTITY.—The term 'covered en-
17	tity' means—
18	"(A) a junior or community college (as de-
19	fined in section 312(f) of the Higher Education
20	Act of 1965 (20 U.S.C. 1058(f)));
21	"(B) a postsecondary vocational institution
22	(as defined in section 102(c) of the Higher
23	Education Act of 1965 (20 U.S.C. 1002(c)));
24	"(C) an area career and technical edu-
25	cation school (as defined in section 3 of the

1	Carl D. Perkins Career and Technical Edu-
2	cation Act of 2006 (20 U.S.C. 2302)); or
3	"(D) any organization that provides career
4	and technical education (as defined in such sec-
5	tion) to veterans (as defined in section 101 of
6	title 38, United States Code).
7	"(f) AUTHORIZATION OF APPROPRIATIONS.—There
8	is authorized to be appropriated to carry out this section
9	\$20,000,000 for each of the fiscal years 2020 through
10	2022. Amounts appropriated under this subsection are au-
11	thorized to remain available until expended.".
