## A BILL

To amend the Intermodal Surface Transportation Efficiency Act of 1991 with respect to a portion of the Wendell H. Ford (Western Kentucky) Parkway, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. WENDELL H. FORD (WESTERN KENTUCKY)**  
4 **PARKWAY.**

5 (a) DESIGNATION AS HIGH PRIORITY CORRIDOR.—

6 Section 1105(c) of the Intermodal Surface Transportation  
7 Efficiency Act of 1991 is amended by adding at the end  
8 the following:

1           “(91) The Wendell H. Ford (Western Ken-  
2           tucky) Parkway from the interchange with the Wil-  
3           liam H. Natcher Parkway in Ohio County, Ken-  
4           tucky, west to the interchange of the Western Ken-  
5           tucky Parkway with the Edward T. Breathitt  
6           (Pennyrile) Parkway.”.

7           (b) DESIGNATION AS FUTURE INTERSTATE.—Sec-  
8           tion 1105(e)(5)(A) of the Intermodal Surface Transpor-  
9           tation Efficiency Act of 1991 is amended by striking “and  
10           subsection (c)(90)” and inserting “subsection (c)(90), and  
11           subsection (c)(91)”.

12           (c) NUMBERING OF PARKWAY.—Section  
13           1105(e)(5)(C)(i) of the Intermodal Surface Transpor-  
14           tation Efficiency Act of 1991 is amended by adding at  
15           the end the following: “The route referred to in subsection  
16           (c)(91) is designated as Interstate Route I–369.”.

17           (d) OPERATION OF VEHICLES.—Section 127(l)(3)(A)  
18           of title 23, United States Code, is amended—

19           (1) by striking “clause (i) or (ii)” and inserting  
20           “clauses (i) through (iii)”; and

21           (2) by adding at the end the following:

22                           “(iii) The Wendell H. Ford (Western  
23                           Kentucky) Parkway (to be designated as a  
24                           spur of Interstate Route 69) from the  
25                           interchange with the William H. Natcher

1 Parkway in Ohio County, Kentucky, west  
2 to the interchange of the Western Ken-  
3 tucky Parkway with the Edward T.  
4 Breathitt (Pennyrile) Parkway.”.
