## **A BILL**

To amend the Public Health Service Act to reauthorize school-based health centers, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “School-Based Health  
5 Centers Reauthorization Act of 2019”.

6 **SEC. 2. REAUTHORIZATION OF SCHOOL-BASED HEALTH**  
7 **CENTERS.**

8 (a) **ELIMINATION OF LIMITATION ON ELIGIBILITY OF**  
9 **HEALTH CENTERS.—**

10 (1) **REPEAL.—**Section 399Z–1(f)(3) of the  
11 Public Health Service Act (42 U.S.C. 280h–5(f)(3))  
12 is amended by striking subparagraph (B).

13 (2) **CONFORMING CHANGE.—**Section 399Z–  
14 1(f)(3) of the Public Health Service Act (42 U.S.C.  
15 280h–5(f)(3)) is amended by striking “LIMITA-  
16 TIONS” and all that follows through “Any provider  
17 of services” and inserting “LIMITATION.—Any pro-  
18 vider of services”.

19 (b) **AUTHORIZATION OF APPROPRIATIONS.—**Section  
20 399Z–1(l) of the Public Health Service Act (42 U.S.C.  
21 280h–5(l)) is amended by striking “2010 through 2014”  
22 and inserting “2019 through 2024”.
