

***In the Senate of the United States,***

*May 23 (legislative day, May 22), 2019.*

*Resolved*, That the bill from the House of Representatives (H.R. 2157) entitled “An Act making supplemental appropriations for the fiscal year ending September 30, 2019, and for other purposes.”, do pass with the following

**AMENDMENT:**

Strike all after the enacting clause and insert the following:

- 1 *The following sums in this Act are appropriated, out of any*
- 2 *money in the Treasury not otherwise appropriated, for the*
- 3 *fiscal year ending September 30, 2019, and for other pur-*
- 4 *poses, namely:*

1 *TITLE I*2 *DEPARTMENT OF AGRICULTURE*3 *AGRICULTURAL PROGRAMS*4 *PROCESSING, RESEARCH AND MARKETING*5 *OFFICE OF THE SECRETARY*

6 *For an additional amount for the “Office of the Sec-*  
7 *retary”, \$3,005,442,000, which shall remain available until*  
8 *December 31, 2020, for necessary expenses related to losses*  
9 *of crops (including milk, on-farm stored commodities, crops*  
10 *prevented from planting in 2019, and harvested adulterated*  
11 *wine grapes), trees, bushes, and vines, as a consequence of*  
12 *Hurricanes Michael and Florence, other hurricanes, floods,*  
13 *tornadoes, typhoons, volcanic activity, snowstorms, and*  
14 *wildfires occurring in calendar years 2018 and 2019 under*  
15 *such terms and conditions as determined by the Secretary:*  
16 *Provided, That the Secretary may provide assistance for*  
17 *such losses in the form of block grants to eligible states and*  
18 *territories and such assistance may include compensation*  
19 *to producers, as determined by the Secretary, for forest res-*  
20 *toration and poultry and livestock losses: Provided further,*  
21 *That of the amounts provided under this heading, tree as-*  
22 *sistance payments may be made under section 1501(e) of*  
23 *the Agricultural Act of 2014 (7 U.S.C. 9081(e)) to eligible*  
24 *orchardists or nursery tree growers (as defined in such sec-*  
25 *tion) of pecan trees with a tree mortality rate that exceeds*

1 7.5 percent (adjusted for normal mortality) and is less than  
 2 15 percent (adjusted for normal mortality), to be available  
 3 until expended, for losses incurred during the period begin-  
 4 ning January 1, 2018, and ending December 31, 2018: Pro-  
 5 vided further, That in the case of producers impacted by  
 6 volcanic activity that resulted in the loss of crop land, or  
 7 access to crop land, the Secretary shall consider all meas-  
 8 ures available, as appropriate, to bring replacement land  
 9 into production: Provided further, That of the amounts pro-  
 10 vided under this heading, not more than \$7,000,000 shall  
 11 be available to make payments to agricultural producers  
 12 whose Whole Farm Revenue Protection indemnity pay-  
 13 ments were reduced following 2018 crop year losses due to  
 14 assistance received through state-legislated agriculture dis-  
 15 aster assistance programs: Provided further, That the total  
 16 amount of payments received under this heading and appli-  
 17 cable policies of crop insurance under the Federal Crop In-  
 18 surance Act (7 U.S.C. 1501 et seq.) or the Noninsured Crop  
 19 Disaster Assistance Program (NAP) under section 196 of  
 20 the Federal Agriculture Improvement and Reform Act of  
 21 1996 (7 U.S.C. 7333) shall not exceed 90 percent of the loss  
 22 as determined by the Secretary: Provided further, That the  
 23 total amount of payments received under this heading for  
 24 producers who did not obtain a policy or plan of insurance  
 25 for an insurable commodity for the applicable crop year

1 *under the Federal Crop Insurance Act (7 U.S.C. 1501 et*  
2 *seq.) for the crop incurring the losses or did not file the*  
3 *required paperwork and pay the service fee by the applica-*  
4 *ble State filing deadline for a noninsurable commodity for*  
5 *the applicable crop year under NAP for the crop incurring*  
6 *the losses shall not exceed 70 percent of the loss as deter-*  
7 *mined by the Secretary: Provided further, That in the case*  
8 *of a crop under this heading for which the Federal Crop*  
9 *Insurance Corporation offers a revenue insurance policy*  
10 *under section 508 of the Federal Crop Insurance Act (7*  
11 *U.S.C. 1508), the Secretary shall use the greater of the pro-*  
12 *jected price or the harvest price for such crop to determine*  
13 *the expected value of such crop: Provided further, That pro-*  
14 *ducers receiving payments under this heading, as deter-*  
15 *mined by the Secretary, shall be required to purchase crop*  
16 *insurance where crop insurance is available for the next*  
17 *two available crop years, excluding tree insurance policies,*  
18 *and producers receiving payments under this heading shall*  
19 *be required to purchase coverage under NAP where crop in-*  
20 *surance is not available in the next two available crop*  
21 *years, as determined by the Secretary: Provided further,*  
22 *That, not later than 120 days after the end of fiscal year*  
23 *2019, the Secretary shall submit a report to the Congress*  
24 *specifying the type, amount, and method of such assistance*  
25 *by state and territory: Provided further, That such amount*

1 *is designated by the Congress as being for an emergency*  
 2 *requirement pursuant to section 251(b)(2)(A)(i) of the Bal-*  
 3 *anced Budget and Emergency Deficit Control Act of 1985.*

4 *FARM SERVICE AGENCY*

5 *EMERGENCY FOREST RESTORATION PROGRAM*

6 *For an additional amount for the “Emergency Forest*  
 7 *Restoration Program”, for necessary expenses related to the*  
 8 *consequences of Hurricanes Michael and Florence and*  
 9 *wildfires occurring in calendar year 2018, tornadoes and*  
 10 *floods occurring in calendar year 2019, and other natural*  
 11 *disasters, \$480,000,000, to remain available until expended:*  
 12 *Provided, That such amount is designated by the Congress*  
 13 *as being for an emergency requirement pursuant to section*  
 14 *251(b)(2)(A)(i) of the Balanced Budget and Emergency*  
 15 *Deficit Control Act of 1985.*

16 *EMERGENCY CONSERVATION PROGRAM*

17 *For an additional amount for the “Emergency Con-*  
 18 *servation Program”, for necessary expenses related to the*  
 19 *consequences of Hurricanes Michael and Florence and*  
 20 *wildfires occurring in calendar year 2018, tornadoes and*  
 21 *floods occurring in calendar year 2019, and other natural*  
 22 *disasters, \$558,000,000, to remain available until expended:*  
 23 *Provided, That such amount is designated by the Congress*  
 24 *as being for an emergency requirement pursuant to section*

1 *251(b)(2)(A)(i) of the Balanced Budget and Emergency*  
 2 *Deficit Control Act of 1985.*

3 *NATURAL RESOURCES CONSERVATION SERVICE*

4 *WATERSHED AND FLOOD PREVENTION OPERATIONS*

5 *For an additional amount for “Watershed and Flood*  
 6 *Prevention Operations”, for necessary expenses for the*  
 7 *Emergency Watershed Protection Program related to the*  
 8 *consequences of Hurricanes Michael and Florence and*  
 9 *wildfires occurring in calendar year 2018, tornadoes and*  
 10 *floods occurring in calendar year 2019, and other natural*  
 11 *disasters, \$435,000,000, to remain available until expended:*  
 12 *Provided, That such amount is designated by the Congress*  
 13 *as being for an emergency requirement pursuant to section*  
 14 *251(b)(2)(A)(i) of the Balanced Budget and Emergency*  
 15 *Deficit Control Act of 1985.*

16 *RURAL DEVELOPMENT*

17 *RURAL COMMUNITY FACILITIES PROGRAM ACCOUNT*

18 *For an additional amount for the cost of grants for*  
 19 *rural community facilities programs as authorized by sec-*  
 20 *tion 306 and described in section 381E(d)(1) of the Consoli-*  
 21 *dated Farm and Rural Development Act, for necessary ex-*  
 22 *penses related to the consequences of Hurricanes Michael*  
 23 *and Florence and wildfires occurring in calendar year*  
 24 *2018, tornadoes and floods occurring in calendar year 2019,*  
 25 *and other natural disasters, \$150,000,000, to remain avail-*

1 *able until expended: Provided, That sections 381E–H and*  
 2 *381N of the Consolidated Farm and Rural Development Act*  
 3 *are not applicable to the funds made available under this*  
 4 *heading: Provided further, That such amount is designated*  
 5 *by the Congress as being for an emergency requirement pur-*  
 6 *suant to section 251(b)(2)(A)(i) of the Balanced Budget and*  
 7 *Emergency Deficit Control Act of 1985.*

8           **GENERAL PROVISIONS—THIS TITLE**

9           *SEC. 101. In addition to amounts otherwise made*  
 10 *available, out of the funds made available under section 18*  
 11 *of the Food and Nutrition Act of 2008, \$25,200,000 shall*  
 12 *be available for the Secretary to provide a grant to the Com-*  
 13 *monwealth of the Northern Mariana Islands for disaster nu-*  
 14 *trition assistance in response to the Presidentially declared*  
 15 *major disasters and emergencies: Provided, That funds*  
 16 *made available to the Commonwealth of the Northern Mar-*  
 17 *iana Islands under this section shall remain available for*  
 18 *obligation by the Commonwealth until September 30, 2020:*  
 19 *Provided further, That such amount is designated by the*  
 20 *Congress as being for an emergency requirement pursuant*  
 21 *to section 251(b)(2)(A)(i) of the Balanced Budget and*  
 22 *Emergency Deficit Control Act of 1985.*

23           *SEC. 102. For purposes of administering title I of sub-*  
 24 *division 1 of division B of the Bipartisan Budget Act of*  
 25 *2018 (Public Law 115–123), losses to agricultural pro-*

1 *ducers resulting from hurricanes shall also include losses*  
2 *incurred from Tropical Storm Cindy, losses of peach and*  
3 *blueberry crops in calendar year 2017 due to extreme cold,*  
4 *and blueberry productivity losses in calendar year 2018 due*  
5 *to extreme cold and hurricane damage in calendar year*  
6 *2017: Provided, That the amounts provided by this section*  
7 *are designated by the Congress as being for an emergency*  
8 *requirement pursuant to section 251(b)(2)(A)(i) of the Bal-*  
9 *anced Budget and Emergency Deficit Control Act of 1985:*  
10 *Provided further, That amounts repurposed under this sec-*  
11 *tion that were previously designated by the Congress as an*  
12 *emergency requirement pursuant to the Balanced Budget*  
13 *and Emergency Deficit Control Act of 1985 are designated*  
14 *by the Congress as an emergency requirement pursuant to*  
15 *section 251(b)(2)(A)(i) of the Balanced Budget and Emer-*  
16 *gency Deficit Control Act of 1985.*

17       *SEC. 103. (a)(1) Except as provided in paragraph (2),*  
18 *a person or legal entity is not eligible to receive a payment*  
19 *under the Market Facilitation Program established pursu-*  
20 *ant to the Commodity Credit Corporation Charter Act (15*  
21 *U.S.C. 714 et seq.) if the average adjusted gross income of*  
22 *such person or legal entity is greater than \$900,000.*

23       *(2) Paragraph (1) shall not apply to a person or legal*  
24 *entity if at least 75 percent of the adjusted gross income*



1 *of such person or legal entity is derived from farming,*  
 2 *ranching, or forestry related activities.*

3 *(b) In this section, the term “average adjusted gross*  
 4 *income” has the meaning given the term defined in section*  
 5 *760.1502 of title 7 Code of Federal Regulations (as in effect*  
 6 *July 18, 2018).*

7 *(c) The amount provided by this section is designated*  
 8 *by the Congress as being for an emergency requirement pur-*  
 9 *suant to section 251(b)(2)(A)(i) of the Balanced Budget and*  
 10 *Emergency Deficit Control Act of 1985.*

11 *SEC. 104. In addition to other amounts made available*  
 12 *by section 309 of division A of the Additional Supplemental*  
 13 *Appropriations for Disaster Relief Requirements Act, 2017*  
 14 *(Public Law 115–72; 131 Stat. 1229), there is appropriated*  
 15 *to the Secretary, out of any moneys in the Treasury not*  
 16 *otherwise appropriated, for the fiscal year ending Sep-*  
 17 *tember 30, 2019, \$600,000,000 to provide a grant to the*  
 18 *Commonwealth of Puerto Rico for disaster nutrition assist-*  
 19 *ance in response to a major disaster or emergency des-*  
 20 *ignated by the President under the Robert T. Stafford Dis-*  
 21 *aster Relief and Emergency Assistance Act (42 U.S.C. 5121*  
 22 *et seq.): Provided, That the funds made available to the*  
 23 *Commonwealth of Puerto Rico under this section shall re-*  
 24 *main available for obligation by the Commonwealth until*  
 25 *September 30, 2020, and shall be in addition to funds other-*

1 *wise made available: Provided further, That such amount*  
 2 *is designated by the Congress as being for an emergency*  
 3 *requirement pursuant to section 251(b)(2)(A)(i) of the Bal-*  
 4 *anced Budget and Emergency Deficit Control Act of 1985*  
 5 *(2 U.S.C. 901(b)(2)(A)(i)).*

6       *SEC. 105. There is hereby appropriated \$5,000,000, to*  
 7 *remain available until September 30, 2020, for the Sec-*  
 8 *retary of Agriculture to conduct an independent study, in-*  
 9 *cluding a survey of participants, to compare the impact*  
 10 *of the additional benefits provided by section 309 of Public*  
 11 *Law 115–72 to the food insecurity, health status, and well-*  
 12 *being of low-income residents in Puerto Rico without such*  
 13 *additional benefits: Provided, That such amount is des-*  
 14 *ignated by the Congress as being for an emergency require-*  
 15 *ment pursuant to section 251(b)(2)(A)(i) of the Balanced*  
 16 *Budget and Emergency Deficit Control Act of 1985.*

17       *SEC. 106. In addition to amounts otherwise made*  
 18 *available, out of the funds made available under section 18*  
 19 *of the Food and Nutrition Act of 2008, \$18,000,000 shall*  
 20 *be available for the Secretary to provide a grant to Amer-*  
 21 *ican Samoa for disaster nutrition assistance in response*  
 22 *to the presidentially declared major disasters and emer-*  
 23 *gencies: Provided, That funds made available to the terri-*  
 24 *tory under this section shall remain available for obligation*  
 25 *by the territory until September 30, 2020: Provided further,*

1 *That such amount is designated by the Congress as being*  
2 *for an emergency requirement pursuant to section*  
3 *251(b)(2)(A)(i) of the Balanced Budget and Emergency*  
4 *Deficit Control Act of 1985.*

5       *SEC. 107. Beginning not later than the 2020 reinsur-*  
6 *ance year, the Federal Crop Insurance Corporation shall*  
7 *offer coverage under the wholefarm revenue protection in-*  
8 *surance policy (or a successor policy or plan of insurance)*  
9 *for hemp (as defined in section 297A of the Agricultural*  
10 *Marketing Act of 1946 (7 U.S.C. 1639o)): Provided, That*  
11 *such amount is designated by the Congress as being for an*  
12 *emergency requirement pursuant to section 251(b)(2)(A)(i)*  
13 *of the Balanced Budget and Emergency Deficit Control Act*  
14 *of 1985.*

15       *SEC. 108. Notwithstanding any other provision of law,*  
16 *any rural community impacted by major declared disaster*  
17 *DR-4407 may have the governor in the affected state, or*  
18 *the governor's designee, certify the area's population as a*  
19 *rural area with respect to eligibility for loans, grants, and*  
20 *technical assistance under rural development programs*  
21 *funded by the Department of Agriculture until data from*  
22 *the 2020 United States Census is available: Provided, That*  
23 *such amount is designated by the Congress as being for an*  
24 *emergency requirement pursuant to section 251(b)(2)(A)(i)*

 12 *relief, long-term recovery, and restoration of infrastructure*  
 13 *in areas that received a major disaster designation as a*  
 14 *result of Hurricanes Florence, Michael, and Lane, Ty-*  
 15 *phoons Yutu and Mangkhut, and of wildfires, volcanic*  
 16 *eruptions, earthquakes, and other natural disasters occur-*  
 17 *ring in calendar year 2018, and tornadoes and floods occur-*  
 18 *ring in calendar year 2019 under the Robert T. Stafford*  
 19 *Disaster Relief and Emergency Assistance Act (42 U.S.C.*  
 20 *5121 et seq.), \$600,000,000, to remain available until ex-*  
 21 *pended: Provided, That such amount is designated by the*  
 22 *Congress as being for an emergency requirement pursuant*  
 23 *to section 251(b)(2)(A)(i) of the Balanced Budget and*  
 24 *Emergency Deficit Control Act of 1985: Provided further,*  
 25 *That within the amount appropriated, up to 2 percent of*

1 *funds may be transferred to the “Salaries and Expenses”*  
 2 *account for administration and oversight activities: Pro-*  
 3 *vided further, That within the amount appropriated,*  
 4 *\$1,000,000 shall be transferred to the “Office of Inspector*  
 5 *General” account for carrying out investigations and audits*  
 6 *related to the funding provided under this heading.*

 13 *until September 30, 2020, as follows:*

- 14 (1) *\$3,000,000 for repair and replacement of ob-*  
 15 *serving assets, real property, and equipment;*
- 16 (2) *\$11,000,000 for marine debris assessment*  
 17 *and removal;*
- 18 (3) *\$31,570,000 for mapping, charting, and ge-*  
 19 *odesy services;*
- 20 (4) *\$25,000,000 to improve: (a) hurricane inten-*  
 21 *sity forecasting, including through deployment of un-*  
 22 *manned ocean observing platforms and enhanced data*  
 23 *assimilation; (b) flood prediction, forecasting, and*  
 24 *mitigation capabilities; and (c) wildfire prediction,*  
 25 *detection, and forecasting; and*

1           (5) \$50,000,000 for Title IX Fund grants as au-  
2       thorized under section 906(c) of division O of Public  
3       Law 114–113:

4       *Provided, That such amount is designated by the Congress*  
5       *as being for an emergency requirement pursuant to section*  
6       *251(b)(2)(A)(i) of the Balanced Budget and Emergency*  
7       *Deficit Control Act of 1985: Provided further, That the Na-*  
8       *tional Oceanic and Atmospheric Administration shall sub-*  
9       *mit a spending plan to the Committees on Appropriations*  
10      *of the House of Representatives and the Senate for funding*  
11      *provided under subsection (4) of this heading within 45*  
12      *days after the date of enactment of this Act.*

13       *PROCUREMENT, ACQUISITION AND CONSTRUCTION*

14       *For an additional amount for “Procurement, Acquisi-*  
15      *tion and Construction”, \$25,000,000, to remain available*  
16      *until September 30, 2021, for improvements to operational*  
17      *and research weather supercomputing infrastructure and*  
18      *satellite ground services used for hurricane intensity and*  
19      *track prediction; flood prediction, forecasting, and mitiga-*  
20      *tion; and wildfire prediction, detection, and forecasting:*  
21      *Provided, That such amount is designated by the Congress*  
22      *as being for an emergency requirement pursuant to section*  
23      *251(b)(2)(A)(i) of the Balanced Budget and Emergency*  
24      *Deficit Control Act of 1985: Provided further, That the Na-*  
25      *tional Oceanic and Atmospheric Administration shall sub-*

1 *mit a spending plan to the Committees on Appropriations*  
 2 *of the House of Representatives and the Senate within 45*  
 3 *days after the date of enactment of this Act.*

4 *FISHERY DISASTER ASSISTANCE*

5 *For an additional amount for “Fishery Disaster As-*  
 6 *sistance” for necessary expenses associated with the mitiga-*  
 7 *tion of fishery disasters, \$150,000,000, to remain available*  
 8 *until expended: Provided, That funds shall be used for miti-*  
 9 *gating the effects of commercial fishery failures and fishery*  
 10 *resource disasters declared by the Secretary of Commerce,*  
 11 *including those declared by the Secretary to be a direct re-*  
 12 *sult of Hurricanes Florence and Michael and Typhoons*

 14 *is designated by the Congress as being for an emergency*

 24 *the Congress as being for an emergency requirement pursu-*

1 *ant to section 251(b)(2)(A)(i) of the Balanced Budget and*  
 2 *Emergency Deficit Control Act of 1985.*

5 *For an additional amount for “Buildings and Facili-*  
 6 *ties” for necessary expenses related to the consequences of*  
 7 *Hurricanes Florence and Michael and Typhoon Yutu,*  
 8 *\$28,400,000, to remain available until expended: Provided,*  
 9 *That such amount is designated by the Congress as being*  
 10 *for an emergency requirement pursuant to section*  
 11 *251(b)(2)(A)(i) of the Balanced Budget and Emergency*  
 12 *Deficit Control Act of 1985.*

13 *RELATED AGENCIES*

14 *LEGAL SERVICES CORPORATION*

15 *PAYMENT TO THE LEGAL SERVICES CORPORATION*

16 *For an additional amount for “Payment to the Legal*  
 17 *Services Corporation” to carry out the purposes of the Legal*  
 18 *Services Corporation Act by providing for necessary ex-*  
 19 *penses related to the consequences of Hurricanes Florence,*  
 20 *Michael, and Lane, Typhoons Yutu and Mangkhut, cal-*  
 21 *endar year 2018 wildfires, volcanic eruptions, and earth-*  
 22 *quakes, and calendar year 2019 tornadoes and floods,*  
 23 *\$15,000,000: Provided, That such amount is designated by*  
 24 *the Congress as being for an emergency requirement pursu-*  
 25 *ant to section 251(b)(2)(A)(i) of the Balanced Budget and*



1 *Emergency Deficit Control Act of 1985: Provided further,*  
 2 *That none of the funds appropriated in this Act to the Legal*

10 *in this Act shall remain available for obligation beyond the*  
11 *current fiscal year unless expressly so provided herein.*

12 *SEC. 1203. Unless otherwise provided for by this Act,*  
13 *the additional amounts appropriated by this Act to appro-*  
14 *priations accounts shall be available under the authorities*  
15 *and conditions applicable to such appropriations accounts*  
16 *for fiscal year 2019.*

17 *SEC. 1204. Each amount designated in this Act by the*  
18 *Congress as being for an emergency requirement pursuant*  
19 *to section 251(b)(2)(A)(i) of the Balanced Budget and*  
20 *Emergency Deficit Control Act of 1985 shall be available*  
21 *(or rescinded or transferred, if applicable) only if the Presi-*  
22 *dent subsequently so designates all such amounts and trans-*  
23 *mits such designations to the Congress.*

24 *SEC. 1205. For purposes of this Act, the consequences*  
25 *or impacts of any hurricane shall include damages caused*

1 *by the storm at any time during the entirety of its duration*  
2 *as a cyclone, as defined by the National Hurricane Center.*

3 *SEC. 1206. Any amount appropriated by this Act, des-*  
4 *ignated by the Congress as an emergency requirement pur-*  
5 *suant to section 251(b)(2)(A)(i) of the Balanced Budget and*  
6 *Emergency Deficit Control Act of 1985 and subsequently*  
7 *so designated by the President, and transferred pursuant*  
8 *to transfer authorities provided by this Act shall retain such*  
9 *designation.*

10 *SEC. 1207. (a) Section 1309(a) of the National Flood*  
11 *Insurance Act of 1968 (42 U.S.C. 4016(a)) is amended by*  
12 *striking “May 31, 2019” and inserting “September 30,*  
13 *2019”.*

14 *(b) Section 1319 of the National Flood Insurance Act*  
15 *of 1968 (42 U.S.C. 4026) is amended by striking “May 31,*  
16 *2019” and inserting “September 30, 2019”.*

17 *(c) If this Act is enacted after May 31, 2019, the*  
18 *amendments made by subsections (a) and (b) shall take ef-*  
19 *fect as if enacted on May 31, 2019.*

20 *This Act may be cited as the “Additional Supple-*  
21 *mental Appropriations for Disaster Relief Act, 2019”.*
