A BILL

To direct the Comptroller General of the United States to conduct an assessment of the responsibilities, workload, and vacancy rates of Department of Veterans Affairs suicide prevention coordinators, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Support for Suicide
5 Prevention Coordinators Act”.

6 **SEC. 2. COMPTROLLER GENERAL ASSESSMENT OF RESPON-**
7 **SIBILITIES, WORKLOAD, AND VACANCY**
8 **RATES OF DEPARTMENT OF VETERANS AF-**
9 **FAIRS SUICIDE PREVENTION COORDINA-**
10 **TORS.**

11 (a) ASSESSMENT REQUIRED.—The Comptroller Gen-
12 eral of the United States shall conduct an assessment of
13 the responsibilities, workload, training, and vacancy rates
14 of Department of Veterans Affairs suicide prevention coor-
15 dinators. Such assessment shall include a determination
16 of—

17 (1) the extent to which the use and staffing of
18 suicide prevention coordinators varies between De-
19 partment facilities; and

20 (2) the extent to which the Secretary provides
21 oversight of suicide prevention coordinators.

22 (b) REPORT TO CONGRESS.—Not later than one year
23 after the date of the enactment of this Act, the Comp-
24 troller General shall submit to the Committees on Vet-
25 erans’ Affairs of the Senate and House of Representatives

- 1 a report containing the findings of the assessment re-
- 2 quired by subsection (a).
