A BILL

To amend chapter 36 of title 44, United States Code, to make certain changes relating to electronic Government services, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Federal CIO Author-
5 ization Act of 2019”.

6 **SEC. 2. CHANGES RELATING TO ELECTRONIC GOVERN-**
7 **MENT SERVICES.**

8 (a) CHANGE OF CERTAIN NAMES IN CHAPTER 36 OF
9 TITLE 44.—

1 (1) DEFINITIONS.—Section 3601 of title 44,
2 United States Code, is amended—

3 (A) by striking paragraph (1);

4 (B) by redesignating paragraphs (2)
5 through (8) as paragraphs (1) through (7), re-
6 spectively; and

7 (C) in paragraph (4), as so redesignated,
8 by striking “E–Government Fund” and insert-
9 ing “Federal IT Fund”.

10 (2) OFFICE OF ELECTRONIC GOVERNMENT.—
11 Section 3602 of title 44, United States Code, is
12 amended—

13 (A) in the heading, by striking “**OFFICE**
14 **OF ELECTRONIC GOVERNMENT**” and insert-
15 ing “**OFFICE OF THE FEDERAL CHIEF IN-**
16 **FORMATION OFFICER**”;

17 (B) in subsection (a), by striking “Office
18 of Electronic Government” and inserting “Of-
19 fice of the Federal Chief Information Officer”;

20 (C) in subsection (b)—

21 (i) by striking “an Administrator”
22 and inserting “a Federal Chief Information
23 Officer”; and

1 (ii) by inserting before the period at
2 the end the following: “and who shall re-
3 port directly to the Director”;

4 (D) in subsection (c), by striking “The Ad-
5 ministrator” and inserting “The Federal Chief
6 Information Officer”;

7 (E) in subsection (d), by striking “The Ad-
8 ministrator” and inserting “The Federal Chief
9 Information Officer”;

10 (F) in subsection (e), by striking “The Ad-
11 ministrator” and inserting “The Federal Chief
12 Information Officer”;

13 (G) in subsection (f)—

14 (i) in the matter preceding paragraph
15 (1), by striking “the Administrator” and
16 inserting “the Federal Chief Information
17 Officer”;

18 (ii) in paragraph (5), by striking “E-
19 Government Fund” and inserting “Federal
20 IT Fund”;

21 (iii) in paragraph (16), by striking
22 “the Office of Electronic Government” and
23 inserting “the Office of the Federal Chief
24 Information Officer”; and

1 (iv) by adding at the end the following
2 new paragraph:

3 “(18) Oversee the Federal Chief Information
4 Security Officer.”; and

5 (H) in subsection (g), by striking “the Of-
6 fice of Electronic Government” and inserting
7 “the Office of the Federal Chief Information
8 Officer”.

9 (3) CHIEF INFORMATION OFFICERS COUNCIL.—
10 Section 3603 of title 44, United States Code, is
11 amended—

12 (A) in subsection (b)(2), by striking “The
13 Administrator of the Office of Electronic Gov-
14 ernment” and inserting “The Federal Chief In-
15 formation Officer”;

16 (B) in subsection (c)(1), by striking “The
17 Administrator of the Office of Electronic Gov-
18 ernment” and inserting “The Federal Chief In-
19 formation Officer”; and

20 (C) in subsection (f)—

21 (i) in paragraph (3), by striking “the
22 Administrator” and inserting “the Federal
23 Chief Information Officer”; and

1 (ii) in paragraph (5), by striking “the
2 Administrator” and inserting “the Federal
3 Chief Information Officer”.

4 (4) E-GOVERNMENT FUND.—Section 3604 of
5 title 44, United States Code, is amended—

6 (A) in the heading, by striking “**E-GOV-**
7 **ERNMENT FUND**” and inserting “**FEDERAL**
8 **IT FUND**”;

9 (B) in subsection (a)—

10 (i) in paragraph (1), by striking “E-
11 Government Fund” and inserting “Federal
12 IT Fund”; and

13 (ii) in paragraph (2), by striking “the
14 Administrator of the Office of Electronic
15 Government” and inserting “the Federal
16 Chief Information Officer”;

17 (C) in subsection (b), by striking “Admin-
18 istrator” each place it appears and inserting
19 “Federal Chief Information Officer”; and

20 (D) in subsection (c), by striking “the Ad-
21 ministrator” and inserting “the Federal Chief
22 Information Officer”.

23 (5) PROGRAM TO ENCOURAGE INNOVATIVE SO-
24 LUTIONS TO ENHANCE ELECTRONIC GOVERNMENT

1 SERVICES AND PROCESSES.—Section 3605 of title
2 44, United States Code, is amended—

3 (A) in subsection (a), by striking “The Ad-
4 ministrator” and inserting “The Federal Chief
5 Information Officer”;

6 (B) in subsection (b), by striking “, the
7 Administrator,” and inserting “, the Federal
8 Chief Information Officer,”; and

9 (C) in subsection (c)—

10 (i) in paragraph (1)—

11 (I) by striking “The Adminis-
12 trator” and inserting “The Federal
13 Chief Information Officer”; and

14 (II) by striking “proposals sub-
15 mitted to the Administrator” and in-
16 serting “proposals submitted to the
17 Federal Chief Information Officer”;

18 (ii) in paragraph (2)(B), by striking
19 “the Administrator” and inserting “the
20 Federal Chief Information Officer”; and

21 (iii) in paragraph (4)—

22 (I) by striking “the Adminis-
23 trator” and inserting “the Federal
24 Chief Information Officer”; and

1 (II) by striking “E–Government
2 Fund” and inserting “Federal IT
3 Fund”.

4 (6) E-GOVERNMENT REPORT.—Section 3606 of
5 title 44, United States Code, is amended—

6 (A) in the heading, by striking “**E–Gov-**
7 **ernment**” and inserting “**Annual**”; and

8 (B) in subsection (a), by striking “an E–
9 Government status report to the Committee on
10 Governmental Affairs of the Senate and the
11 Committee on Government Reform of the
12 House of Representatives” and inserting “a re-
13 port to the Committee on Homeland Security
14 and Governmental Affairs of the Senate and the
15 Committee on Oversight and Government Re-
16 form of the House of Representatives”.

17 (7) TREATMENT OF INCUMBENT.—The indi-
18 vidual serving as the Administrator of the Office of
19 Electronic Government under section 3602 of title
20 44, United States Code, as of the date of the enact-
21 ment of this Act, may continue to serve as the Fed-
22 eral Chief Information Officer commencing as of
23 that date, without further appointment under such
24 section.

1 (8) REFERENCES.—Any reference to the Ad-
2 ministrator of the Office of Electronic Government
3 in any law, regulation, document, record, or other
4 paper of the United States shall be deemed to be a
5 reference to the Federal Chief Information Officer.

1 Office of the Federal Chief Information
2 Officer”.

3 (F) PROGRAM MANAGEMENT IMPROVE-
4 MENT OFFICERS AND PROGRAM MANAGEMENT
5 POLICY COUNCIL.—Section 1126(b)(3)(A)(i)(II)
6 of title 31, United States Code, is amended by
7 striking “The Administrator of the Office of
8 Electronic Government” and inserting “The
9 Federal Chief Information Officer”.

10 (G) ELECTRONIC GOVERNMENT AND IN-
11 FORMATION TECHNOLOGIES.—Section 305 of
12 title 40, United States Code, is amended by
13 striking “the Administrator of the Office of
14 Electronic Government” and inserting “the
15 Federal Chief Information Officer”.

16 (H) CAPITAL PLANNING AND INVESTMENT
17 CONTROL.—Section 11302(c)(4) of title 40,
18 United States Code, is amended by striking
19 “the Administrator of the Office of Electronic
20 Government” each place it appears and insert-
21 ing “the Federal Chief Information Officer”.

22 (I) RESOURCES, PLANNING, AND PORT-
23 FOLIO MANAGEMENT.—Section 11319(d) of
24 title 40, United States Code, is amended by
25 striking “Administrator of the Office of Elec-

1 tronic Government” each place it appears and
2 inserting “Federal Chief Information Officer”.

3 (J) E-GOVERNMENT ACT OF 2002.—Sec-
4 tion 207(f)(3)(C) of the E-Government Act of
5 2002 (Public Law 107–347; 44 U.S.C. 3501
6 note) is amended by striking “the Adminis-
7 trator of the Office of Electronic Government”
8 and inserting “the Federal Chief Information
9 Officer”.

10 (b) ESTABLISHMENT OF CHIEF INFORMATION SECUR-
11 ITY OFFICER AND REPORT ON IT EXPENDITURES.—

12 (1) IN GENERAL.—Chapter 36 of title 44,
13 United States Code, is further amended by adding
14 at the end the following new sections:

15 **“§ 3607. Federal Chief Information Security Officer**

16 “(a) ESTABLISHMENT.—There is established in the
17 Office of Management and Budget a Federal Chief Infor-
18 mation Security Officer, who shall—

19 “(1) be appointed by the President;

20 “(2) be within the Office of the Federal Chief
21 Information Officer; and

22 “(3) report directly to the Federal Chief Infor-
23 mation Officer.

24 “(b) DUTIES.—The Federal Chief Information Secu-
25 rity Officer shall—

1 and programs of agencies, if such information would
2 otherwise be subject to public disclosure under sec-
3 tion 552 of title 5, commonly known as the Freedom
4 of Information Act.”.

5 (2) CLERICAL AMENDMENT.—The table of sec-
6 tions for chapter 36 of title 44, United States Code,
7 is further amended by adding at the end the fol-
8 lowing new item:

“3607. Federal Chief Information Security Officer.

“3608. Technology investment planning and oversight process.”.

9 (3) DEADLINE.—Not later than 180 days after
10 the date of the enactment of this Act, the Director
11 shall establish the process described in section
12 3608(b) of title 44, United States Code, as added by
13 paragraph (1).

14 (4) REPORT TO CONGRESS.—Not later than
15 120 days after the date of the enactment of this Act,
16 the Federal Chief Information Officer shall submit
17 to the Committee on Oversight and Government Re-
18 form of the House of Representatives and the Com-
19 mittee on Homeland Security and Governmental Af-
20 fairs of the Senate a report on the status of estab-
21 lishing the process described in section 3608(b) of
22 title 44, United States Code, as added by paragraph
23 (1).

1 **SEC. 3. PROPOSAL RELATED TO SHARED SERVICES.**

2 Not later than 180 days after the date of the enact-
3 ment of this Act, the Federal Chief Information Officer
4 shall submit to Congress a proposal for consolidating in-
5 formation technology across the Federal Government, es-
6 pecially among Federal agencies not referred to under sec-
7 tion 901(b) of title 31, United States Code, and increasing
8 the use of shared services, including any recommendations
9 for legislative changes that may be necessary to effect the
10 proposal.

11 **SEC. 4. NO ADDITIONAL FUNDS AUTHORIZED.**

12 No additional funds are authorized to be appro-
13 priated to carry out this Act and the amendments made
14 by this Act. This Act and the amendments made by this
15 Act shall be carried out using amounts otherwise author-
16 ized.
