## A BILL

To amend title X of the Public Health Service Act to prohibit family planning grants from being awarded to any entity that performs abortions, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

## 1 SECTION 1. SHORT TITLE.

- This Act may be cited as the "Title X Abortion Pro-
- 3 vider Prohibition Act".
- 4 SEC. 2. PROHIBITION ON ABORTION.
- 5 Title X of the Public Health Service Act (42 U.S.C.
- 6 300 et seq.) is amended by adding at the end the fol-
- 7 lowing:
- 8 "SEC. 1009. ADDITIONAL PROHIBITION REGARDING ABOR-
- 9 TION.
- 10 "(a) Prohibition.—The Secretary shall not provide
- 11 any assistance under this title to an entity unless the enti-
- 12 ty certifies that, during the period of such assistance, the
- 13 entity will not perform, and will not provide any funds
- 14 to any other entity that performs, an abortion.
- 15 "(b) Exception.—Subsection (a) does not apply
- 16 with respect to an abortion where—
- 17 "(1) the pregnancy is the result of rape or in-
- 18 cest; or
- 19 "(2) a physician certifies that the woman suf-
- fers from a physical disorder, physical injury, or
- 21 physical illness that would place the woman in dan-
- ger of death unless an abortion is performed, includ-
- ing a life-threatening physical condition caused by or
- arising from the pregnancy itself.
