## AN ACT

To amend title 38, United States Code, to clarify presumptions relating to the exposure of certain veterans who served in the vicinity of the Republic of Vietnam, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Blue Water Navy Viet-  
3 nam Veterans Act of 2019”.

4 **SEC. 2. CLARIFICATION OF PRESUMPTIONS OF EXPOSURE**  
5 **FOR VETERANS WHO SERVED IN VICINITY OF**  
6 **REPUBLIC OF VIETNAM.**

7 (a) IN GENERAL.—Chapter 11 of title 38, United  
8 States Code, is amended by inserting after section 1116  
9 the following new section:

10 **“§ 1116A. Presumptions of service connection for vet-**  
11 **erans who served offshore of the Repub-**  
12 **lic of Vietnam**

13 “(a) SERVICE CONNECTION.—For the purposes of  
14 section 1110 of this title, and subject to section 1113 of  
15 this title, a disease covered by section 1116 of this title  
16 becoming manifest as specified in that section in a veteran  
17 who, during active military, naval, or air service, served  
18 offshore of the Republic of Vietnam during the period be-  
19 ginning on January 9, 1962, and ending on May 7, 1975,  
20 shall be considered to have been incurred in or aggravated  
21 by such service, notwithstanding that there is no record  
22 of evidence of such disease during the period of such serv-  
23 ice.

24 “(b) EXPOSURE.—A veteran who, during active mili-  
25 tary, naval, or air service, served offshore of the Republic  
26 of Vietnam during the period beginning on January 9,

1 1962, and ending on May 7, 1975, shall be presumed to  
2 have been exposed during such service to an herbicide  
3 agent unless there is affirmative evidence to establish that  
4 the veteran was not exposed to any such agent during that  
5 service.

6 “(c) EFFECTIVE DATE OF AWARD.—(1) Except as  
7 provided by paragraph (2), the effective date of an award  
8 under this section shall be determined in accordance with  
9 section 5110 of this title.

10 “(2)(A) Notwithstanding subsection (g) of section  
11 5110 of this title, the Secretary shall determine the effec-  
12 tive date of an award based on a claim under this section  
13 for an individual described in subparagraph (B) by treat-  
14 ing the date on which the individual filed the prior claim  
15 specified in clause (i) of such subparagraph as the date  
16 on which the individual filed the claim so awarded under  
17 this section.

18 “(B) An individual described in this subparagraph is  
19 a veteran, or a survivor of a veteran, who meets the fol-  
20 lowing criteria:

21 “(i) The veteran or survivor submitted a claim  
22 for disability compensation on or after September  
23 25, 1985, and before January 1, 2020, for a disease  
24 covered by this section, and the claim was denied by  
25 reason of the claim not establishing that the disease

1 was incurred or aggravated by the service of the vet-  
 2 eran.

3 “(ii) The veteran or survivor submits a claim  
 4 for disability compensation on or after January 1,  
 5 2020, for the same condition covered by the prior  
 6 claim under clause (i), and the claim is approved  
 7 pursuant to this section.

8 “(d) DETERMINATION OF OFFSHORE.—Notwith-  
 9 standing any other provision of law, for purposes of this  
 10 section, the Secretary shall treat a location as being off-  
 11 shore of Vietnam if the location is not more than 12 nau-  
 12 tical miles seaward of a line commencing on the south-  
 13 western demarcation line of the waters of Vietnam and  
 14 Cambodia and intersecting the following points:

1 “(e) HERBICIDE AGENT.—In this section, the term  
2 ‘herbicide agent’ has the meaning given that term in sec-  
3 tion 1116(a)(3) of this title.”.

4 (b) CLERICAL AMENDMENT.—The table of sections  
5 at the beginning of such chapter is amended by inserting  
6 after the item relating to section 1116 the following new  
7 item:

“1116A. Presumptions of service connection for veterans who served offshore of  
the Republic of Vietnam.”.

8 (c) IMPLEMENTATION.—

9 (1) GUIDANCE.—Notwithstanding section 501  
10 of such title, the Secretary of Veterans Affairs may  
11 issue guidance to implement section 1116A of title  
12 38, United States Code, as added by subsection (a),  
13 before prescribing new regulations under such sec-  
14 tion.

15 (2) UPDATES.—(A) Not later than 120 days  
16 after the date of the enactment of this Act, the Sec-  
17 retary shall submit a report to the Committees on  
18 Veterans’ Affairs of the House of Representatives  
19 and the Senate regarding the plans of the Sec-  
20 retary—

21 (i) to conduct outreach under subsection  
22 (d); and

1 (ii) to respond to inquiries from veterans  
2 regarding claims for disability compensation  
3 under section 1116A of title 38, United States  
4 Code, as added by subsection (a) of this section.

5 (B) On a quarterly basis during the period be-  
6 ginning on the date of the enactment of this Act and  
7 ending on the date on which regulations are pre-  
8 scribed to carry out such section 1116A, the Sec-  
9 retary shall submit to the Committees on Veterans'  
10 Affairs of the House of Representatives and the Sen-  
11 ate updates on the status of such regulations.

12 (3) PENDING CASES.—

13 (A) AUTHORITY TO STAY.—The Secretary  
14 may stay a claim described in subparagraph  
15 (B) until the date on which the Secretary com-  
16 mences the implementation of such section  
17 1116A.

18 (B) CLAIMS DESCRIBED.—A claim de-  
19 scribed in this subparagraph is a claim for dis-  
20 ability compensation—

21 (i) relating to the service and diseases  
22 covered by such section 1116A; and

23 (ii) that is pending at the Veterans  
24 Benefits Administration or the Board of  
25 Veterans' Appeals on or after the date of

1           the enactment of this Act and before the  
2           date on which the Secretary commences  
3           the implementation of such section 1116A.

4       (d) OUTREACH.—

5           (1) REQUIREMENT.—The Secretary of Veterans  
6       Affairs shall conduct outreach to inform veterans de-  
7       scribed in paragraph (2) of the ability to submit a  
8       claim for disability compensation under section  
9       1116A of title 38, United States Code, as added by  
10      subsection (a). Such outreach shall include the fol-  
11      lowing:

12           (A) The Secretary shall publish on the  
13      website of the Department a notice that a vet-  
14      erans described in paragraph (2) may submit or  
15      resubmit a claim for disability compensation  
16      under such section 1116A.

17           (B) The Secretary shall notify in writing  
18      the veteran service organization community of  
19      the ability of veterans described in paragraph  
20      (2) to submit or resubmit claims for disability  
21      compensation under such section 1116A.

22           (2) VETERAN DESCRIBED.—A veteran described  
23      in this paragraph is a veteran who, during active  
24      military, naval, or air service, served offshore of the

1 Republic of Vietnam during the period beginning on  
2 January 9, 1962, and ending on May 7, 1975.

3 (e) REPORTS.—Not later than January 1, 2021, and  
4 annually thereafter for 2 years, the Secretary of Veterans  
5 Affairs shall submit to the Committees on Veterans' Af-  
6 fairs of the House of Representatives and the Senate a  
7 report regarding claims for disability compensation under  
8 section 1116A of title 38, United States Code, as added  
9 by subsection (a). Each report shall include, with respect  
10 to the calendar year preceding the report, disaggregated  
11 by the regional offices of the Department of Veterans Af-  
12 fairs, the following:

13 (1) The number of claims filed under such sec-  
14 tion.

15 (2) The number of such claims granted.

16 (3) The number of such claims denied.

17 (f) HEALTH CARE.—Section 1710(e)(4) of title 38,  
18 United States Code, is amended by inserting “(including  
19 offshore of such Republic as described in section 1116A(d)  
20 of this title)” after “served on active duty in the Republic  
21 of Vietnam”.

22 (g) EFFECTIVE DATE.—The amendments made by  
23 this section shall take effect on January 1, 2020.

1 **SEC. 3. PRESUMPTION OF HERBICIDE EXPOSURE FOR CER-**  
2 **TAIN VETERANS WHO SERVED IN KOREA.**

3 (a) IN GENERAL.—Chapter 11 of title 38, United  
4 States Code, is amended by inserting after section 1116A,  
5 as added by section 2, the following new section:

6 **“§ 1116B. Presumption of herbicide exposure for cer-**  
7 **tain veterans who served in Korea**

8 “(a) PRESUMPTION OF SERVICE-CONNECTION.—(1)  
9 For the purposes of section 1110 of this title, and subject  
10 to section 1113 of this title, a disease specified in sub-  
11 section (b) that becomes manifest as specified in that sub-  
12 section in a veteran described in paragraph (2) shall be  
13 considered to have been incurred or aggravated in the line  
14 of duty in the active military, naval, or air service, not-  
15 withstanding that there is no record of evidence of such  
16 disease during the period of such service.

17 “(2) A veteran described in this paragraph is a vet-  
18 eran who, during active military, naval, or air service,  
19 served in or near the Korean Demilitarized Zone (DMZ),  
20 during the period beginning on September 1, 1967, and  
21 ending on August 31, 1971.

22 “(b) DISEASES.—A disease specified in this sub-  
23 section is—

24 “(1) a disease specified in paragraph (2) of  
25 subsection (a) of section 1116 of this title that be-  
26 comes manifest as specified in that paragraph; or

1 “(2) any additional disease that—

2 “(A) the Secretary determines in regula-  
3 tions warrants a presumption of service-con-  
4 tion by reason of having positive association  
5 with exposure to an herbicide agent; and

6 “(B) becomes manifest within any period  
7 prescribed in such regulations.

8 “(c) HERBICIDE AGENT.—For purposes of this sec-  
9 tion, the term ‘herbicide agent’ has the meaning given  
10 such term in section 1821(d) of this title.”.

11 (b) CLERICAL AMENDMENT.—The table of sections  
12 at the beginning of such chapter is amended by inserting  
13 after the item relating to section 1116A, as added by sec-  
14 tion 2, the following new item:

“1116B. Presumption of herbicide exposure for certain veterans who served in  
Korea.”.

15 (c) IMPLEMENTATION.—

16 (1) GUIDANCE.—Notwithstanding section 501  
17 of such title, the Secretary of Veterans Affairs may  
18 issue guidance to implement section 1116B of title  
19 38, United States Code, as added by subsection (a),  
20 before prescribing new regulations under such sec-  
21 tion.

22 (2) UPDATES.—(A) Not later than 120 days  
23 after the date of the enactment of this Act, the Sec-  
24 retary shall submit a report to the Committees on

1 Veterans' Affairs of the House of Representatives  
2 and the Senate regarding the plans of the Secretary  
3 to respond to inquiries from veterans regarding  
4 claims for disability compensation under section  
5 1116B of title 38, United States Code, as added by  
6 subsection (a) of this section.

7 (B) On a quarterly basis during the period be-  
8 ginning on the date of the enactment of this Act and  
9 ending on the date on which regulations are pre-  
10 scribed to carry out such section 1116B, the Sec-  
11 retary shall submit to the Committees on Veterans'  
12 Affairs of the House of Representatives and the Sen-  
13 ate updates on the status of such regulations.

14 (3) PENDING CASES.—

15 (A) AUTHORITY TO STAY.—The Secretary  
16 may stay a claim described in subparagraph  
17 (B) until the date on which the Secretary com-  
18 mences the implementation of section 1116B of  
19 title 38, United States Code, as added by sub-  
20 section (a).

21 (B) CLAIMS DESCRIBED.—A claim de-  
22 scribed in this subparagraph is a claim for dis-  
23 ability compensation—

24 (i) relating to the service and diseases  
25 covered by such section 1116B; and

1 (ii) that is pending at the Veterans  
2 Benefits Administration or the Board of  
3 Veterans' Appeals on or after the date of  
4 the enactment of this Act and before the  
5 date on which the Secretary commences  
6 the implementation of such section 1116B.

7 (d) EFFECTIVE DATE.—The amendments made by  
8 this section shall take effect on January 1, 2020.

9 **SEC. 4. BENEFITS FOR CHILDREN OF CERTAIN THAILAND**  
10 **SERVICE VETERANS BORN WITH SPINA**  
11 **BIFIDA.**

12 (a) IN GENERAL.—Subchapter III of chapter 18 of  
13 title 38, United States Code, is amended by adding at the  
14 end the following new section:

15 **“§ 1822. Benefits for children of certain Thailand**  
16 **service veterans born with spina bifida**

17 “(a) BENEFITS AUTHORIZED.—The Secretary may  
18 provide to any child of a veteran of covered service in  
19 Thailand who is suffering from spina bifida the health  
20 care, vocational training and rehabilitation, and monetary  
21 allowance required to be paid to a child of a Vietnam vet-  
22 eran who is suffering from spina bifida under subchapter  
23 I of this chapter as if such child of a veteran of covered  
24 service in Thailand were a child of a Vietnam veteran who  
25 is suffering from spina bifida under such subchapter.

1       “(b) SPINA BIFIDA CONDITIONS COVERED.—This  
2 section applies with respect to all forms and manifesta-  
3 tions of spina bifida, except spina bifida occulta.

4       “(c) VETERAN OF COVERED SERVICE IN THAI-  
5 LAND.—For purposes of this section, a veteran of covered  
6 service in Thailand is any individual, without regard to  
7 the characterization of that individual’s service, who—

8               “(1) served in the active military, naval, or air  
9 service in Thailand, as determined by the Secretary  
10 in consultation with the Secretary of Defense, dur-  
11 ing the period beginning on January 9, 1962, and  
12 ending on May 7, 1975; and

13               “(2) is determined by the Secretary, in con-  
14 sultation with the Secretary of Defense, to have been  
15 exposed to a herbicide agent during such service in  
16 Thailand.

17       “(d) HERBICIDE AGENT.—For purposes of this sec-  
18 tion, the term ‘herbicide agent’ means a chemical in a her-  
19 bicide used in support of United States and allied military  
20 operations in Thailand, as determined by the Secretary in  
21 consultation with the Secretary of Defense, during the pe-  
22 riod beginning on January 9, 1962, and ending on May  
23 7, 1975.”.

24       (b) CONFORMING AMENDMENT TO DEFINITION OF  
25 “CHILD”.—Section 1831(1) of such title is amended—

1 (1) in subparagraph (B)—

2 (A) by striking “subchapter III of this  
3 chapter” and inserting “section 1821 of this  
4 title”; and

5 (B) in clause (i), by striking “section 1821  
6 of this title” and inserting “that section”; and

7 (2) by adding at the end the following new sub-  
8 paragraph:

9 “(C) For purposes of section 1822 of this  
10 title, an individual, regardless of age or marital  
11 status, who—

12 “(i) is the natural child of a veteran  
13 of covered service in Thailand (as deter-  
14 mined for purposes of that section); and

15 “(ii) was conceived after the date on  
16 which that veteran first entered service de-  
17 scribed in subsection (e) of that section.”.

18 (c) CLERICAL AMENDMENTS.—

19 (1) SUBCHAPTER HEADING.—The heading for  
20 subchapter III of chapter 18 of such title is amend-  
21 ed by inserting “AND THAILAND” after  
22 “KOREA”.

23 (2) TABLE OF SECTIONS.—The table of sections  
24 at the beginning of chapter 18 of such title is  
25 amended—

1 (A) by striking the item relating to sub-  
2 chapter III and inserting the following new  
3 item:

“SUBCHAPTER III—CHILDREN OF CERTAIN KOREA AND THAILAND SERVICE  
VETERANS BORN WITH SPINA BIFIDA”;

4 and

5 (B) by inserting after the item relating to  
6 section 1821 the following new item:

“1822. Benefits for children of certain Thailand service veterans born with spina  
bifida.”.

7 (d) IMPLEMENTATION.—

8 (1) GUIDANCE.—Notwithstanding section 501  
9 of such title, the Secretary of Veterans Affairs may  
10 issue guidance to implement section 1822 of title 38,  
11 United States Code, as added by subsection (a), be-  
12 fore prescribing new regulations under such section.

13 (2) UPDATES.—(A) Not later than 120 days  
14 after the date of the enactment of this Act, the Sec-  
15 retary shall submit a report to the Committees on  
16 Veterans’ Affairs of the House of Representatives  
17 and the Senate regarding the plans of the Secretary  
18 to respond to inquiries from veterans regarding  
19 claims for disability compensation under section  
20 1822 of title 38, United States Code, as added by  
21 subsection (a) of this section.

22 (B) On a quarterly basis during the period be-  
23 ginning on the date of the enactment of this Act and

1 ending on the date on which regulations are pre-  
2 scribed to carry out such section 1822, the Secretary  
3 shall submit to the Committees on Veterans' Affairs  
4 of the House of Representatives and the Senate up-  
5 dates on the status of such regulations.

6 (3) PENDING CASES.—

7 (A) AUTHORITY TO STAY.—The Secretary  
8 may stay a claim described in subparagraph  
9 (B) until the date on which the Secretary com-  
10 mences the implementation of section 1822 of  
11 title 38, United States Code, as added by sub-  
12 section (a).

13 (B) CLAIMS DESCRIBED.—A claim de-  
14 scribed in this subparagraph is a claim for ben-  
15 efits—

16 (i) relating to the spina bifida and  
17 service covered by such section 1822; and

18 (ii) that is pending at the Veterans  
19 Benefits Administration or the Board of  
20 Veterans' Appeals on or after the date of  
21 the enactment of this Act and before the  
22 date on which the Secretary commences  
23 the implementation of such section 1822.

24 (e) REPORT.—Not later than 180 days after the date  
25 of the enactment of this Act, the Secretary of Veterans

1 Affairs, in consultation with the Secretary of Defense,  
2 shall submit to the Committees on Veterans' Affairs of  
3 the House of Representatives and the Senate a report  
4 identifying—

5           (1) the military installations of the United  
6 States located in Thailand during the period begin-  
7 ning on January 9, 1962, and ending on May 7,  
8 1975, at which an herbicide agent (as defined in sec-  
9 tion 1822 of title 38, United States Code, as added  
10 by subsection (a)) was actively used; and

11           (2) the period of such use.

12           (f) EFFECTIVE DATE.—The amendments made by  
13 this section shall take effect on January 1, 2020.

14 **SEC. 5. UPDATED REPORT ON CERTAIN GULF WAR ILLNESS**  
15 **STUDY.**

16           Not later than 180 days after the date of the enact-  
17 ment of this Act, the Secretary of Veterans Affairs shall  
18 submit to the Committees on Veterans' Affairs of the  
19 House of Representatives and the Senate an updated re-  
20 port on the findings, as of the date of the updated report,  
21 of the Follow-up Study of a National Cohort of Gulf War  
22 and Gulf Era Veterans under the epidemiology program  
23 of the Department of Veterans Affairs.

1 **SEC. 6. LOANS GUARANTEED UNDER HOME LOAN PRO-**  
2 **GRAM OF DEPARTMENT OF VETERANS AF-**  
3 **FAIRS.**

4 (a) ADJUSTMENT OF LOAN LIMIT.—

5 (1) IN GENERAL.—Section 3703(a)(1) of title  
6 38, United States Code, is amended—

7 (A) in subparagraph (A)—

8 (i) in clause (i)(IV), by striking “the  
9 lesser of the maximum guaranty amount  
10 (as defined in subparagraph (C)) or”; and

11 (ii) in clause (ii), by striking “sub-  
12 subparagraph (B) of this paragraph” and in-  
13 serting “subparagraph (B) or (C)”;

14 (B) in subparagraph (B)—

15 (i) by striking “The maximum” and  
16 inserting “With respect to loans described  
17 in subclauses (I), (II), or (III) of subpara-  
18 graph (A)(i), the maximum”; and

19 (ii) by striking “or in the case” and  
20 all that follows through “subparagraph  
21 (C),”; and

22 (C) by striking subparagraph (C) and in-  
23 serting the following new subparagraph (C):

24 “(C)(i) With respect to loans described in subclause  
25 (IV) of subparagraph (A)(i) made to a veteran not covered  
26 by clause (ii), the maximum amount of guaranty entitle-

1 ment available to the veteran shall be 25 percent of the  
2 loan.

3 “(ii) With respect to loans described in subclause  
4 (IV) of subparagraph (A)(i) made to a covered veteran,  
5 the maximum amount of guaranty entitlement available  
6 to the veteran shall be 25 percent of the Freddie Mac con-  
7 forming loan limit, reduced by the amount of entitlement  
8 previously used by the veteran under this chapter and not  
9 restored as a result of the exclusion in section 3702(b)  
10 of this title.

11 “(iii) In this subparagraph:

12 “(I) The term ‘covered veteran’ means a vet-  
13 eran who has previously used entitlement under this  
14 chapter and for whom the full amount of entitlement  
15 so used has not been restored as a result of the ex-  
16 clusion in section 3702(b) of this title.

17 “(II) The term ‘Freddie Mac conforming loan  
18 limit’ means the limit determined under section  
19 305(a)(2) of the Federal Home Loan Mortgage Cor-  
20 poration Act (12 U.S.C. 1454(a)(2)) for a single-  
21 family residence, as adjusted for the year involved.”.

22 (2) LOANS TO NATIVE AMERICAN VETERANS.—  
23 Section 3762(c) of such title is amended—

24 (A) by striking paragraph (1); and

1 (B) by redesignating paragraphs (2) and  
2 (3) as paragraphs (1) and (2), respectively.

3 (3) CONFORMING AMENDMENT.—Section  
4 3710(d)(4) of such title is amended by striking “sec-  
5 tion 3703(a)(1)(B) of this title” and inserting “sub-  
6 paragraph (B) or (C) of section 3703(a)(1) of this  
7 title”.

8 (b) ADJUSTMENT OF LOAN FEES.—Section  
9 3729(b)(2) of title 38, United States Code, is amended  
10 by striking the loan fee table and inserting the following:

# H. R. 299

To amend title 38, United States Code, to clarify presumptions relating to the exposure of certain veterans who served in the vicinity of the Republic of Vietnam, and for other purposes.
