A BILL

To amend title 10, United States Code, to require the inclusion of information regarding military installation resilience in master plans for major military installations, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Military Installation
5 Resilience Assuredness Act”.

1 **SEC. 2. INCLUSION OF INFORMATION REGARDING MILI-**
2 **TARY INSTALLATION RESILIENCE IN MASTER**
3 **PLANS FOR MAJOR MILITARY INSTALLA-**
4 **TIONS.**

5 (a) **MILITARY INSTALLATION RESILIENCE.**—Section
6 2864 of title 10, United States Code, is amended—

7 (1) in subsection (a)(1), by inserting “military
8 installation resilience,” after “master planning,”;

9 (2) by redesignating subsections (c) and (d) as
10 subsections (e) and (f), respectively; and

11 (3) by inserting after subsection (b) the fol-
12 lowing new subsection:

13 “(c) **MILITARY INSTALLATION RESILIENCE COMPO-**
14 **NENT.**—To address military installation resilience under
15 subsection (a)(1), each installation master plan shall dis-
16 cuss the following:

17 “(1) Risks and threats to military installation
18 resilience that exist at the time of the development
19 of the plan and that are projected for the future, in-
20 cluding from extreme weather events, mean sea level
21 fluctuation, wildfires, flooding, and other changes in
22 environmental conditions.

23 “(2) Assets or infrastructure located on the
24 military installation vulnerable to the risks and
25 threats described in paragraph (1), with a special
26 emphasis on assets or infrastructure critical to the

1 mission of the installation and the mission of mem-
2 bers of the armed forces.

3 “(3) Lessons learned from the impacts of ex-
4 tremе weather events, including changes made to the
5 military installation to address such impacts, since
6 the prior master plan developed under this section.

7 “(4) Ongoing or planned infrastructure projects
8 or other measures, as of the time of the development
9 of the plan, to mitigate the impacts of the risks and
10 threats described in paragraph (1).

11 “(5) Community infrastructure and resources
12 located outside the installation (such as medical fa-
13 cilities, transportation systems, and energy infra-
14 structure) that are—

15 “(A) necessary to maintain mission capa-
16 bility or that impact the resilience of the mili-
17 tary installation; and

18 “(B) vulnerable to the risks and threats
19 described in paragraph (1).

20 “(6) Agreements in effect or planned, as of the
21 time of the development of the plan, with public or
22 private entities for the purpose of maintaining or en-
23 hancing military installation resilience or resilience
24 of the community infrastructure and resources de-
25 scribed in paragraph (5).

1 “(7) Projections from recognized governmental
2 and scientific entities such as the Census Bureau,
3 the National Academies of Sciences, the United
4 States Geological Survey, and the United States
5 Global Change Research Office (or any similar suc-
6 cessor entities) with respect to future risks and
7 threats (including the risks and threats described in
8 paragraph (1)) to the resilience of any project con-
9 sidered in the installation master plan during the
10 50-year lifespan of the installation.”.

11 (b) REPORT ON MASTER PLANS.—Section 2864 of
12 title 10, United States Code, is amended by inserting after
13 subsection (c), as added by subsection (a), the following
14 new subsection:

15 “(d) REPORT.—Not later than March 1 of each year,
16 the Secretary of Defense shall submit to the congressional
17 defense committees a report listing all master plans com-
18 pleted pursuant to this section in the prior calendar
19 year.”.

20 (c) DEFINITION OF MAJOR MILITARY INSTALLA-
21 TION.—Section 2864(f)(1) of title 10, United States Code,
22 as redesignated by subsection (a), is amended by striking
23 “has the meaning given to the term ‘large site’” and in-

- 1 scribing “means a ‘large site’ or ‘medium site’ as such
- 2 terms are described”.
