3 **SECTION 1. DESIGNATION OF NATIONAL PULSE MEMORIAL.**

6 *designated as the “National Pulse Memorial”.*

7 (b) *EFFECT OF DESIGNATION.*—*The national memo-*
8 *rial designated by this section is not a unit of the National*
9 *Park System and the designation of the National Pulse Me-*
10 *morial shall not require or permit Federal funds to be ex-*
11 *pended for any purpose related to that national memorial.*
