A BILL

To authorize the Secretary of the Interior to carry out a land exchange involving lands within the boundaries of the Cape Cod National Seashore, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. LAND EXCHANGE INVOLVING CAPE COD NA-
- 4 TIONAL SEASHORE.
- 5 (a) AUTHORIZATION OF EXCHANGE.—If title accept-
- 6 able to the Secretary of the Interior, acting through the
- 7 National Park Service (referred to hereafter in this section
- 8 as the "Secretary"), for non-Federal land defined in sub-
- 9 section (b)(1) is conveyed to the United States, the Sec-

- 1 retary shall convey to the owner of the non-Federal land,
- 2 subject to valid existing rights, all right, title, and interest
- 3 of the United States in and to the Federal land defined
- 4 in subsection (b)(2).
- 5 (b) Land Descriptions.—
- 6 (1) FEDERAL LAND.—The term "Federal land"
- 7 means the approximately 1.09 acres of land depicted
- 8 as Tract 22–4556 on the map titled "United States
- 9 Department of the Interior, National Park Service,
- Northeast Region, Cape Cod National Seashore"
- and dated October 20, 1963, Sheet 202–22A.
- 12 (2) Non-Federal Land.—The term "non-Fed-
- eral land" means the approximately 1.02 acres of
- land depicted as Tract 26–4653 on the map titled
- 15 "United States, Department of the Interior, Na-
- tional Park Service, Northeast Region, Cape Cod
- National Seashore" and dated October 27, 1964,
- 18 Sheet 202–26.
- 19 (c) Acceptable Title.—Title to the non-Federal
- 20 land conveyed to the United States under subsection (a)
- 21 shall be such title as is acceptable to the Secretary, in con-
- 22 formance with title approval standards applicable to Fed-
- 23 eral land acquisitions.
- 24 (d) Applicable Laws; Terms and Conditions.—
- 25 The exchange under this section shall be subject to—

- 1 (1) the laws (including regulations) and policies
- 2 applicable to exchanges of land administered by the
- 3 National Park Service, including the laws and poli-
- 4 cies concerning equalization of values, and environ-
- 5 mental compliance; with the exception of appraisal
- 6 requirements; and
- 7 (2) such terms and conditions as the Secretary
- 8 determines to be appropriate.
- 9 (e) APPRAISALS.—For the purpose of valuation of the
- 10 land proposed for exchange under this section, the Sec-
- 11 retary may use the appraisals conducted by Michael Sut-
- 12 ton, Certified General Real Estate Appraiser, and dated
- 13 July 14 and July 22, 2009.
- 14 (f) ADMINISTRATION.—The land acquired by the Sec-
- 15 retary pursuant to the exchange authorized by this section
- 16 shall be administered as part of the Cape Cod National
- 17 Seashore.
- 18 (g) Maps.—The maps referred to in subsection (a)
- 19 shall be on file and available for inspection in the appro-
- 20 priate offices of the Department of the Interior.
- 21 (h) Definition of Improved Property.—Section
- 22 4(d) of Public Law 87–126 (16 U.S.C. 459b–3(d)) is
- 23 amended by adding at the end the following: "The term
- 24 'improved property' includes such dwelling structures (in-
- 25 cluding the land thereon) as shall be conveyed by the Sec-

- 1 retary pursuant to section 2 in exchange for conveyance
- 2 to or acquisition by the Secretary of an improved property

3 as described in this section.".
