A BILL

To prohibit the manufacture for sale, offer for sale, distribution in commerce, or importation into the United States of any inclined sleeper for infants, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Safe Sleep for Babies*
5 *Act of 2019”.*

6 **SEC. 2. PROHIBITION ON SALE OF INCLINED SLEEPERS FOR**
7 **INFANTS.**

8 *(a) PROHIBITION ON THE SALE OF INCLINED SLEEP-*
9 *ERS FOR INFANTS.—Beginning on the date that is 180 days*
10 *after the date of enactment of this Act, it shall be unlawful*
11 *for any person to manufacture for sale, offer for sale, dis-*
12 *tribute in commerce, or import into the United States any*
13 *inclined sleeper for infants.*

14 *(b) TREATMENT OF VIOLATION.—A violation of sub-*
15 *section (a) shall be treated as a violation of section 19(a)(1)*
16 *of the Consumer Product Safety Act (15 U.S.C. 2068(a)(1)).*

17 *(c) INCLINED SLEEPER FOR INFANTS DEFINED.—In*
18 *this section, the term “inclined sleeper for infants” means*
19 *a product with an inclined sleep surface greater than ten*
20 *degrees that is intended, marketed, or designed to provide*
21 *sleeping accommodations for an infant up to one year old.*
